Adani Ports Profit Jumps 37% to a Record in FY25

Mumbai: Adani Ports and Special Economic Zone clocked in a 50% year-on-year growth in its consolidated profit for the March quarter at ₹3,023 crore, aided by a 23% jump in revenue to ₹8,488 crore.

Most brokerages had pegged bottomline for the company in the range of ₹2,800-2,700 crore.

For the full year (April 2024-March 2025), Adani Ports' profit rose 37% on-year to an all-time high of ₹11,061 crore. This was driven by growth across its ports, logistics and marine business, the company said.

Its revenue for the year rose 16% on-year to ₹31,079 crore, surpassing the guidance of ₹29,000-31,000 crore. Ebitda for the fiscal was ₹19,025 crore, also higher than the latest guidance of ₹18,800-18,900 crore.

"Our record-breaking performance in FY25—crossing ₹11,000 crore in profit after tax (PAT) and handling 450 MMT cargo—is a testament to the power of integrated thinking and flawless execution," chief executive officer Ashwani Gupta said in a statement. "We have outperformed guidance across all metrics, expanded our footprint across India and globally, and transformed our logistics and marine verticals into engines of future growth." The company's market share for cargo increased to 27% in FY25 from 26.5% in FY24.

For the current fiscal, the Adani Group company has guided for a revenue of ₹36,000-38,000 crore, Ebitda in the range of ₹21,000-22,000 crore, capital expenditure of ₹11,000-12,000 crore, and a net debt to Ebitda ratio of up to 2.5 times.

Mumbai: Adani Power on Wednesday reported a 5% fall in January-March net profit to ₹2,599.23 crore. Profit stood at ₹2,737.24 crore in the March 2024 quarter.

For the FY25 fiscal, net profit plunged 39% to ₹12,749 crore from ₹20,828 crore in the previous fiscal.

Revenue rose 6.54% to ₹14,237 crore in the last quarter against ₹13,363 crore (yoy). Revenue from operations rose 11.62% to ₹56,203 crore in FY25 against ₹50,351 crore in FY24.

Total income climbed 4.7% to ₹14,535 crore in the March 2025 quarter, up from ₹13,881 crore in the same period a year ago.

Total expenses climbed to ₹11,274 crore in Q4 against ₹10,323 crore in the year-ago quarter.

"Adani Power has posted ever higher operating and financial performance for FY 2024-25, aptly demonstrating the strength and resilience of the Adani Portfolio companies," said SB Khyalia, CEO, Adani Power Limited, adding that as the company progresses in the next phase of capacity expansion, it is prioritising capital and cost efficiencies to sharpen its competitive edge and extend sectoral leadership across key parameters.

Consolidated power sale volume at 95.9 billion units (BU) in FY25, up by 20.7% from 79.4 BU in FY24 due to robust power demand and higher operating capacity.

Consolidated Operating capacity grew from 15,250 MW in FY24 to 17,550 MW in FY25 on account of the acquisition of the 1,200 MW Moxie Power Generation Ltd, 600 MW Korba Power Limited, and 500 MW Adani Dahanu Thermal Power Station.

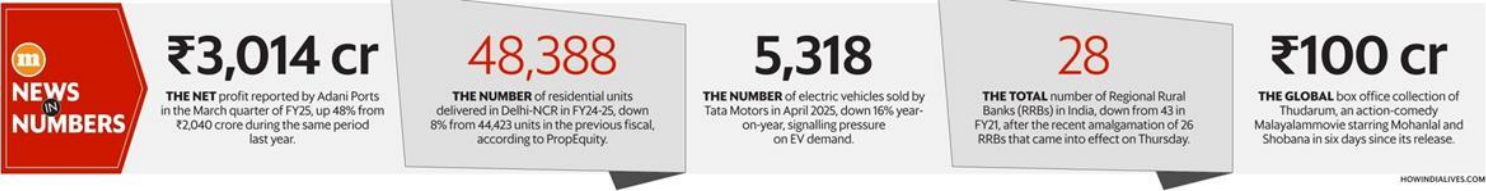

Having achieved record high cargo volume at 450 million tonnes (MT), Adani Ports and Special Economic Zone (APSEZ) posted an all-time-high profit after tax (PAT) of ₹11,061 crore, a 37 per cent year-on-year (y-o-y) growth in FY25.

The board of directors recommended a dividend of ₹7 (350 per cent) per equity share. The payout will translate to ₹1,500 crore.

Mundra became the first port in India to cross 200 mt in a single year. The company's total cargo volumes grew 7 per cent to 450 mt, and revenues of the company grew 16 per cent to ₹31,079 crore in FY25.

During the year, revenue from domestic ports and logistics grew 12 per cent and 39 per cent respectively. "During FY26, we expect significant growth across ports,

Adani Ports announces significant growth with a record Rs 11,061 crore net profit for FY 2024-25 and outlines ambitious expansion plans for 2025-26.

The Adani Group's ports business will continue to invest across businesses in 2025-26. In a video message announcing the results for 2024-25, Ashwani Gupta, Whole-time Director and CEO, Adani Ports and SEZ Ltd on Thursday pegged the capital expenditure (capex) guidance for the current fiscal 2025-26 at Rs 11,000-12,000 crore. In 2025-26, Adani Ports and SEZ expects a significant growth across ports, logistics and marine business lines. "We have guided FY26 revenue at Rs 36,000 to Rs 38,000 crore driven by growth in port volumes and 3x to 4x increase in trucking and 2x increase in marine revenue. FY26 EBITDA is expected to be between Rs. 21,000 to Rs. 22,000 crore," Gupta said in the video message. In his video message, he also highlighted the strategic milestones it had achieved.



APSEZ's Board approved the acquisition of North Queensland Export Terminal (NQXT), Australia. NQXT is a critical export gateway for producers in resource-rich Queensland, Australia and has current capacity of 50 MTPA.

Within India, APSEZ closed the acquisition of Gopalpur port, commenced operations at Vizhinjam port, India's first fully automated transshipment port that has already crossed the milestone of 100,000+ TEUs in a sin-

gle month, the company statement noted. APSEZ also commenced O&M operations at Syama Prasad Mookerjee Port's Netaji Subhas dock and won concession agreement with Deendayal Port Authority to develop Berth No. 13.

APSEZ also expanded its international footprint significantly during the year. APSEZ commenced operations at the Colombo West International Terminal (CWIT), located at the port of Colombo. This is the first deep-water terminal in

Colombo to be fully automated, designed to enhance cargo handling capabilities, improve vessel turnaround times and elevate the port's status as a key transshipment hub in South Asia. APSEZ's Board approved the acquisition of North Queensland Export Terminal (NQXT), Australia. NQXT is a critical export gateway for producers in resource-rich Queensland, Australia and has current capacity of 50 MTPA. APSEZ also signed a 30-year concession agreement to manage container terminal at Dar es Salaam Port, Tanzania. Ahmedabad: Adani Ports and Special Economic Zone Limited (APSEZ) on Thursday reported its highest-ever profit after tax of Rs 11,061 crore for the financial year ended March 31, 2025, up 37% over FY 2024.

The company's revenue from operations increased 16% to Rs 31,079 crore while EBITDA grew 20% to Rs 19,025 crore during the period. For the January–March quarter, APSEZ posted a 50% rise in PAT at Rs 3,023 crore, with quarterly revenue up 23% to Rs 8,488 crore.

The company handled 450 million metric tonnes (MMT) cargo in FY25, driven by strong growth in container traffic (up 20%) and liquids and gas (up 9%). Mundra Port became the first in India to surpass 200 MMT of annual cargo, while Vizhinjam Port, which became operational only in late 2024, crossed the 100,000 TEUs monthly milestone in March 2025.

The company's all-India market share rose to 27%, while its container market share increased to 45.5%.

APSEZ's logistics business saw continued momentum, with container volumes rising 8% to 0.64 million Twenty-foot Equivalent Units (TEUs) and bulk cargo volumes reaching 21.97 MMT, up 9%. The number of rakes increased to 132, while warehousing capacity grew from 2.4 million to 3.1 million sq ft. TNN

APSEZ net profit jumps 50% in Q4

NEW DELHI: Adani Ports and Special Economic Zone (APSEZ) on Thursday reported a 50 per cent jump in Q4 net profit and issued a higher year-on-year revenue growth forecast for FY26, citing a strong growth in port volumes and robust rise in logistics business.

Net profit was Rs 3,025 crore in Q4 FY25 against Rs 2,015 crore earnings in the same period a year back, the company said. Cargo handled by APSEZ-operated 15 ports soared 8 per cent to 118 million tonnes in Q4 and by 7 per cent to 450 million tonnes in FY25.

For FY25 the company posted an all-time high profit of Rs 11,061 crore, up 37 per cent over FY24. The company said it expects revenue to grow in the range of 15.8 per cent to 22.2 per cent in FY26. Its reve-



nue grew 16 per cent in the last fiscal to Rs 31,079 crore.

In FY25, APSEZ's revenue from the ports business, its biggest, climbed 12 per cent, while the logistics business jumped 39 per cent, led by higher container and bulk cargo volumes.

Revenue from the marine services division - its third biggest - surged 82 per cent in FY25 and is likely to grow 3x in two years, the company said.

It gave a capex guidance of Rs 11,000 crore to Rs 12,000 crore for FY26.

APSEZ said its all-India cargo market share for FY25 increased to 27 per cent (26.5 per cent in FY24). Container market share increased to 45.5 per cent (44 per cent in FY24).

Mundra became the first Indian port to cross 200 million tonnes of annual cargo volume in a single year. Vizhinjam port crossed the 1,00,000 monthly TEUs milestone in March 2025, just four months after becoming operational.

Operating revenue grew by 16 per cent to Rs 31,079 crore in FY25. Domestic ports revenue increased 12 per cent to Rs 22,740 crore while logistics revenue jumped 39 per cent to Rs 2,881 crore. Just four months after becoming operational, Vizhinjam port crossed the 1,00,000 monthly TEUs milestone in March 2025.
