

Mumbai: BlackRock, the world's largest asset manager, emerged as the largest investor in a \$500 million (about ₹6,934 crore) bond issue of Renew Exim DMCC, a wholly owned offshore entity of the Adani Group promoter family.

Blackrock subscribed to around \$275 million of the bond issue, said people familiar with the matter.

The issue saw participation from five to six international investors including BlackRock and Sona Asset Management, the sources said.

The bond issue has a tenure of three to five years, and its proceeds will be used to finance Renew Exim's acquisition of ITD Cementation, and the rest for general corporate purposes.

This marks BlackRock's debut in a private bond issue of an Adani group company, the people said.
