Adani Unit to Undertake ₹36,000-cr Redevelopment in Mumbai

Mumbai: The Adani Group is set to undertake the redevelopment of more than 143 acres at Motilal Nagar in Mumbai's Goregaon (West), said people with direct knowledge of the development. Adani Properties would partner with the state's housing body for redevelopment that a top official source said could cost ₹36,000 crore.

Maharashtra Housing and Area Development Authority (MHADA), the state housing entity, will maintain full control over the project, including land ownership, while Adani Properties, the construction and development agency (C&DA), will handle design, approvals, construction, infrastructure development, and rehabilitation.

The redevelopment will involve rehabilitating over 3,372 MHADA residential units, 328 commerci-

al units, and 1,600 slum tenements, with a rehabilitation period of seven years from the project's commencement.

"Adani Properties has secured the project by agreeing to provide 3.97 million square metres of built-up area to MHADA, surpassing the second highest offer of 2.6 million square metres. The Maharashtra government has accorded this a "Special

Project" status," said a source.

MEGA HOUSING PROJECT

Motilal Nagar I, II & III, is one of Mumbai's biggest housing redevelopment projects. As per tender conditions, C&DA was expected to provide housing stock of 3.83 lakh square metre.

The private developer cannot mortgage the land, raise finance on it, or sell/transfer rights without MHADA's permission. This pro-

tects MHADA residents, slum dwellers and prevents misuse of redevelopment right.

The housing density in the redevelopment area is 106 units per hectare, much lower than the DCPR 2034 limit of 450 units per hectare.

The compensation to the developer (C&DA) will be in the form of floor space index (FSI), allowing construction rights on the land. Adani Group declined to comment.

In Dharavi Redevelopment Project (now called Navbharat Mega Developers), Adani Group

held an 80% stake while the rest was with the state government.

Under the Dharavi project, Adani plans to turn 620 acres of prime land, about three-quarters of the size of New York's Central Park, into a glitzy urban hub. About one million people live in rickety shanties with open sewers and shared toilets in the densely populated slums, close to Mumbai's international airport.

Eligible residents will be given flats of up to 350 sq ft free of cost as part of the \$3 billion redevelopment of rubbish-strewn Mumbai slum of Dharavi into a 'world-class' district.

The Gautam Adani Group has secured the mega project for redevelopment of Motilal Nagar, spread over 143 acres in Goregaon (W).

Adani's bid of ₹36,000 crore was the highest and was accepted when the Maharashtra Housing & Area Development Authority (MHADA) opened the bids on Tuesday.

A MHADA official told FPJ that construction major Larsen & Toubro was the second-highest bidder. After winning the Dharavi redevelopment project, Adani has made yet another successful foray into the Mumbai real estate market.

"It is only a matter of time before Adani emerges as the biggest player in

Mumbai's real estate market," a city builder observed.

The Motilal Nagar project is expected to significantly impact the real estate market in the western suburbs, where several major developers are already active. Incidentally, India's biggest builder, DLF Pvt Ltd, is set to enter the Mumbai market later this month with a project in Andheri.

Motilal Nagar primarily consists of small, chawl-type houses spread across a vast area, largely occupied by the lower-middle class.

Adani Properties Pvt Ltd (APPL) emerged as the highest bidder, offering more built-up area than its closest rival, L&T, according to sources familiar with the matter.

The private developer is prohibited from mortgaging the land, raising finance against it, or selling/transferring rights without MHADA's permission, according to the tender conditions. This ensures the protection of MHADA residents and slum dwellers while preventing misuse of redevelopment rights.

The selected C&DA will be responsible for the entire redevelopment process, including design, approvals, construction, infrastructure development, and rehabilitation.

The project aims to rehabilitate 3,372 residential units eligible under MHADA, 328 eligible commercial units, and 1,600 eligible slum tenements under the 1971 Slum Act.

Last week, a Bombay High Court division bench comprising Chief Justice Alok Aradhe and Justice Bharati Dangre upheld MHADA's decision to carry out redevelopment through a C&DA for integrated development of the entire layout.

The court noted that if individual cooperative societies managed redevelopment, they would prioritize their own interests and likely appoint developers for small-scale projects. This, the court

ruled, would hinder orderly planning and infrastructure development while exposing societies and residents to commercial risks from developers.

The court further emphasized that only holistic redevelopment can provide a long-term solution to the recurring problems of flooding and waterlogging faced by Motilal Nagar residents—issues that cannot be resolved through piecemeal redevelopment of separate land parcels.
