Shareholders will get a dozen shares of Ambuja Cements for every 100 held in Sanghi Industries, while shareholders of Penna Cement, which is unlisted, will get ₹321.50 for every share held in the company.

The merger is expected to be completed within 9-12 months. Ambuja Cements had a market capitalisation of ₹1.41 lakh crore as of Tuesday, while that of Sanghi Industries was ₹1,996 crore. Shares of Ambuja Cements closed 1% lower at ₹570.95 apiece on BSE compared with a 1.3% decline in the benchmark Sensex. Sanghi Industries closed 0.38% lower at ₹76.92 apiece.

The merger is expected to be completed within 9-12 months.

Ambuja Cements had a market capitalisation of ₹1.41 lakh crore as on Tuesday, while that of Sanghi Industries was at ₹1,986 crore. Shares of Ambuja Cements closed 1% lower at ₹571.10 rupees on the NSE, while tho-

se of Sanghi Industries closed 0.3% lower at ₹76.90.



For the listed entity SIL, the statement said, for every 100 equity shares of SIL. Ambuja Cements will issue 12 company more competitive equity shares with a face value of ₹2 each, to eligible shareholders of SIL. Thereby, the shareholders of SIL will become the shareholders of

Ambuja Cements said the SIL transaction is expected to be completed within 9-12 months, subject to requisite approvals.

#### CAPACITY OF PLANTS

Ambuja Cements stated that it will issue 12 equity shares with face value of ₹2 each for every 100 equity shares of SIL of face value ₹10 each as recommended by the valuers and accepted by the Board, thereby making eligible shareholders of SIL the shareholders of Ambuja Cements. These transactions

will be effected with requisite approvals from related stakeholders and authorities, anticipated to be completed within 9-12 months' time, it added.

SIL has a clinker capacity of 6.6 mtpa, a cement capacity of 6.1 mtpa, and limestone reserves of over 1 billion tonnes.

Penna has four integrated plants in Andhra Pradesh and Telangana, along with a grinding unit in Maharashtra. It has an operational capacity of 10 mtpa.

Additionally, two plants, with a capacity of 2 mtpa each, are under construction in Krishnapatnam and Jodhpur. It also has five bulk cement terminals at Kolkata, Gopalpur, Karaikal, Kochi, and Colombo (Sri Lanka).

Mumbai: Ambuja Cements plans to consolidate its business by merging its recent acquisitions, Sanghi Industries and Penna Cement Industries. The

company, under Gautam Adani's leadership, had purchased Sanghi in Dec 2023 and Penna in Aug 2024.

Following the merger completion, the Adani family's ownership in Ambuja will decrease marginally to 67% from 68%, while public shareholders' stake will increase to 33% from 32%.

Currently, holds 58% in Sanghi, with founder Ravi Sanghi and family controlling 17%, and public shareholders owning 25% of the Mumbai-listed firm. In Penna, Ambuja has 99.94% ownership, with minor investors holding the remaining 0.06%.
