

## Adani group to exit AWL JV in \$1.3 bn deal

Adani Enterprises expects to get ₹10,870 crore (\$1.3 billion) by selling its residual 20 per cent stake in AWL Agri Business as the ports-to-power conglomerate exits non-core activities to focus on its mainstay infrastructure businesses like renewables and airports. Separately, the remaining 10.42 per cent AWL stake "will be sold to a set of pre-identified investors," Adani Enterprises said in an exchange filing.

## Adani group sells 20 % in AWL Agri Biz to Wilmar for ₹7,150 cr

Adani Group has sold a 20 per cent stake in AWL Agri Business Ltd (formerly known as Adani Wilmar Ltd) to Wilmar International, Singapore, for ₹7,150 crore, according to a stock exchange filing.

Adani had in December announced divestment of its entire 44 per cent stake in Adani Wilmar in order to sharpen its focus on core infrastructure businesse

Adani Commodities LLP (ACL), subsidiary of Adani Enterprises Ltd (AEL), and Lence Pte Ltd, subsidiary of Wilmar International, Singapore entered into an agreement. They gave each other the option to buy or sell AEL/ACL's shares in AWL (Adani Wilmar Limited) later, at a price they both agree on, but not more than ₹305 per share. The two together held around 88 per cent in the company (44 per cent each).

In January 2025, AEL/ACL sold 13.5 per cent of its shareholding in AWL at ₹276.51 per share. This was done so that more of the company's shares are owned by the public, as required by minimum public shareholding requirements. After this sale, ACL/AEL owned about 30.42 overtaking Adani. per cent of AWL.



Adani Commodities, which holds a 30.42% stake in the company, will sell 20% stake to Wilmar unit Lence for ₹7,150 crore at ₹275 a share. The balance 10.42% will be sold to "a set of pre-identified investors", Adani Enterprises, the flagship company of the Adani Group, said, without specifying who these investors were.

The latest communication is part of an exit process that was first set in motion in December last year, when the Adani Group had indicated that it would get out of the fast-moving consumer goods (FMCG) business to focus on its core infrastructure and energy verticals. From a portfolio perspective, Mallick said that the company was looking to enter new categories such as organic foods and cold-pressed edible oils via acquisitions. Its foods business crossed ₹6,000 crore in FY25 and contributes 10% to its top line. Edible oil, led by the Fortune brand, contributes around 78% to its top line while industry essentials, led by oleochemicals, contributes 12% to its turnover.

The company has also lined up capital expenditure of over ₹1,000 crore in FY26 to beef up capacity in oleochemicals, foods and edible oils. The company is also eyeing mid-to-high teen revenue growth in FY26, led by a consumption uptick starting August, Mallick said.


