Mumbai: The US Securities and Exchange Commission (SEC) has asked India's Ministry of Law and Justice to help serve legal notices to industrialist Gautam Adani and his nephew Sagar in connection with its probe into alleged securities fraud and a \$265 million bribery scheme.

The SEC made the request by invoking the Hague Service Convention, which facilitates legal cooperation in cross-border cases.

According to documents seen by ET, the SEC stated in a letter that both individuals "are located in India, and the SEC's efforts to serve them there are ongoing, including through a request for assistance to the Indian authorities".

The US agency has sent 'Notices of Lawsuit and Requests for Waiver of Service of Summons' to the Adani Group chairman, his nephew and their legal representatives.

The Adani Group did not respond to ET's queries.



Legal experts said this is a procedural step under the Hague Service Convention to ensure compliance with international law. "India's role is to process the request through its designated central authority, which verifies compliance before serving the documents," said Nilesh Tribuvann, managing partner at White & Brief - Advocates. "The Indian government can assess the request's validity but plays only a procedural role."

Burjeon Law senior partner Ke-

tan Mukhija said the Adani Group has several options: cooperate, contest the allegations, or seek a settlement, depending on the charges.

The SEC's probe is related to securities fraud allegations linked to a 2021 bond offering. The agency has also linked the Adani case to its ongoing probe under the Foreign Corrupt Practices Act (FCPA) against former Azure Power executives Ranjit Gupta and Rupesh Agarwal, who are accused of bribery to secu-

re government contracts in India.

Adani Green Energy Ltd clarified in November that Sagar and Gautam Adani, as well as its chief executive Vneet S Jaain were not charged under the FCPA or bribery-related violations. They face charges of securities fraud conspiracy, wire fraud conspiracy and securities fraud, including allegations tied to the bond offering.

A US court has consolidated civil and criminal cases against the three executives. "The next steps will depend on whether the Adanis contest the service or engage with the US legal system," said Tribuvann.

The Adani Group has appointed Kirkland & Ellis and Quinn Emanuel Urquhart & Sullivan LLP to represent it in the case, people in the know told ET.

The SEC is also probing Canadian institutional investor CDPQ's executives Cyril Cabanes, Saurabh Agarwal and Deepak Malhotra for allegedly destroying evidence and withholding key information in the bribery case.

Last week, Prime Minister Narendra Modi said he did not discuss the Adani case with US President Donald Trump during his visit to Washington, describing it to reporters as an individual issue never discussed by leaders.

Nine Adani group stocks down

Nine Adani group stocks ended lower on Wednesday as the US Securities and Exchange Commission (SEC) has told a federal judge that its efforts to serve its complaint on Gautam Adani and Sagar Adani in the alleged bribery scheme are "ongoing", including through a request for assistance to the Indian authorities.

Shares of Adani Green Energy dropped 3.75 per cent, the group's flagship firm Adani Enterprises declined 1.78 per cent, Ambuja Cements went lower by 1.36 per cent, Sanghi Industries fell 1.36 per cent, ACC slipped 0.93 per cent, Adani Wilmar dipped 0.90 per cent, Adani Energy Solutions (0.81 per cent), Adani Power (0.47 per cent), and Adani Ports (0.28 per cent) on the BSE.

In intraday trade, shares of Adani Green Energy tanked 4.25 per cent and Adani Enterprises tumbled 4.30 per cent. However, the stock of NDTV climbed 1.35 per cent and Adani Total Gas went up by 0.54 per cent.

Adani broke the US Securities Act when AGEL raised \$2 bn from American investors: SEC

The Securities and Exchange Commission (SEC) has sought the Indian government's assistance in the US market regulator's investigation of billionaire Gautam Adani, his nephew Sagar and their role in allegedly paying more than \$250 million in bribes to Indian government officials between 2020 and 2024 to obtain lucrative solar-energy contracts.

The SEC told a New York district court on Tuesday that as the Adanis are based out of India, the regulator had sought help from India's law ministry to serve its complaint to the Ahmedabad-based business tycoon.

"Defendants are located in India, and the SEC's efforts to serve them there are ongoing, including through a request for assistance to the Indian authorities to effect service under the Hague Service Convention for Service Abroad of Judicial and Extrajudicial Documents in Civil or Commercial Matters," SEC's counsel Christopher M. Colorado wrote in a letter, dated 18 January.

"Additionally, under Article 5(a) of the Hague Service Convention, the SEC has requested assistance from India's ministry of law and justice, the Central Authority for India under the Hague Service Convention," said Colorado in his letter to the judge.

Emails sent to the Adani group and India's ministry of law and justice seeking comment went unanswered.

The Hague Convention, which includes 90 countries, including India and the US, allows legal documents from foreign law agencies to be delivered to a citizen of another country

"All possible legal recourse will be sought," said a spokesperson for the Adani group in the past. "The Adani Group has always upheld and is steadfastly committed to maintaining the highest standards of governance, transparency and regulatory compliance across all jurisdictions of its operations. We assure our stakeholders, partners and employees that we are a law-abiding organisation fully compliant with all laws."

Since being charged by the DoJ and the SEC in November, the Adani group, comprised of 11 public companies, has faced new challenges to its global ambitions. Kenya has cancelled Adani's proposed deals worth

\$2.6 billion, which included expanding an airport and investing in electricity. French oil giant TotalEnergies, which has invested \$3.85 billion in Adani group companies since 2019, decided not to make new investments in the group until the allegations are clarified.

In December, Adani chose to opt out of a \$500 million loan with the US International Development Finance Corporation to finance a port terminal project in Colombo, saying it would fund the project internally.

Opposition Congress party has called for Adani's arrest and accused Modi of shielding him or favouring him in deals in the past. While Bharatiya Janata Party (BJP) and Adani have denied the charges.




The SEC submitted a status update



Tuesday to Judge Nicholas Garaufis at the United States District Court, Eastern District of New York regarding its efforts to serve its complaint on Gautam Adani and Sagar Adani. The SEC said that "both Gautam Adani and Sagar Adani are located in India, and the SEC's efforts to serve them there are ongoing, including through a request for assistance to

the Indian authorities to effect service under the Hague Service Convention for Service Abroad of Judicial and Extrajudicial Documents in Civil or Commercial Matters."

The SEC said that its complaint dated November 20 last year alleges that Gautam Adani and Sagar Adani violated the antifraud provisions of the federal securi-

ties laws by "knowingly or recklessly making false and misleading representations concerning Adani Green Energy Ltd in connection with a Sept 2021 debt offering by Adani Green

with a September 2021 debt offering by Adani Green. It said that because the "defendants are located in a foreign country, Rule 4(f) of the Federal Rules of Civil Procedure (FRCP) governs service of the Summons and Complaint. FRCP 4(f) contains no set time limit for service, and the SEC may serve Defendants "by any internationally agreed means of service that is reasonably calculated to give notice,"... such as the Hague Service Convention."

The SEC update, submitted by its Counsel Christopher Colorado, cited a case which notes that service via the Hague Service Convention is one permissible means of serving defendants located in India.

अदाणी धोखाधड़ी मामले की जांच में भारत की मदद चाहता है अमेरिकी नियामक

अमेरिकी प्रतिभूति और विनियम आयोग ने अदाणी समूह के संस्थापक गौतम अदाणी और उनके भतीजे के खिलाफ कथित प्रतिभूति धोखाधड़ी और 26.5 करोड़ डॉलर की रिश्वत योजना की जांच में भारतीय अधिकारियों से मदद मांगी है। मंगलवार को अदालत में दाखिल एक विवरण में यह जानकारी दी गई है।

इस विवरण में कहा गया है कि एसईसी ने हेग सेवा संघिके के तहत सहायता मांगी है। अदाणी समूह और भारत के कानून मंत्रालय ने इस बारे में रॉयटर्स के सवाल का कोई जवाब नहीं दिया।

पिछले सप्ताह प्रधानमंत्री नरेन्द्र मोदी ने कहा था कि उन्होंने वॉशिंगटन यात्रा के दौरान अमेरिकी राष्ट्रपति डॉनल्ड ट्रंप के साथ अदाणी मामले पर चर्चा नहीं की। उन्होंने पत्रकारों से बातचीत में इसे एक निजी मामला बताया था, जिस पर कभी नेताओं के बीच चर्चा नहीं होती।

भारत में विपक्ष कांग्रेस पार्टी ने अदाणी की गिरफ्तारी की मांग की है और मोदी पर उन्हें बचाने या अतीत में सौदों में उनका पक्ष लेने का आरोप लगाया है। मोदी की पार्टी और अदाणी ने आरोपों से इनकार किया है।

पिछले वर्ष ब्रूकलिन में संघीय अभियोजकों ने एक अभियोग पत्र जारी किया था जिसमें अदाणी पर भारतीय अधिकारियों को रिश्वत देकर उन्हें अदाणी समूह की सहायक कंपनी अदाणी ग्रीन एनर्जी द्वारा उत्पादित बिजली खरीदने के लिए तैयार करने का आरोप लगाया गया था।

इसके बाद उन्होंने कंपनी की भ्रष्टाचार विरोधी नीति के बारे में आश्वस्त करने वाली जानकारी देकर अमेरिकी निवेशकों को गुमराह किया। अदाणी समूह ने इन आरोपों को निराधार बताया है और हरसंभव कानूनी उपाय अपनाने की प्रतिज्ञा की है।

जनवरी में अदाणी ग्रीन ने कहा था कि उसने अमेरिकी अभियोग की समीक्षा के लिए स्वतंत्र कानूनी फर्मों को नियुक्त किया है।

The Indian conglomerate has denied the allegations by the DoJ and the SEC, describing the allegations against its directors as "baseless." "All possible legal recourse will be sought," an Adani group spokesperson has said in the past.

India's opposition Congress

party has called for Adani's arrest and accused Modi of shielding him or favouring him in deals in the past. Modi's party and Adani have denied the charges.

Last year, federal prosecutors in Brooklyn unsealed an indictment accusing Adani of bribing Indian officials to convince them to buy electricity produced by Adani Green Energy, a subsidiary of his Adani Group.

He then misled U.S. investors by providing reassuring information about the company's anti-graft practices, it added.

THE US Securities and Exchange Commission (SEC) has sought assistance from India's Ministry of Law and Justice regarding a complaint against Gautam Adani and his nephew Sagar Adani in the alleged violation of securities laws. The SEC had accused the Adanis' for "recklessly making false and misleading representations" concerning Adani Green Energy's debt offering.

The SEC submitted a status update on Tuesday to Judge Nicholas Garaufis at the US District Court, Eastern District of New York regarding its efforts to serve its complaint on Gautam Adani and Sagar Adani (defendants).

The SEC had filed a complaint on November 20, 2024, alleging that the Adanis "violated the antifraud provisions of the federal securities laws by knowingly or recklessly making false and misleading representations concerning Adani Green Energy Ltd in connection with a September 2021 debt offering by Adani Green".

The Adani group withdrew the \$600 million bond offering after the US Department of Justice indicted group chairman Gautam Adani and six related entities of al-

leged bribery charges. US prosecutors in New York had charged Gautam S Adani, his nephew Sagar Adani, and six others for allegedly offering US \$265 million in bribes to Indian government officials to secure lucrative solar energy supply contracts. The indictment, filed on November 21, 2024, alleged schemes to pay over \$250 million in bribes, lie to investors and banks, and obstruct justice.

"In a related criminal case arising from many of the same alleged facts, the US Attorney for the Eastern District of New York charged defendants (Gautam Adani and his nephew Sagar Adani) with, among other things, conspiracy and securities fraud," SEC said.

The Adani group did not respond to a mail from *The Indian Express* regarding the latest SEC move. When contacted, the spokesperson declined to comment.

SEC submitted a status update to Judge Nicholas Garaufis at the US District Court, Eastern District of New York on efforts to serve its complaint on Gautam Adani & Sagar Adani (defendants)

As defendants (Adanis) are located in a foreign country, Rule 4(f) of the Federal Rules of Civil Procedure (FRCP) governs service of the summons and complaint, SEC said. Since the filing of its complaint, SEC staff has been working to serve the Adanis (defendants) in accordance with FRCP 4(f). "SEC staff has contacted defendants or their counsel (to the extent SEC staff is aware of such counsel) and has sent them notices of lawsuit and requests for waiver of service of summons, including copies of the complaint," SEC said.

"Additionally, under Article 5(a) of the Hague Service Convention, the SEC has requested assistance from India's Ministry of Law and Justice, the central authority for India under the Hague Service Convention. That process is ongoing, and the SEC will continue its efforts to serve defendants," SEC said.

"Adani and other defendants also defrauded investors by raising capital on the basis of false statements about bribery and corruption, while still other defendants allegedly attempted to conceal the bribery conspiracy by obstructing the government's investigation," a press release quoting James E Dennehy, Assistant Director in Charge, Federal Bureau of Investigation, New York Field Office (FBI) had said.

US President Donald Trump had signed an executive order last week, directing the US Justice Department to halt prosecuting Americans accused of bribing foreign government officials to win overseas business. While the order is meant to provide relief to US citizens, it will likely come as a breather for key executives of the Adani Group currently facing bribery charges in a US court.

Meanwhile, according to a PTI report, the Congress on Wednesday said Prime Minister Narendra Modi has already declared the Adani issue to be a personal matter and asked whether he would oblige the US SEC request in the ongoing probe against the business group.

"The PM has already declared the Modani issue to be a personal matter. Will he oblige the SEC?" Congress general secretary in-charge communications Jairam Ramesh said on X.

The Congress on Wednesday asked whether the Narendra Modi government would respond to the U.S. Securities and Exchanges Commission's request in the ongoing probe against the Adani Group since the Prime Minister had already declared the Adani issue to be a "personal matter".

The comment came after the SEC told a federal judge in New York that its efforts to serve its complaint on industrialist Gautam Adani and Sagar Adani in the alleged bribery scheme are "ongoing" and that it has sent a request for assistance to the Indian authorities.

"The Prime Minister has already declared the Modani issue to be a personal matter. Will he oblige the SEC," asked Congress lead-

er Jairam Ramesh.

In a separate post on X, Mr. Ramesh said the talk of reciprocal tariffs by U.S. President Donald Trump was calling into question a consumption tax such as GST. He wondered whether his "good friend in New Delhi" would stand up to it when national sovereignty was at stake.

Call for GST 2.0

"The Congress has long been calling for a GST 2.0 that will make GST a truly Good and Simple Tax, as it was intended to be. It has called for the barest minimum of rates and vastly reformed compliance rules," Mr. Ramesh said.

"Now President Trump is threatening the very existence of GST. Now all this talk of reciprocal tariffs by the U.S. President is calling into question a consumption tax like GST," he said.

Despite U.S. President Donald Trump's executive order to hit the pause button on the foreign anti-bribery law – a move viewed as a big relief for Indian billionaire and top industrialist Gautam Adani – the U.S. Securities and Exchange Commission (SEC) has now written to Indian authorities to serve a complaint on the Adani Group founder and his nephew Sagar Adani for their alleged involvement in securities fraud and a \$265 million bribery scheme, according to a court filing.

The SEC told a New York district court on Tuesday that it was taking steps to

serve its complaint to both the Adanis, defendants in the case, and that it has sought the help of India's Union Ministry of Law and Justice in this regard.

Assistance request

"Defendants are located in India and the SEC's efforts to serve them there are ongoing, including a request for assistance to Indian authorities to effect service under the Hague Service Convention for Service Abroad of Judicial and Extrajudicial documents in Civil and Commercial matters," the SEC filing said.

In November 2024, the SEC had filed a complaint alleging that the defendants violated the anti-fraud provisions of the fed-

eral securities law "by knowingly or recklessly making false and misleading representations concerning Adani Green Energy Ltd in connection with a September 2021 debt offering by Adani Green".

Criminal case

In a related criminal case arising from the same alleged facts, the United States Attorney of the Eastern District of New York has charged the defendants with, among other things, conspiracy and securities fraud, the SEC filing said.

Because the defendants are located in a foreign country, outside the United States, there is no time limit to serve the summons and complaints as per Rule 4(f) of the Federal Rules of Civil Procedure, the SEC said.

The U.S. regulator said it has requested assistance from India's law and justice department, and the process is ongoing. "SEC will continue its efforts to serve Defendants," it reiterated.

Earlier this month, Mr. Trump signed an executive order pausing the Foreign Corrupt Practices Act of 1977 for a period of at least 180 days, until the new U.S. Attorney General completes a review of the legislation.

Given the SEC's fresh filing with the court, it now appears that the executive order did not have retrospective effect. Thus, the SEC probe into the Adanis seems likely to continue unless and until the law is amended.

People familiar with the development said that the Indian authorities will take their time to act or even ask for concrete proof from the SEC before serving the U.S. regulator's complaints to the Adanis, and this is likely to be a long drawn out process.

After meeting with Mr. Trump on his trip to Washington last month, Prime Minister Narendra Modi told journalists that the two leaders did not discuss the Adani case as it was an "individual issue".

Adani group stocks came under selling pressure in the markets on Tuesday and became a trading opportunity for big traders. While Adani Enterprises lost 2%, Adani Green Energy fell nearly 4%, Adani Power dipped 0.5%, Adani Energy Solutions dropped 1%, and Adani Ports was down 0.3% on the BSE.

Even in America, Modiji covered up Adaniji's corruption!" "When filling a friend's pocket is 'nation building' for Modiji, then bribery and looting the country's wealth becomes a 'personal matter', " he added.

Congress general secretary in-charge communications Jairam Ramesh said the SEC has just informed a New York district court that it has sought the assistance of the Modi government to serve complaints on the violations of US laws by Gautam Adani and some of his colleagues.

Shares of Adani Green Energy dropped 3.75%, the group's flagship firm Adani Enterprises declined 1.78%, Ambuja Cements went lower by 1.36%, Sanghi Industries fell 1.36%, ACC slipped 0.93%, Adani Wilmar dipped 0.90%, Adani Energy Solutions (0.81%), Adani Power (0.47%) and Adani Ports (0.28%) on the BSE.

However, the stock of NDTV climbed 1.35% and Adani Total Gas went up by 0.54%.

In a parallel action, the US Attorney's Office for the Eastern District of New York unsealed criminal charges against Gautam and Sagar Adani and Cabanes, among other individuals connected to Adani Green and Azure Power.

अमेरिकी प्रतिभूति एवं विनिमय आयोग (एसईसी) ने यहां एक संघीय न्यायाधीश को बताया कि कथित रिश्वतखोरी मामले में गौतम अडाणी और सामर अडाणी के खिलाफ शिकायत संबंधी नोटिस पहुंचाने के उसके प्रयास 'जारी' हैं। इसके लिए भारतीय अधिकारियों से भी सहायता का अनुरोध किया गया है।

एसईसी ने भारतीय उद्योगपति गौतम अडाणी और सामर अडाणी को अपनी शिकायत के संबंध में नोटिस पहुंचाने के अपने प्रयासों के संबंध में न्यायार्थ के पूर्वी जिले के 'यूनाइटेड स्टेट्स डिस्ट्रिक्ट कोर्ट' के न्यायाधीश निकोलस गरफैक्स के समक्ष मंगलवार को एक स्थिति रिपोर्ट पेश की। एसईसी ने कहा कि गौतम अडाणी और सामर अडाणी दोनों 'भारत में बसे हैं, और उन्हें शिकायत का नोटिस जारी करने के लिए एसईसी के प्रयास जारी हैं। इसके लिए भारतीय अधिकारियों से दीवानी या वाणिज्यिक मामलों में न्यायिक तथा न्यायेतर दस्तावेजों की विदेश में सेवा के लिए 'हेग सर्विस कन्वेंशन' के तहत घटन का अनुरोध भी किया गया है।'

एसईसी ने कहा कि पिछले वर्ष 20 नवंबर की उसकी शिकायत में आरोप लगाया गया था कि गौतम और सामर ने 'अडाणी ग्रीन' द्वारा सितंबर 2021 की त्रह पेशकश के संबंध में अडाणी ग्रीन एनर्जी लिमिटेड के बारे में जानवूछकर या लापरवाही से गलत तथा अमाक बयान देकर संघीय प्रतिभूति कानूनों के शोखाधड़ी विरोधी प्रावधानों का उल्लंघन किया। इसने कहा कि चूंकि प्रतिवादी विदेश में रहते हैं, इसलिए संघीय दीवाने प्रक्रिया नियम (एफआरसीपी) का नियम



4(एफ) समन तथा शिकायत जारी करने की प्रक्रिया को नियंत्रित करता है।' एफआरसीपी 4(एफ) में सेवा के लिए कोई नियांसित समय सीमा नहीं है और एसईसी प्रतिवादियों को 'अंतरराष्ट्रीय रूप से सहमत किसी भी सेवा के जरिये कानूनी दस्तावेज दे सकता है।'

प्रतिभूति एवं विनिमय आयोग ने पिछले वर्ष नवंबर में गौतम, सामर और एज्योर पॉवर म्लोबल लिमिटेड के कार्यकारी अधिकारी सिरिल कैबनेस पर व्यापक स्तर पर रिश्वतखोरी की योजना की साजिश रचने का आरोप लगाया था। इसके साथ ही न्यूयॉर्क के पूर्वी

जिले के अमेरिकी अटॉनी कार्यालय ने गौतम तथा सामर अडाणी और कैबनेस के अलावा अडाणी ग्रीन और एज्योर पॉवर से जुड़े अन्य लोगों के खिलाफ आपराधिक आरोप लगाए थे। अडाणी पर अमेरिकी न्याय मंत्रालय द्वारा अनुकूल सौर ऊर्जा ठेके हासिल करने के बदले भारतीय अधिकारियों को 25 करोड़ अमेरिकी डालर की रिश्वत देने की कथित साजिश में उनकी भूमिका के लिए अभियोग लगाया जा रहा है।

अडाणी समूह ने हालांकि न्याय मंत्रालय और एसईसी द्वारा लगाए गए आरोपों को 'निराधार' करार दिया और इनका खंडन किया है। अडाणी समूह के प्रवक्ता ने बयान में कहा, 'अमेरिकी न्याय मंत्रालय और अमेरिकी प्रतिभूति एवं विनिमय आयोग द्वारा अडाणी ग्रीन के निदेशकों के खिलाफ लगाए गए आरोप निराधार हैं और उनका खंडन किया जाता है।' प्रवक्ता ने अमेरिकी न्याय मंत्रालय के एक बयान का हवाला देते हुए कहा कि अभियोग में लगाए गए आरोप तब तक केवल आरोप हैं और जब तक कि वे दोषी साबित न हो 'जाएं।' समूह ने कहा कि वह सभी संभव कानूनी विकल्प तलाश सकता है।

प्रांसिक्यूटसं ने अडानी और ग्रुप के कई अधिकारियों पर भारतीय अधिकारियों को रिश्वत देने का आरोप लगाया था। यह रिश्वत अडानी ग्रीन एनर्जी से विजली खरीदने के लिए दी गई थी। आरोप यह भी था कि अडानी ने अमेरिकी निवेशकों को गुपराह किया। उन्होंने कंपनी के भ्रष्टाचार विरोधी उपायों के बारे में गलत जानकारी दी।

झूठ बोलकर पैसा जुटाने का आरोप

घोखाधड़ी का यह मामला अडानी ग्रुप की कंपनी अडानी झीन एनर्जी लिमिटेड और एक अन्य फर्म से जुड़ा हुआ था। आरोप था कि अडानी और वाकी लोगों ने अमेरिकी इन्वर्टर्स और बैंकों से झूठ बोलकर पैसा इकट्ठा किया। फिर प्रोजेक्ट हासिल करने के लिए सरकारी अधिकारियों को 250 मिलियन डॉलर यानी करीब 2,029 करोड़ रुपए रिश्वत देने की योजना बनाई।

अडानी ग्रुप के सभी शेयर लुढ़के

अडानी ग्रुप के अधिकारियों में आज 19 फरवरी को गिरावट देखने को मिली। दोपहर के कारोबार के दौरान ग्रुप की सभी 10 कंपनियों के शेयर लाल निशान में थे। यह गिरावट इस खबर के बाद आई कि अमेरिका ने अडानी मामले में भारत सरकार से मदद मांगी है। इस रिपोर्ट के आज सबसे अधिक गिरावट दाणी ग्रीन एनर्जी के शेयरों में देखने को मिली। बाजार बंद होने पर यह 3.20 फीसदी गिरकर 869.80 रुपये के भाव पर कारोबार कर रहा था। वर्ही ग्रुप की सबसे मुख्य कंपनी, अडानी एंटरप्राइजेज के शेयर 1.55 प्रतिशत गिरकर 2,185.00 रुपये पर कारोबार कर रहे थे।






