

Hindenburg Research shut down by founder

Nate Anderson has disbanded the company after highprofile battles, including one with the Adani Group.



indenburg Research, the US investment research firm renowned for its short-selling activities, has been officially disbanded, its founder Nate Anderson announced on 15 January. The firm had gained notoriety in India in recent times for its reports that significantly impacted billionaire Gautam Adani and his business interests, resulting in billions of dollars in losses.

In his statement, Anderson said, "As I've shared with family, friends and our team since late last year, I have made the decision to disband Hindenburg Research." He explained that the plan was to wind up operations after completing their pipeline of investigative ideas. Notably, the firm recently concluded its final projects related to Ponzi schemes, marking the end of its research activities.

Adani Group

Hindenburg Research had been actively targeting the Adani Group, publishing reports throughout 2023, which led to substantial financial repercussions for Gautam Adani. A huge chunk of Adani Group's market value was wiped out following Hindenburg's accusations. The group, however, made good most of the stock market losses later. Despite the gravity of the allegations made by Hindenburg, Adani and his companies have consistently denied all the charges against them.

Anderson's rationale

The timing of Anderson's announcement is particularly striking, occurring just days after a US Republican Congressman, who is part of the House Judiciary Committee, requested the Department of Justice to

preserve all documents and communications linked to the investigations involving Adani and his companies. Anderson did not specify a singular reason for the closure of Hindenburg Research, which comes at a politically sensitive time, just before the end of President Biden's term and the upcoming swearing in of Donald Trump as the 47th President of the United States.

Addressing the rationale behind his decision, Anderson stated, "There is not one specific thing—no particular threat, no health issue, and no big personal issue." He reflected on his career, noting, "Someone once told me that at a certain point a successful career becomes a selfish act."

He expressed new-found comfort with himself and acknowledged the personal sacrifices made during his career, stating, "The intensity and focus has come at the cost of missing a lot of the rest of the world and the people I care about."

Future plans

In a subsequent interview with *The Wall Street Journal*, Anderson shared his aspirations for the future, including pursuing hobbies, travelling, and spending quality time with his fiancée and their child. He emphasised that he has accumulated enough wealth to ensure their financial security and indicated a shift towards investing in index funds and low-stress investments.

Anderson also expressed his commitment to supporting his former team members as they transition into new opportunities. He noted that some may start their own research firms, which he plans to encourage, while others are now in a position to pursue new ventures. He welcomed inquiries from those interested in collaborating with his former colleagues.

When the association first emerged, Hindenburg had said it received "hundreds of leads each year from diverse sources," such as industry experts, whistleblowers and other investors. "We rigorously vet each lead and have always maintained full editorial independence over our work."

In 2020, Hindenburg Research published a report on Facedrive, a Canadian company that went public through a reverse merger as an ecofriendly ride-sharing service, chiding it for being over valued and lavishly paying promoters. Anson allegedly exchanged emails with Anderson over the report and court documents reveal the hedge fund had

knowledge of when the report was to be published.

The filings follow a separate years-long investigation by the US Justice Department and the Securities and Exchange Commission. In June, Anson Funds Management and Anson Advisors Inc, without admitting or denying any wrongdoing, agreed to pay \$2.25 million to settle SEC claims that they failed to tell clients about payments to outside publishers of bearish research.

Last week, Anderson announced shutting down of Hindenburg Research, which made headlines globally in 2023 after publishing explosive reports about billionaire Gautam Adani's conglomerate, sparking political rows and major losses for the company.

He didn't share a specific reason for his decision, but expressed a desire to spend more time with friends and family in the future. "Nearly 100 individuals have been charged civilly or criminally by regulators at least in part through our work, including billionaires and oligarchs. We shook some empires that we felt needed shaking," he wrote announcing the decision.

SUBSTANTIAL evidence has begun to emerge against the controversial short-seller Hindenburg Research and its founder Nathan Anderson in a court battle in Ontario, Canada, exposing Hindenburg's secret ties, and potential securities fraud and faulty disclosures made by

the firm and the founder, according to media reports.

"There are multiple counts of securities fraud for both Nate Anderson and Anson Funds, and we have only reviewed 5 per cent of the material as of the time of writing," said a report by Market Frauds, a Canadian online investigative news outlet. "It is almost certain that when the entire exchange between Hindenburg and Anson reaches the SEC, Nate Anderson will be charged with securities fraud in 2025," the report states. Continued on Page 7

Continued from p1 Hindenburg's decision to abruptly close down operations has taken many by surprise, particularly due to its timing -- just three days before Donald Trump's inauguration.

In November 2024, Bloomberg's Crack Research team published an extensive report, the first in a series exposing the covert forces behind various short-sellers and research firms, including Hindenburg. The report, titled "Short-Sellers' Secret Talks and Alliances Emerge in Court Battle", centred on firms, including Hindenburg Research and Anson Funds, a Canada-based fund operated by Moez Kassam, of Indian origin. Denying any relationship with Anson, Hindenburg told Bloomberg that it receives "hundreds of leads each year from diverse sources. We rigorously vet each lead and have always maintained full editorial independence over our work," it said.

Following the article, Anderson also publicly denied any partnership with Anson or anyone else. However, leaked emails suggest otherwise. Dozens of emails exchanged between Hindenburg and Sanjeev Puri of Anson in 2019 over a trade indicate that Anson took the editorial lead, with Hindenburg having little to no editorial control. It is still uncertain whether there were any financial arrangements between the two.

Sources indicate that the Adani Group, which did not sue the short-seller, initiated covert investigations with foreign intelligence partners last year to counter those working against them. Hindenburg first released its report on the Adani Group in January 2023, leading to a market valuation loss of over \$150 billion.

The role of Anson in the attacks on the Adani Group remains unclear, with some reports alleging that its backers include organised crime. Marissa Siegal Kassam, the wife of Anson's founder, and Mahua Moitra were colleagues at JP Morgan, where Moitra worked for nearly 12 years. Moitra was the one who initiated the attacks on the Adani Group in the Lok Sabha post-Hindenburg report.
