### US attorney behind Adani case to resign

United States (US) attorney Breon Peace said he will step down on January 10, ending a stint as federal prosecutor that included high-profile cases like fraud indictment of Gautam Adani. Peace, a 53-year-old from Brooklyn, New York, said in a statement Wednesday, "it has been the honour of a lifetime to serve as the US attorney." He was appointed by US President Joe Biden in 2021 and will leave before President-elect Donald Trump takes office on January 20. Adani was indicted in November by Peace's office for allegedly defrauding US investors by concealing a bribery scheme to win Indian government contracts. BLOOMBERG

US Attorney Breon Peace, has tendered in his resignation weeks before the Trump 2.0 administration is set to take over.

In a press release by the US Department of Justice, it was announced, "Breon Peace is resigning as United States Attorney for the Eastern District of New York on January 10, 2025. Peace has served in the position since October 15, 2021."

According to the Department of Justice, First Assistant United States Attorney Carolyn Pokorny will become the Acting United States Attorney for the Eastern District of New York upon Peace's departure. Breon Peace, US Attorney for the Eastern District of New York, had recently been among those who had announced charges against Guatami Adani and other executives linking them to an alleged bribery case.

#### President-elect Donald Trump's swearing in scheduled on Jan 20

NEW DELHI

THE US Department of Justice's (DoJ) indictment of Adani Group officials in an alleged bribery case is 'extremely flimsy', senior advocate Mahesh Jethmalani said on Friday, as Breon Peace, the US Attorney behind the case, announced his resignation.

According to reports, Brooklyn US Attorney Peace, who presented charges against Adani Group officials, has announced to step down on January 10, just days away from Donald Trump's inauguration as the next US President on January 20.

53-yr-old Peace, who was appointed by outgoing US President Joe Biden in 2021, will be replaced by First Assistant US Attorney Carolyn Pokorny.

"The Adani case in US court was already a very



diluted case. There was no evidence or basis to the indictment. The uproar by the Opposition over the issue in the Indian Parliament is baseless," Jethmalani was quoted as saying in media reports.

Peace's resignation was on expected lines as he was likely to be asked by the next US administration under Trump to step down. Peace's tenure included high-profile cases such as singer R Kelly's trial for sex-trafficking, a fraud indictment of Indian billionaire Gautam Adani and the criminal conviction of a US Congressman.

Last week, Adani stocks gained following the news of FBI Director Chris Wray resigning from office early next year after the US Presidentelect replaced him with Kash Patel.

BREON PEACE, who has served as the top federal prosecutor in Brooklyn since 2021, announced on Wednesday that he plans to resign on January 10, before Republican President-elect Donald Trump's inauguration. Peace, a former longtime partner at law firm Cleary Gottlieb, was nominated as the US. Attorney for the Eastern District of New York by Democratic President Joe Biden. His deputy Carolyn Pokomy will serve as acting US attorney.

Last month, Peace's office brought fraud charges against Gautam Adani over an alleged bribery scheme. The office has also charged Linda Sun, a former aide to New York state governor Kathy Hochul, with secretly acting as an agent of the Chinese government — part of a broader effort to crack down on Beijing's influence in the US. Adani has denied the charges and is not in custody. Sun has pleaded not guilty.

"I look forward to the Office's continued courageous commitment to pursuing justice, fairly and ethically, without bias, without fear or favor, and with compassion," Peace said. During his tenure, the Eastern District secured the guilty plea of former Republican US Representative George Santos for fraud, won the conviction at trial of a former Goldman Sachs, opens new tab banker related to the looting of a Malaysian development fund, and got French cement maker Lafarge to cough up \$778 mn for making payments to groups designated as terrorists.



According to reports, Brooklyn US Attorney Peace, who presented charges against Adani Group officials, has announced to step down on January 10 - just days away from Donald Trump's inauguration as the next US President on January 20. Peace, who was appointed by outgoing US President Joe Biden in 2021, will be replaced by First Assistant US Attorney Carolyn Pokorny.

"The Adani case in US court was already a very diluted case. There was no evidence or basis to the indictment. The uproar by the Opposition over the issue in the Indian Parliament is baseless," Jethmalani was quoted as saying in media reports. Peace's resignation was on expected lines as he was likely to be asked by the next US administration under Trump to step down.

Last week, Adam stocks gained following the news of FBI Director Chris Wray resigning from office early next year after the US President-elect replaced him with Kash Patel. Despite the earlier hedge funds allegations, the Group made a roaring comeback.

In November, the DoJ indicted Group officials on allegations ranging from securities fraud to wire fraud. The Group rejected the allegations as "malicious, mis-



chievous and manipulative selections of publicly available information" to arrive at "predetermined conclusions for personal profiteering with wanton disregard for facts and the law". The indictment by the US DoJ is nothing but a "wasted expense and once Trump assumes office, such wasteful exercises involving the government offices with overseas businesses will probably fade away," investor Mark Mobius said. Carolyn Pokorny will become the acting United States attorney for the Eastern District of New York after Peace's departure.
