Mumbai: Adani Group companies reported earnings before interest, taxes, depreciation and amortisation of ₹86,789 crore for the 12 months through December 2024, an increase of 10.1% from a year earlier.

Core infrastructure businesses spanning energy, utilities and transport accounted for 84% of the total Ebitda, the group said in a release.

The group said it will look at a capital expenditure of \$100 billion over the next decade, targeting re-

newable energy, airports, green hydrogen and logistics.

As of September 30, 2024, consolidated cash after tax stood at ₹53,024 crore, with an asset base of ₹5.53 lakh crore and net debt at 2.46 times the Ebitda, which the group

said it considers to be sustainable for its large-scale investments.

Mumbai: Adani Group companies reported earnings before interest, taxes, depreciation and amortisation of ₹86,789 crore for the 12 months through December 2024, an increase of 10.1% from a year earlier.

Core infrastructure businesses spanning energy, utilities and transport accounted for 84% of the total Ebitda, the group said in a release.

The group said it will look at a capital expenditure of \$100 billion over the next decade, targeting renewable energy, airports, green hydrogen and logistics.

As of September 30, 2024, consolidated cash after tax stood at ₹53,024 crore, with an asset base of ₹5.53 lakh crore and net debt at 2.46 times the Ebitda, which the group said it considers to be sustainable for its large-scale investments.

"Adani portfolio companies are entering a new phase of significant capital expenditure," the group said.

The upcoming investments will be primarily financed through internal cash flows unlike the debt-heavy cycles previously, a compa-

ny spokesperson said.

Adani Enterprises, the flagship incubator, will lead much of the capex, focusing on green hydrogen, airports, and data centres. Adani Green Energy, Adani Energy Solutions and Adani Ports & SEZ will also play key roles, with the group aiming for global leadership across major businesses by FY30, the company said.

The group has reduced its average finance cost from 10.26% in FY19 to 8.18% on a trailing 12-month basis, improving its capacity to fund

long-term projects, the company spokesperson said. Even a half percentage point drop in borrowing costs could yield significant savings, enhancing capex efficiency.

"Regardless of external volatilities, since the Hindenburg report in January 2023, not even a single entity out of the more than 100 entities part of the Adani Portfolio companies has seen a downgrade, but only upgrades," the spokesperson said.

As of December 31, 2024, more than three quarters of the group's profits (Ebitda) came from assets rated 'AA-' and above, up from 48% in FY19, the spokesperson said.

Adani group on Thursday said it has enough cash to service debt obligations, and that its business achieved record pre-tax profits in the 12-months ending December 2024 as it looked to reassure creditors and investors of a robust business profile.

Cash balances exceed long-term debt repayments for the next 28 months, while portfolio-level cash balances were at ₹53,024 crore, the port-to-power conglomerate said in a report for the first nine months of the financial year ending March 2025 released on Thursday. "Expanding cash flows have enabled consistent investments while keeping the leverage at an all-time low. As on September 30, 2024, FFO or cash after tax for the trailing 12 months was at ₹58,908 crore," it said.

For the 12-month period ending December 2024, Ebitda touched ₹86,789 crore, marking a 10.1 per cent year-on-year growth. Adjusted for prior income, the growth stands at 21.3 per cent. **PTI**



This 'Core Infrastructure' platform comprises AEL's incubating Infrastructure businesses, Utility (Adani Green

Energy, Adani Power, Adani Energy Solutions, and Adani Total Gas), and Transport (Adani Ports and SEZ) businesses.

The credit profile has now achieved a significant milestone, with 75 per cent of the run-rate EBITDA now generated from assets with domestic ratings of 'AA-' and above, according to the company.

Adani Enterprises' Incubating infra businesses (ANIL, airports, and roads) are on a high growth trajectory and continue to lead the growth with EBITDA growth of 45.6 per cent YoY in Q3 FY25 and 33.3 per cent in TTM.

"As on 30 September 2024, Adani Portfolio had a cash balance of Rs 53,024 crore, representing 20.5 per cent of Gross Debt," it said.



Ahmedabad: Ports to power conglomerate, Adani Group, on Thursday reported its highest-ever trailing 12-month EBITDA of Rs 86,789 crore, which grew 10.1% year-on-year, the group said in a statement.

In the statement, the company outlined its plans for a high capital expenditure (Capex) phase, akin to its growth period between FY20 and FY22, as it continues to expand its infrastructure footprint across various sectors, all backed by robust cash flow and strong project execution.

The group's core infrastructure businesses—utilities, transport, and incubating infrastructure projects under its flagship company, Adani Enterprises Limited (AEL)—contributed 84% of total EBITDA. Q3FY25 EBITDA grew 17.2% YoY to Rs



22,823 crore, while EBITDA from incubating infrastructure businesses rose 45.6%. The cement business also posted a 58.8% YoY surge in Q3FY25 EBITDA.

With a strong balance sheet and ample liquidity, Adani Group ensured robust financial stability. As of Sep 30, 2024, the company maintained a cash balance of Rs 53,024 crore, covering its debt servicing obligations for at least the next 12 months.

module sales, reaching 3,273 MW.

Adani Green Energy Limited, a key player in the group's renewable energy expansion, increased its operational capacity by 37% year-on-year to 11.6 GW. Meanwhile, Adani Energy Solutions Limited secured \$1 billion through a QIP and won five new transmission projects, significantly expanding its infrastructure pipeline to Rs 54,700 crore—three times its size at the end of FY24.

Adani Power, a major contributor to the group's utility segment, posted a 21.4% YoY increase in Q3FY25 EBITDA to Rs 6,078 crore.

Adani Ports & SEZ Ltd (APSEZ) retained its position as India's largest commercial port operator, handling 332 million metric tonnes (MMT) of cargo in 9MFY25, a 7% YoY increase.


