

Analysts see conglomerate's entry driving organised sector gains

New Delhi, 20 March

Shares of large cable and wire (C&W) manufacturers came under investors' axe on Thursday as intensifying competition, following the Adani group's foray into the sector, hit sentiment. Shares of KEI Industries, Polycab India, RR Kabel, Finolex Cables, and Havells India fell up to 13 per cent on the BSE, while the benchmark BSE Sensex rose 1.19 per cent.

In a stock exchange filing on Wednesday, Adani Enterprises (AEL) informed the market that Kutch Copper, a wholly owned subsidiary, has incorporated a 50:50 joint venture (JV) company — Praneetha Ecocables — with Praneetha Ventures.

Through the JV, Adani group will manufacture, market, distribute, buy, and sell metal products, cables, and wires.

On the bourses, KEI shares plunged 15.68 per cent intraday, while Polycab fell 9.7 per cent, Havells 5.5 per cent, and Finolex 4.7 per cent. These stocks ended up to 13.3 per cent lower. AEL, meanwhile, settled 0.77 per cent higher after rising 1.6 per cent intraday.

Adani's entry into the C&W sector comes less than a month after Aditya Birla group, through UltraTech Cement, entered the industry. On February 25, UltraTech informed the stock exchanges that its board had approved a proposal to enter the construction value chain through the C&W segment, with a capital expenditure of ₹1,800 crore to be spent over the next two years.

According to analysts, the entry of larger players in the sector will drive a shift from the unorganised to the organised market while fostering healthy competition among organised players. The organised market's share has risen from 68 per cent in 2018-19 to 73 per cent in

2023-24 (FY24).

Moreover, the fundamental nature of the C&W industry, which requires new distribution channels and customer acceptance, limits any new player's immediate impact on incumbents, according to Nuvama Institutional Equities.

"The C&W industry needs a distribution channel to be largely built afresh for wires; and approvals from several customers across different user industries (railways, oil and gas, solar/agencies (that may take six to 24 months). Besides, the fragmented nature of the C&W industry makes market share gains hard to come by for a new player as each incumbent is strong in select segment/geography," said the brokerage.

Financially, while the industry enjoys reasonable margins and returns on capital employed, limiting a new player's ability to disrupt pricing materially, the brokerage estimates a 3-9 per cent earnings per share impact for incumbents for every 100-basis-point change in industrywide C&W margins.

Shares of smaller C&W manufacturers rose on Thursday on hopes of potential mergers and acquisitions. Universal Cables rallied 4.6 per cent intraday, while Cords Cable Industries gained 2.7 per cent, Plaza Wires 2.2 per cent, Ultracab (India) 3 per cent, and

Jigar Cables 5 per cent. However, three of these five stocks closed in the red.

According to analysts at Motilal Oswal Financial Services, the Indian C&W industry, valued at ₹80,000 crore at the end of FY24, posted a compound annual growth rate of 9 per cent from 2013-14 (FY14) through FY24 — 1.5 times the growth of gross domestic product. The industry continues to expand, driven by rising demand for electricity and power infrastructure, rapid growth in renewable energy, a real estate upcycle, the expansion of telecommunications, the rise of data centres, mobility, smart cities, and increasing urbanisation.

Estimates suggest that the C&W industry will grow in the mid-teens over the next five years. Branded players currently account for 74 per cent of the industry (up from 61 per cent in FY14), and this share is expected to rise to 80 per cent by 2026-27. "While there will be no change in earnings estimates for C&W companies over the next two years, there could be a derating in their valuation multiples due to the entry of a sizeable player. We cut our target valuation multiple for all C&W companies (20 per cent for Polycab, KEI, and RR Kabel each, and 10 per cent for Havell)," the brokerage had said after UltraTech's announcement.

After Birla, Adani's entry shocks cable & wire stocks

Shares of Polycab India, KEI Industries, Havells, Finolex Cables and other peers plummeted after Adani Group's foray into the cables and wires segment. This comes after Kumara Mangalam Birla owned UltraTech Cement recently announced its foray into the segment, which resulted in a major stock correction of these stocks earlier.

Adani Enterprises on Wednesday announced that its wholly-owned subsidiary Kutch Copper Ltd had completed the incorporation of the joint venture Praneetha Ecocables with Praneetha Ventures, in which KCL will



hold a 50 per cent stake.

Global brokerage UBS emphasised that the competitive intensity in the space continues to rise. UBS sees this as a negative sentiment for companies like Polycab, KEI and Havells.

MARKET SHARE

According to JM Financial, Polycab commands a market share of 20 per cent followed

by KEI (12 per cent), Havells (8 per cent) and KEC (6 per cent) in the cables segment. In the wire segment, Finolex holds a 15 per cent market share, RR Kabel (12 per cent), Polycab (10 per cent), and Havells (6 per cent). This is an industry where no single player commands more than 15 per cent share in wires and 20 per cent in cables, the domestic broker-

age said. "The industry is, therefore, ideal for a new entrant with deep pockets," it added.

KEI Industries plummeted 13.29 per cent to end at ₹2,843.65 on the BSE, after hitting a 52-low of ₹2,762 (nearly 16 per cent down from the previous close). Havells India declined 3.51 per cent to ₹1,502.70 and the Finolex Cables stock fell 4.45 per cent to ₹829.80.

Goldman Sachs has noted that the attractiveness of cables and wires is raising competition and supply build-up. However, it is optimistic on the near-term demand fundamentals of this sector as well as the export potential but is waiting for better entry points on stock.

Adani Group eyes \$500-700 m cables & wires segment foray

The Adani Group is planning to make an entry into the cables and wires (C&W) segment and scale up through acquisition in the range of \$500-700 million. Sources said that it is scouting for potential targets in the segment.

Late on Wednesday, group flagship Adani Enterprises said in an exchange filing that its wholly-owned subsidiary Kutch Copper had incorporated a joint venture (JV) company called Praneetha Ecocables that will be involved in manufacturing, marketing and selling metal, products, cables and wires.

The equal JV is with Praneetha Ventures Pvt Ltd, a Delhi-based entity involved in real estate activities.

According to sources, Adani's foray into the C&W segment is part of its \$1.2-billion copper smelter project coming up at Mundra. Production of cables, wires and copper tubes will be a downstream expansion in the project that will be used in industrial applications, retail and real estate sectors.

In order to jumpstart its foray and presence, the plan is to make an acquisition that will help it in scaling the segment faster. "We do not plan to build it from scratch. Inorganic acquisition is preferred for faster scaling," said the sources.

Kutch Copper is expected to launch its operations in the next couple of months with an initial production of 1.1 lakh tonnes per month, scaling to 5 lakh tonnes by the end of 2025, and by 2027 reaching an annual capacity of one million tonnes (mt). The long-term goal is get to two mt production capacity.



C&W SEGMENT: A SNAPSHOT

- Adani Group plans to scale up C&W business through acquisitions
- Entry of large players such as Adani will trigger consolidation in the sector
- Demand-supply gap in the C&W segment has opened up window for more entrants

Making a foray and scaling up through acquisitions is a strategy that the Adani group has been following in the cement sector, and it plans to follow a similar playbook here.

C&W SEGMENT

The Adani Group is the second big conglomerate to announce its entry into the

C&W segment after cement major UltraTech Cement said in February it was investing an initial ₹1,800 crore to set up a manufacturing facility in Gujarat, that will start production by December 2026.

Now, as then, it had the effect of knocking down the stocks of existing listed companies in the space.

The segment, dominated by organised players such as Polycab, KEI Industries, Finolex Cables and others, has been growing at 11 per cent annually in market size over the last five years, while the sales of the top six companies have been rising 15 per cent during the same period.

The supply has, however, been lagging demand, presenting opportunities for new entrants into the segment. Over the next two-three years, the existing players will be investing around ₹8,000-9,000 crore in expanding capacities to meet the demand.

M&A OPPORTUNITIES

Analysts said that the entry of the two big players will lead to consolidation in the segment and offer opportunities for mergers and acquisitions. Organised players have 70 per cent market share, with the top five players controlling 60 per cent of the organised market.

The demand in the segment is being driven by the power sector especially renewables, real estate and infrastructure.

वायर और केबल क्षेत्र में अदाणी समूह के प्रवेश से प्रतिस्पर्धा बढ़ने के कारण गुरुवार को प्रमुख वायर और केबल निर्माता कंपनियों के शेयर में भारी गिरावट आई। बीएसई पर केईआई इंडस्ट्रीज, पॉलिकैब ईंडिया, आरआर केबल, फिलालेस केबल्स और हैवेल्स ईंडिया में 13 फीसदी तक की गिरावट आई, जबकि बीएसई के सेसेक्स में 1.19 फीसदी की तेजी दर्ज की गई।

बुधवार बाजे स्टॉक एक्सचेंज को दी जानकारी में अदाणी एंटरप्राइजेज ने बताया कि कंपनी की एग्स्ट्रामिल्ट वाली सहायक कंपनी कच्छ कॉमर लिमिटेड ने प्रणीत वैचर्स प्राइवेट लिमिटेड के साथ 50:50 के अनुपात में संयुक्त उद्यम कंपनी 'प्रणीता इकोकेबल्स लिमिटेड' का गठन किया है। इस संयुक्त उपक्रम के जरिये अदाणी समूह धृत उतार, केबल और वायर का निर्माण, विक्री, वितरण, खरीद करेगा।

The stock market extended its winning streak on fourth straight session on Thursday, led by positive global markets after the US Federal Reserve held the benchmark interest rate steady.


At close, the Sensex was up 899.01 points or 1.19 per cent at 76,348.06, and the Nifty was up 283.05 points or 1.24 per cent at 23,190.65.

Indian indices had opened gap-up with Nifty above 23,000 and extended the gains to cross 23,200 intraday, before closing near day's high.

The BSE Midcap and Smallcap indices recorded 0.5 per cent gains, reflecting strong momentum across the board.

In terms of sectors, all ended in the green with metal, media, IT, FMCG, auto, consumer durables, realty, telecom up 1 per cent each.

IT stocks surged after Fed reaffirmed two rate cuts for 2025, boosting investor confidence rising by 1.3 per cent, marking a five-session high,



as domestic IT stocks tracked US tech stock gains.

On Nifty, 44 out of the 50 constituent stocks settled higher, with gains led by Bharti Airtel, Titan, Britannia, Eicher Motors, and Bajaj Auto, which rose by up to 4.08 per cent. IndusInd Bank, Trent, Shriram Finance, and Bajaj Finance were among the few stocks that ended lower by up to 1.11 per cent while UltraTech Cement and Axis Bank were the only two constituent stocks of Nifty

that settled flat.

On the BSE, over 100 stocks touched 52-week low including KEI Industries, Paushak, Veritas, Kesoram Industries, GVK Power, Suyog Telematics, EKI Energy, among others.

IndiGo hit a fresh record high, rising 4 per cent amid continued bullish sentiment from brokerages. Hindustan Copper also jumped 6 per cent as copper prices surged past \$10,000 per ton.

Some of the key loafers

On Nifty, 44 out of 50 stocks closed higher, led by Bharti Airtel, Titan, and Britannia, while IndusInd Bank, Trent, and Shriram Finance declined. UltraTech Cement and Axis Bank remained flat.

were KEI plunging 13 per cent while Polycab fell 9 per cent and Havells fell over 5 per cent after Adani Group announced its entry into the cables & wires segment with its joint venture, Praneetha Ecocables.

Further, the shares of Paytm also fell 6 per cent after Jefferies maintained a 'hold' rating, citing growth concerns and potential roadblocks. The crisis-ridden IndusInd Bank shares declined over 1 per cent, reversing early gains after RBI termed its derivatives issue an isolated case.

While global uncertainties continue to contribute to volatility, recent measures by the government and central bank are expected to support economic growth.
