New Delhi: The Supreme Court on Monday dismissed an application seeking directions to the Securities and Exchange Board of India to complete the pending investigation expeditiously and give a final report into the US-based Hindenburg Research's allegations against the Adani Group.

The apex court also upheld its registrar's order that refused to accept the application by petitioner-in-person, advocate Vishal Tiwari, wanting a direction to Sebi and the government to file a status report on the progress made on the recommendations given by the SC-appointed Justice Sapre panel.

In March 2023, the top court had formed a six-member committee headed by former Supreme Court judge AM Sapre to investigate the research firm's allegations of stock manipulation against the Adani Group. While the com-

mittee in its report stated that it could not conclude that there was regulatory failure by Sebi in the case, the SC had asked the government and Sebi to consider the Sapre panel's recommendations to strengthen Indian investors' interest.

In March 2023, the top court had formed a six-member committee headed by former Supreme Court judge AM Sape to investigate the research firm's allegations of stock manipulation against the Adani Group. While the committee in its report stated that it could not conclude that there was regulatory failure by Sebi in the case, the SC had asked the government and Sebi to consider the Sape panel's recommendations to strengthen Indian investors' interest.

In the Adani-Hindenburg case, the top court had last year in January held that there

was no ground to transfer the Sebi's probe either to a special investigation team or the Central Bureau of Investigation. It refused to give any directions or interfere with the Sebi's jurisdiction, noting that the latter's regulations do not suffer from any infirmities. Noting that the Sebi has completed investigation in 20 out of 22 matters in the Adani-Hindenburg case, the apex court had directed the market regulator to complete its probe in the remaining two cases within three months.

Tiwari in his application had also highlighted the new Hindenburg Research's allegations that were published in August where it claimed that Sebi chairperson Madhabi Puri Buch created an "atmosphere of doubt", making it incumbent for the SC to conclude its probe against the Adani Group.

The report alleged that Buch and her husband, Dhaval Buch, held stakes in offshore funds which were also allegedly used by Vinod Adani, the elder brother of Adani Group chairman Gautam Adani, to invest in Indian stocks, including in Adani Group companies. This raised the prospect of conflict of interest in Sebi's investigation of the Hindenburg Research's previous allegations against the Adani Group, the report had said.

The petitioner said that Buch had denied these allegations as baseless and the apex court had also held that third-party reports cannot be considered.

The SC in its January 3 last year's judgement had declined to order a CBI or SIT probe on the grounds that the market regulator was conducting a "comprehensive investigation" that "inspires confidence." Noting that the Sebi has completed investigation in 20 out of 22 matters in the Adani-Hindenburg case, it had then said that no apparent regulatory failure can be attributed to Sebi and there was prima facie no deliberate inaction or inadequacy in the investigation by it.

SC turns down plea on Adani-Hindenburg

THE Supreme Court has upheld an order passed by the apex court registry in August 2024 refusing to admit a lawyer's application seeking direction to Sebi to submit its conclusive probe report into the Adani-Hindenburg controversy. Advocate Vishal Tiwari had moved an appeal against the order passed by the Registrar on August 5 last year.

Earlier on July 15, 2024, the top court had dismissed a review petition filed against its earlier verdict refusing to form any SIT or group of experts to conduct an investigation. After perusing the review petition, a bench, headed by then CJI DY



Chandrachud said that there was no error apparent on the face of the record.

"No case for review under Order XLVII Rule 1 of the Supreme Court Rules 2013. The review petition is, therefore, dismissed. Pending applications, if any, stand disposed of," added the Bench, also comprising Justices JB Pardiwala and Manoj Misra.

Reports prepared by third-party organisations such as the OCCRP and Hindenburg Research can't be regarded as 'conclusive proof', SC said.

SC rejects fresh Hindenburg-Adani matter application

New Delhi: Supreme Court Monday rejected an application filed by advocate Vishal Tiwari, challenging SC registrar's order declining to list his previous application related to Hindenburg-Adani group controversy.

SC registry had on Aug 5 refused to register his application citing absence of a "reasonable cause" for registration. In his plea, Tiwari pleaded that the registry be directed to accept his application so that it could be listed and heard before the court. At the outset of hearing, a bench of Justices J B Pardiwala and R Mahadevan said it was not inclined to entertain the plea and threatened to impose cost on the petitioner. The bench, however, dismissed the plea without imposing cost.

The petitioner in his application contended that market regulator Sebi must complete and disclose the results of its probe into the allegations, arising out of Hindenburg's report. He said the registrar's decision to reject his application under Order XV Rule 5 of Supreme Court Rules, 2013, had effectively barred him from pursuing legal remedies. TNN

The Supreme Court has upheld an order passed by the apex court registry in August 2024 refusing to admit a lawyer's application seeking direction to SEBI to submit its conclusive probe report into the Adani-Hindenburg controversy.

Advocate Vishal Tiwari had moved an appeal against the order passed by the Registrar on 5 August last year.

Earlier on 15 July 2024, the top court had dismissed a review petition filed against its earlier verdict refusing to form any SIT or group of experts to conduct an investigation. After perusing the review petition, a bench, headed by then CJI D.Y. Chandrachud said that there was no error apparent on the face of the record.

"No case for review under Order XLVII Rule 1 of the Supreme Court Rules 2013. The review petition is, therefore, dismissed. Pending applications, if any, stand disposed of," added the Bench, also comprising Justices J.B. Pardiwala and



Manoj Misra.

In a detailed order passed on 3 January, the Supreme Court had said that reports prepared by third-party organisations such as the Organized Crime and Corruption Reporting Project (OCCRP) and Hindenburg Research cannot be regarded as "conclusive proof".

It had said that the reliance placed by PIL litigants on newspaper articles or reports by third-party organisations "does not inspire confidence" to question the comprehensive investigation undertaken by the SEBI.

The apex court said that the facts in the case did not warrant a transfer of investigation from the SEBI and asked the market regulator to take its investigation to a logical conclusion in accordance with the law.

The SC had also cautioned against the use of unverified and unrelated material in the filing of public interest litigations (PILs), adding that pleas lacking adequate research and relying on unverified and unrelated material tend to be "counterproductive". However, it had asked the Central government to constructively

consider the suggestions made by the expert panel headed by former apex court judge Justice A.M. Sapre.

"The Government of India and SEBI will take any further actions as are necessary to strengthen the regulatory framework to protect investors and ensure the orderly functioning of the securities market," it said. The apex court had asked SEBI and other investigative agencies of the Union government to probe into allegations of short selling resulting in loss of investors' value.

It had noted that the SEBI has already finalised 22 out of 24 investigations relating to allegations against the Adani group of companies and in relation to the remaining two cases, the market regulator has sought information from foreign agencies and entities and will determine future course of action based on receipt of such information.

However, the Supreme Court had said that these pending investigations should be completed "expeditiously within a period of three months".

नई दिल्ली, (पंजाब के सरोरी): सुप्रीम कोर्ट ने हिंडनबर्ग मामले में आगे सुनवाई जारी रखने से साफ इनकार कर दिया है। कोर्ट ने इस मामले में दाखिल याचिका को भी खारिज कर दिया है। साथ ही कोर्ट ने याचिकाकर्ताओं से पूछा है कि बताएं, कितना जुर्माना लगाया जाए। आपको बत दें कि हिंडनबर्ग मामले में याचिकाकर्ता विशाल तिवारी ने सुप्रीम कोर्ट में याचिका दाखिल की थी। हालांकि, 5 अगस्त 2024 को सुप्रीम कोर्ट रोजस्ट्रर ने विशाल तिवारी की अजी को लिस्ट करने से इनकार कर दिया था। कुछ दिन पहले ही अमेरिका स्थित शार्ट सेलर कंपनी हिंडनबर्ग रिसर्च को बंद करने की घोषणा की थी। इसकी घोषणा सुन्दर इसके संस्थापक नेट एंडरसन



ने की थी। नेट एंडरसर ने हिंडनबर्ग वेबसाइट पर एक नोट लिखकर कहा था कि वे हिंडनबर्ग रिसर्च को खत्म करने का निर्णय लिया है। ये पहले ही प्लान किया गया था कि जिन विचारों के लिए वे काम कर रहे हैं उनके पूरा होने के बाद कंपनी को बंद कर दी जाएगी। पिछले पांच वर्षों मामलों के मुताबिक, जिन कामों के अभी पूरा किया है उनको विनियामकों के साथ शेयर करने के बाद वे दिन आ गया है।

उच्चतम न्यायालय ने सोमवार को कहा कि 30 जनवरी को होने वाले चंडीगढ़ महापौर कुप्रथा के लिए वे एक स्वतंत्र पर्यवेक्षक नामित करेगा। न्यायमूर्ति सर्वकात्ता और न्यायमूर्ति एन कोटिलाट टिक्के ने पर्यवेक्षक का नाम लिए जिनमें आदेश पालित किया गया कि समृद्धी सामाजिक उन्नती (पर्यवेक्षक की) औजृदगी में को जाए और इसकी वीडियोस्पॉफी कराई जाए। पीठ ने कहा कि चंडीगढ़ प्रशासन स्वतंत्र पर्यवेक्षक को मानदेश का मृगतान करेगा। गौजुड़ा महापौर कुलदीप कुमार की ओर से न्यायालय में पैसा, पंजाब सरकार के महानियक्षा गुरुगिंदर सिंह ने सुझाव दिया कि उच्च न्यायालय के किसी सेवानिवृत् न्यायाधीश को स्वतंत्र पर्यवेक्षक नियुक्त किया जा सकता है। चंडीगढ़ प्रशासन का प्रतिनिधित्व कर रहे सालिलोट असल यूएस मेहता ने कहा कि स्वतंत्र पर्यवेक्षक नियुक्त जिसे जाने से उन्हें कोई परेशानी नहीं है तो कैफियत यह एक दृष्टिकोण नहीं बनाता वहाँ जिससे कि सभी नगर निकाय शीर्ष अदालत का ठिकाना बनने लगें। पीठ ने कहा कि वह दलीलें दर्ज करते समय केवल प्रक्रिया की नियमितता और घटनारूपों को लेकर विविध हों और पर्यवेक्षक का नाम लिए जिस आदेश पालित किया गया है। उन्हें वाद में नामित किया जाएगा।




