The defendants, who are based in India, are yet to be officially served.

US SEC has to serve the summons to Adani Group founder and chairman Gautam Adani and his nephew Sagar in the alleged \$265 million payoffs to win lucrative renewable power supply contracts through proper diplomatic channels as it has no jurisdiction to summon a foreign national directly.

The SEC originally filed the complaint on November 20, 2024, alleging that two violated US securities laws by making false and misleading statements related to a September 2021 bond offering by Adani Green Energy Ltd.

According to the SEC, Rule 4(f) of the Federal Rules of Civil Procedure governs service in foreign jurisdictions and permits the use of international treaties, such as the Hague Convention. The rule does not impose a specific time limit for service, provided reasonable efforts are being made. **PTI**

The SEC originally filed the complaint on November 20, 2024, alleging that two indi-

viduals violated US securities laws by making false and misleading statements related to a September 2021 bond offering by Adani Green Energy Ltd.

SEC said it had previously requested assistance from India's ministry of law and justice in serving the summons and complaint on Adani in India.

Gautam Adani, 63, and seven other defendants, allegedly agreed to pay about \$265 million in bribes to Indian government officials between approximately 2020 and 2024 to obtain lucrative solar energy supply contracts on terms that expected to yield \$2 billion of profit over 20 years, according to an indictment unsealed in a New York court in November last year. ¶¶

अमेरिकी बाजार नियामक ने अदालत से कहा अभी तक अडाणी को नहीं भेज पाए समन

न्यूयार्क, 27 जून (भाषा)।

अमेरिकी प्रतिभूति और विनियम आयोग (एसईसी) ने न्यूयार्क की एक अदालत को सौंपी स्थिति रपट में कहा है कि वह भारतीय उद्योगपति गौतम अडाणी और उनके भतीजे को समन भेजने की कोशिश में लगातार जुटा हुआ है। यह मामला पिछले साल दायर एक दीवानी प्रतिभूति मामले से जुड़ा हुआ है।

अमेरिकी बाजार नियामक ने शुक्रवार को न्यूयार्क के पूर्वी जिले के अमेरिकी जिला न्यायालय के मजिस्ट्रेट न्यायाधीश जेम्स आर चो को सूचित किया कि वह 'हेग सेवा संधि' के नियमों के तहत गौतम अडाणी और उनके भतीजे सागर अडाणी को समन और शिकायत औपचारिक रूप से भेजने के लिए काम कर रहे हैं। प्रतिवादियों के भारत में निवास करने की वजह से एसईसी उन्हें अभी तक ये कानूनी दस्तावेज आधिकारिक तौर पर नहीं सौंप पाया है। अमेरिकी एसईसी को ये समन उचित कूटनीतिक माध्यमों से ही भेजने होंगे, क्योंकि उसके पास सीधे किसी विदेशी नागरिक को समन भेजने का अधिकार नहीं है। यह मामला कथित तौर पर 26.5 करोड़ डॉलर के भुगतान से संबंधित है। आरोप है कि नवीकरणीय ऊर्जा आपूर्ति अनुबंध हासिल करने के लिए यह भुगतान किया गया

था। प्रतिभूति एवं विनियम आयोग ने मूल रूप से 20 नवंबर, 2024 को इस मामले में शिकायत दर्ज की थी।

इसमें आरोप है कि गौतम अडाणी और सागर ने अडाणी ग्रीन एनर्जी लिमिटेड के सितंबर 2021 बांड के बारे में झूठे और भ्रामक बयान देकर अमेरिकी प्रतिभूति कानूनों का उल्लंघन किया है। एसईसी ने बताया कि संघीय दीवानी प्रक्रिया नियमों का नियम 4 (एफ) विदेशी न्याय-क्षेत्रों में दस्तावेजों की तामील (सेवा) को नियंत्रित करता है और हेग संधि जैसी अंतरराष्ट्रीय संधियों के उपयोग की अनुमति देता है। उसने कहा कि यह नियम कानूनी दस्तावेजों की तामील के लिए कोई विशिष्ट समय सीमा तय नहीं करता है, बशर्ते कि उचित प्रयास किए जा रहे हों। अमेरिकी अदालत ने एसईसी से कहा है कि वह 11 अगस्त, 2025 तक इस मामले में अद्यतन जानकारी मुहैया कराए। एसईसी ने अदालत को बताया कि चूंकि प्रतिवादी भारत में हैं, लिहाजा उन्हें दस्तावेज देने की कोशिशें जारी हैं। इसमें हेग संधि के तहत भारतीय अधिकारियों से मदद मांगी गई है, ताकि दीवानी या वाणिज्यिक मामलों में न्यायिक और न्यायेतर दस्तावेजों की विदेश में तामील सुनिश्चित की जा सके। अमेरिकी बाजार नियामक ने पहले भी भारत के विधि और न्याय मंत्रालय से अडाणी पर समन और शिकायत की तामील करने के लिए मदद मांगी थी।
