Mumbai: Adani Energy Solutions on Thursday announced the acquisition of a project special purpose vehicle, Mahan Transmission, which will evacuate 1,230 MW of power from Adani Power's upcoming 1,600 MW expansion units at Mahan in Singrauli district.

"The company has on 26th March, 2025... executed a share purchase agreement with REC Power Development and Consultancy Ltd for acquiring 100 per cent equity shares of Mahan Transmission Ltd (MTL)," Adani Energy Solutions said in a regulatory filing.

According to the filing, equity shares were acquired at a face value of ₹10 each for a cash consideration. It said the acquisition has been completed and MTL has a total authorised and paid-up share capital of ₹5 lakh.

Adani Energy Solutions said the acquisition would further its strategy of enhancing value for its shareholders through organic and inorganic opportunities.

Mahan Transmission will evacuate 1,230 MW of power from Adani Power's upcoming 1,600 MW expansion units at Mahan in Singrauli district and feed into the state grid. —

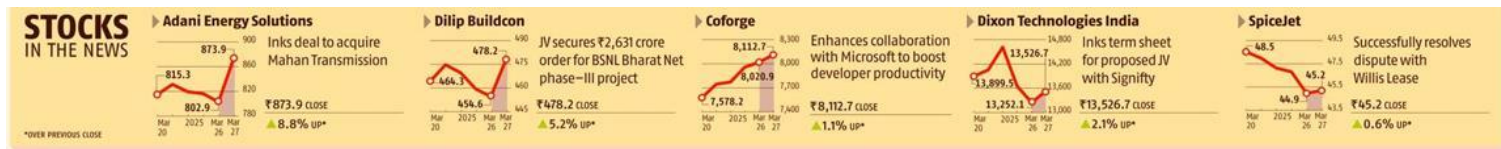

Adani arm buys Mahan Transmission

ADANI ENERGY SOLUTIONS (AESL) on Thursday announced acquisition of a special purpose vehicle (SPV) Mahan Transmission (MTL). The company on March 26 executed a share purchase agreement with REC Power Development and Consultancy for acquisition of 100% stake in Mahan Transmission.

The project will evacuate 1,230 MW power from Adani Power's upcoming 1,600 MW

expansion units at Mahan in Singrauli district in Madhya Pradesh. MTL is a ₹2,200 crore intra-state transmission project.

The project involves setting up of 2,800 Mega Volt-Amperes (MVA) of substations capacity and 740 circuit kilometers (ckm) of transmission line, taking AESL's transmission network to 26,668 ckm and 89,986 MVA of transformation capacity. The project will be delivered

by April 2027.

"This acquisition is proposed to further AESL's strategy for enhancing value for its shareholders through organic as well as inorganic opportunities," AESL said in an exchange filing.

AESL won the project under the Tariff Based Competitive Bidding (TBCB) mechanism, and REC Power Development and Consultancy was the bid process coordinator. —FE BUREAU

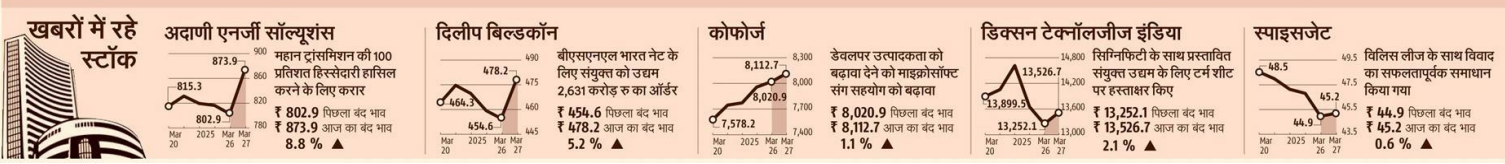

Mahan Energy Ltd (MEL) is a subsidiary of Adani Power Ltd and the InSTS scheme under discussion relates to evacuation from the capacity expansion of 2x800-MW at the Mahan power plant. The InSTS scheme mainly involves building two 400/220/132kV substations — one each at Rewa and Amarpatan — along with associated lines.

For AESL, Mahan Transmission Ltd represents the second InSTS-TBCB win in Madhya Pradesh after 'MP Power Transmission Package-II Ltd' that is currently under construction.

This acquisition marks another milestone in Adani Energy's commitment to strengthening India's power sector through organic and inorganic growth opportunities. With this move, AESL continues to reinforce its leadership in energy transmission, ensuring reliable power supply while enhancing value for its stakeholders, the statement said.

10 Adani group stocks end higher

Ten Adani group stocks ended higher on Thursday, with Adani Energy Solutions rising nearly 9 per cent, in tandem with an optimistic trend in the equity market. Shares of Adani Energy Solutions soared 8.84 per cent, Adani Green Energy surged 5.25 per cent, Adani Power jumped 4.39 per cent, Adani Total Gas advanced 2.32 per cent, Ambuja Cements went up 2.13 per cent, Adani Enterprises climbed 2.05 per cent, Adani Wilmar (1.85 per cent), Sanghi Industries (1.66 per cent), ACC (1.44 per cent), and Adani Ports (1.38 per cent) on the BSE. The stock of NDTV dipped 0.39 per cent.

Adani resumes power supply to Dhaka

Calcutta: Adani Power Ltd has resumed supply of electricity to Bangladesh from its power plant in Jharkhand after the neighbouring country started payments.

Both units of the 1,600 (800x2) mega watt thermal power plant at Godda are now operating and supplying electricity to Bangladesh Power Development Board.

However, the payment coming in from across the border only covers the current consumption, sources said, adding that dues continue to be \$820-\$830 million.

The ultra-supercritical plants were commissioned in April and June 2023 and the revenue model of India's first transnational project is based on a dollar denominated 25-year power purchase agreement.

The Godda plant is connected to the Bangladesh grid

with a 400 KV dedicated transmission line that goes through Bengal. Electricity from the Adani plant largely caters to the north of the country.

A Bangladeshi senior official also confirmed that BPDB is making payments to Adani and receiving electricity as per requirement.

Resumption of the Godda unit and payment from Bangladesh lifted the stock of Adani Power Ltd on the bourses on Thursday. It ended the day at ₹519.65 with a gain of 4.39 per cent, or ₹21.85 a share, on the BSE when the Sensex gained only by 0.41 per cent.

The stock reaction under-

scores the relief from an uncertainty surrounding the financial viability of the Godda power plant after the political transition in Bangladesh with the present regime often voicing concerns about allegedly inflated power tariff from Adani plant.

Dues from Bangladesh has been on an upward curve even before the transition but the dues have ballooned in the last 8 months.

Adani's power tariff to BPDB has two components: capacity charge and variable charge. While the capacity charge is fixed, variable charge is dependent on coal cost.

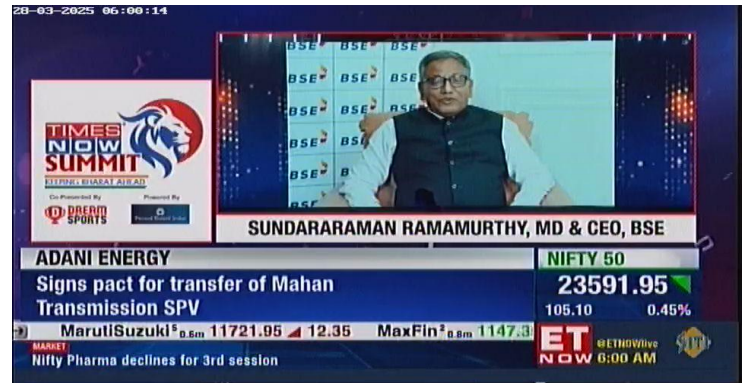
