'Yahi samay hai,' PM bats for Odisha

ASSERTING his backing to Odisha in its journey towards fastpaced economic growth and development, PM Narendra Modi on Tuesday said that this was the right time to invest in the state.

"Yahi Samay Hai, Sahi Samay Hai (this is the time, the right time). Your investment in this development journey of Odisha will take you to new heights of success. This is Modi's guarantee," he said urging investors to explore the potential of the state.

After inaugurating the Utkarsh Odisha: Make-in-Odisha Conclave 2025, Modi reaffirmed his love for the state and his commitment to its progress and prosperity. "As prime minister, I have come here for around 30 times. I have visited Odisha more times than all the prime ministers combined. I have gone to most of the districts in the state. This is due to the love and affection of the people. I have faith in the potential of Odisha, I have faith in the people here," he said. Praising CM Mohan Charan

Praising CM Mohan Charan Majhi for his efforts in accelerating development, he described the state as a symbol of optimism and originality of a new India.

"Odisha has a significant role to play in the development of a prosperous India. It is becoming one of India's leading states in various industries, in-

cluding food processing, petrochemicals, port-led development, fisheries, IT, edutech, textiles, tourism, mining, and green energy," he said.

Addressing the industry and business gathering, the PM also stressed on the urgent need to shift from export of raw materials to value addition within the country. "Mineral resources extracted from our country are exported outside where there is value addition and a finished product comes back to India as import. This trend is unacceptable and must end," he said.

India cannot rely on fragmented and import-based supply chains. Instead, a robust supply and value chain must be built within India to minimise the impact of global uncertainties. This responsibility lies with both the government and the industry, he said. The successes of Coldplay's concerts in Mumbai and Ahmedabad also did not escape the notice of the PM, who said, it pointed towards emergence of a new sector of concert economy.

"In the last few days, you must have seen the wonderful pictures of the Coldplay concerts held in Mumbai and Ahmedabad. This is proof of how much scope there is in India for live concerts. Big global artistes are getting attracted to India. The concert economy boosts tourism and creates numerous jobs," he said.

Adani to invest ₹2.3L cr in Odisha

NEW DELHI: Adani Group on Tuesday committed to investing Rs 2.3 lakh crore over the next five years across power, cement, industrial parks, aluminium and city gas expansion in Odisha.

According to a statement by the group, the investment commitment was made during Utkarsh Odisha 2025 - the state's investor meeting.

Karan Adani, Managing Director of Adani Ports and SEZ Limited (APSEZ), met state Chief Minister Mohan Charan Majgi and exchanged Memorandum of Understandings (MoUs) for investment in Odisha over the next five years, it added.

"The Adani Group committed to invest Rs 2.3 lakh crore over the next five years across power, cement, industrial parks, aluminium, city Gas etc," the statement said.

It, however, did not give details.

"This is the biggest investment intent by any group in Utkarsh Odisha 2025."

Also, the first test flight landed at Dhamra Airstrip successfully on Tuesday.

Additionally, on the occasion of Utkarsh Odisha, six projects of ATGL in Odisha were commissioned. These include an elec-

tric vehicle charging station at Bhubaneswar airport and the completion of the city gate station cum mother station project.

Other projects include the groundbreaking for an LNG cum multi-fuel hub at Bhadrak, a CNG station in Balasore, the first domestic piped cooking gas charging and burner in Bhadrak and a CNG station project completion at Rairangpur (1st in the city) of Mayurbhanj district.

"It will be open to the public soon," it added. PII

At least 54 MoUs have been signed already and the total investment will be around Rs 4.5 lakh crore . Besides Adani Group, the JSW has signed MoU for a 5MTPA steel mill in Keonjhar, IOCL will invest Rs 70,000 crore, the Aditya Birla Group, Vedanta, JSP and others have also inked MoUs.

Chief Minister Mohan Charan Majhi said "we had an initial target of Rs 5 lakh crore investment proposals but as it appears now we will achieve three times more than the target".

The Conclave will conclude on Wednesday and the final figures in terms of MoUs and investment proposals will be known.

Referring to Odisha's historical trade links with Southeast Asia, he remarked on the cultural significance of Bali Yatra and recalled the Indonesian President's recent visit, where he mentioned Odisha's cultural ties to Indonesia.

Minister The Prime pointed out Odisha's evolving role in the 21st century. underscoring its renewed connection with Southeast Asia and growing interest from ASEAN countries in strengthening trade and cultural ties. He called on investors to seize opportunities in Odisha's development, assuring that their contributions would yield significant success. PM Modi also lauded

Touching on Odisha's tourism potential, the PM described it as a unique destination offering a blend of faith, spirituality, nature, and heritage. He encouraged initiatives like "Wed in India" and "Heal in India," showcasing Odisha's 500-kilometer coastline and eco-tourism prospects. Target 80: "While 54 MoUs have already been signed, we expect the total to reach around 80 in next 2–3 hours," announced Additional Chief Secretary and Odisha Industries Secretary Hemant Sharma during the Make in Odisha Conclave on Tuesday.

Addressing reporters, Sharma explained that some of the MoUs had been finalized in advance, while others were set to be signed during the CEO Roundtable, which Chief Minister Mohan Majhi is scheduled to attend. "Given the sheer number of agreements, it won't be physically possible to exchange all 54 MoUs. Instead, companies will make formal announcements," he added.

The event gained momentum following Prime Minister Narendra Modi's inaugural address, in which he endorsed the Chief Minister's vision and highlighted Odisha as a prime destination for investment.

Earlier in the day, Naveen Jindal announced a Rs 70,000 crore investment by JSPL. This was followed by the Adani Group committing the largest investment of the day — Rs 2.28 lakh crore — across sectors like cement, power, alumina, smelters, energy, and industrial parks.

Sajjan Jindal's JSW Group also signed an MoU to establish a 5 MTPA steel plant in Keonjhar district with an investment of Rs 35,000 crore, in the presence of the Chief Minister.

Sharma noted that the government is optimistic about attracting Rs 5 lakh crore worth of investments through the conclave, which has drawn industry leaders, foreign envoys, and delegations from over 16 countries.

Bhubaneswar, Jan 28: Prime Minister Narendra Modi Tuesday said he cannot accept raw materials getting exported and finished products being shipped into the country, asserting that value additions must happen in India.

Inaugurating the 'Utkarsh Odisha, Make in Odisha Conclave' at Janata Maidan here, Modi said he considers eastern India as the growth engine of the country, and the state plays an important role in it.

"The country's development is not possible only by exporting raw materials. Therefore, we are changing the entire ecosystem and working with a new vision," he said.

"The minerals are extracted here and exported to some other country where value addition is done and finished products are then sent back to India. This trend is not acceptable to Modi," he added, citing the example of the export of marine products for processing in other countries. Urging all to recognise the challenges of the global supply chain in a changing world, the PM said India cannot rely on fragmented and import-based supply chains.

"Instead, a robust supply and value chain must be built within India to minimise the impact of global fluctuations. This responsibility lies with both the government and the industry," he said.

The PM said the milestone of a USD 5 trillion economy was



not far away for India.

He said India's economy rests on two major pillars -the innovative service sector and quality products. "The potential for green jobs is also growing significantly. There is a need to adapt to the demands and requirements of the times. India is focusing on green technology and a green future, including solar, wind, hydro, and green hydrogen, which will power the energy security of a developed India," he said. The PM said the aspirations of crores of people were driving India's movement on the path of development.

"Today, India is moving on a path of development driven by the aspirations of crores of people. This is an era of AI. However, the aspiration of India, not just AI, is the power of our country. Aspiration grows when the needs of the people are fulfilled. In the last decade, the country has witnessed the benefit of empowering crores of people. Odisha represents the same aspiration," he said.

Modi said the 21st century is about connected infrastructure and multi-modal connectivity.

"India is building specialised infrastructure at unprecedented speed and scale. It will make India a great destination for investment," he said.

The PM said ASEAN countries have shown interest in strengthening trade ties with Odisha. "I consider eastern India as the growth engine of the country, with Odisha playing a crucial role in this. Vedanta's ₹1L-cr project in Rayagada

BHUBANESWAR: Mining conglomerate Vedanta Tuesday said the company's Rs 1-lakh crore aluminium refinery and smelter proj-ect will be set up in Rayagada district the first phase of which is to be commissioned in the next three years, company Chairman

Anil Agarwal said. Speaking on the sidelines of Utkarsh Odi-sha-Make in Odisha, Agarwal said, "We will establish the aluminium refinery of 6 MTPA capacity and aluminium smelter of 30 lakh tonne capacity in Rayagada district. The total investment will be around Rs 1 lakh crore." He said the mining conglomerate has got

Sijimali bauxite mine in Rayagada district, which is now being developed for explora-tion. During his meeting with Chief Minis-ter Mohan Charan Majhi here in October, the Vedanta chairman had promised to set up an alumina refinery and an aluminium plant in the state with an investment of Rs lakh crore. Vedanta group has already made signifi-

cant investments in Odisha, amounting to more than Rs 1 lakh crore, Agarwal said.

JSP to invest addl ₹70K-crore

BHUBANESWAR: Jindal Steel & Power (JSP) Tuesday said it will invest an addition-al Rs 70,000 crore in Odisha in the coming years. The announcement was made by the company's Chairman Naveen Jindal during the 'Utkarsh Odisha: Make in Odisha Con-

clave 2025' here. "Our vision is to make Odisha a global in-dustrial leader, while improving the quality of life for its people consistently. This additional Rs 70,000 crore investment will not only drive industrial growth, but also uplift the quality of life of thousands of families in Odisha," Jindal said. He also said the company was exploring the possibility of setting up a steel plant in Ke onjhar district to fulfil the vision of the CM. Jindal Steel & Power operates India's first coal gasification plant for steel production in Angul gasincation piant for steel production in Angui with focus on reducing dependence on import-ed coking coal. "The company's Angul plant, currently at 6-MTPA capacity, will double to 12-MTPA this year and is set to reach 52-MTT-PA by 2030, positioning it as the world's largest and greenest steel plant, and a leader in hydro-gen-based green steel production," Jindal said.

JSW's steel plant in Keonjhar

BHUBANESWAR: Saijan Jindal-led JSW Group Tuesday inked a pact with the state government to set up a 5-million tonne per annum (MTPA) steel plant in Keonjhar district. The agreement was signed in presence of

Chief Minister Mohan Charan Majhi and Sajjan Jindal here on the first day of 'Utkarsh Odisha: Make in Odisha Conclave 2025'.

"The JSW (Group) will set up a 5-MTPA steel plant in Keonjhar district at an invest-ment of around Rs 35,000 crore." Industries department Additional Chief Secretary Hemant Sharma told reporters.

Keonihar district is located in the iron ore reserves belt, and the minerals were being exported to other areas from the district. As a result, the locals did not get any benefit from the mineral resources, Jindal said. Asked whether South Korean steel major

POSCO is also a part of the proposed Keon-jhar project, Jindal said, "It has not yet been decided whether we will go for collaboration with some other firm. It will be decided in the future course."

Avaada pledges ₹20,700cr

NEW DELHI: Ayaada Group Tuesday said it has inked a pact to invest Rs 20,700 crore to develop renewable energy projects in Odisha. The investment will be utilised for the de-

velopment of 1,500 MW of floating solar projects, two 1,000 MW Pumped Storage Projects (PSPs) and green energy equipment manu-facturing units in the state, the company said in a statement. The company has reaffirmed its commitment to sustainable growth by signing a Rs 20,700-crore agreement with the Odisha government in the presence of Chief Minister Mohan Charan Majhi at the 'Utkarsh Odisha: Make in Odisha Conclave 2025', it said.

Adani Group commits to invest ₹2.3 lakh cr over 5 yrs in state

THE Adani Group on Tuesday announced to invest a staggering ₹2.3 lakh crore over the next five years in Odisha, making it the biggest investment intent by any group in Utkarsh Odisha Conclave 2025.

Managing director of Adani Ports and SEZ Limited (APSEZ) Karan Adani met Chief Minister Mohan Charan Majhi and exchanged the MoU for the investment in the state.

"The investment spans across sectors like power, cement, industrial parks, aluminium and city gas expansion in Odisha," Adani told mediapersons immediately after the pact with the state government.

The company's plans include an aluminium refinery as well as smelter in the state. It had secured the Ballada bauxite mine in Koraput during auctions in 2023. The conglomerate would set up a renewable energy unit at Cuttack, cement plants in Malkangiri and Cuttack and develop the Dhamra

industrial park. This apart, expansion of both Dhamra and Gopalpur ports are in the offing. "It is a ballpark figure basing on the spectrum of investments," sources familiar with the development said.

Six projects of Adani Total Gas Limited (ATGL) were commissioned and launched on the first day of the mega investment summit. While a CNG station at JIO fuel station in Balasore has been commissioned, it will be open to public shortly after getting the approval from Petroleum and Explosives Safety Organisation (PESO). Similarly, another CNG station project at Rairangpur in Mayurbhanj district has been completed and will be open to the public soon.

The EV charging station at Bhubaneswar airport is a part of the company's plan to set up 250 EV charging stations in next three years on major highways, tourist places of the state to make it clean and green.

The city gate station at Chandbali is ready to gas charge and cater to city gas infrastructure in Bhadrak, Balasore and Mayurbhanj districts. It will help in piped gas supply to domestic customers as well as CNG to automotive vehicles.

ATGL has planned to establish LNG refilling stations at Angul, Jharsuguda and Chandikhol with investment of ₹100 crore.

The company, in a statement said, the first test flight also landed at Dhamra airstrip successfully on Tuesday. Adani is developing the airstrip at an investment of ₹500 crore. It will have a runway length of 3,200 metre when fully operational.

ODISHA on Tuesday presented an impressive business pitch to Indian and global investors attracting over ₹4.5 lakh crore investment intents on the Day-1 of Utkarsh Odisha: Make-in-Odisha Conclave 2025.

Chief Minister Mohan Majhi said Odisha is poised to become a major industrial hub of the country as it has received investment proposals three times more than its initial expectations. "Adani Group has announced to invest ₹2.3 lakh crore, which is the highest investment proposal received by the state so far. JSW will also set up a 5 MTPA steel plant in Keonjhar district with an investment of around ₹35,000 crore. An MoU has been signed in this regard," he said.

Similarly, Vedanta Group has signed an MoU to invest ₹1 lakh crore to set up a 6 MTPA aluminium refinery and 3 MTPA smelter plant along with an aluminium park in Rayagada district. Jindal Steel and Power (JSP) will invest ₹70,000 crore for the expansion of Angul steel plant. The state also received IT investments worth over ₹20,000 crore.

Tata Steel has committed ₹80,000 crore, while new pet-

rochemical, IT, renewable energy, and semiconductor industries are expected to take shape in Paradip and Gopalpur. While Avaada Group unveiled its plans to invest ₹20,000 crore at Gopalpur, Birla Group has confirmed plans for a copper foil plant in the state, Sharma informed.

Day 1 of the conclave, Odisha's flagship investment summit organised in collaboration with CII witnessed the presence of 30 industry captains, 28,000 individual registrations, over 200 exhibitors and participants from 18 countries at four plenary sessions and six sectorial sessions, including a CEO round-table.






