They had denied the allegations saying the short-seller was attacking the capital markets regulator's credibility and attempting a character assassination.

The Adani Group had also ter medtheallegations as malicious and manipulation of selective public information.

In its Wednesday order, the Lokpal "concluded that the allegations in the complaint (s) are more on presumptions and not supported by any verifiable material and do not attract the ingredients of the offences... so as to direct an in-

vestigation therefore".

Accordingly, these complaints are disposed of, said the order by a six-member bench headed by Lokpal chairperson Justice AM Khanwilkar.

Buch, who took over as the chief of the Sebi of March 2, 2022, demitted office on February 28, this year after the completion of her tenure.

Referring to an earlier order in this regard, the Lokpal said the Hindenburg report by itself cannot be made the sole basis to escalate action against Buch

Ombudsman says charges not supported by any verifiable material

Mumbai: The Lokpal on Wednesday disposed of complaints alleging impropriety and conflict of interest against former Sebi chairperson Madhabi Puri Buch based on a report by US-based short seller Hindenburg Research.

The anti-corruption ombudsman said the allegations against Buch are on "'presumptions and assumptions' and not supported by any verifiable material" to direct an investigation.

The six-member bench headed by Lokpal chairperson Justice AM Khanwilkar, while disposing of three complaints by different complainants including TMC MP Mahua Moitra, said the allegations are untenable, unsubstantiated and bordering on frivolity.

Allegations of conflict of interest and financial misconduct were levelled against Buch by Hindenburg Research and the Congress party.

Hindenburg alleged that Buch and her husband had investments in offshore funds controlled by Vinod Adani, the brother of Adani Group chairman

Gautam Adani, which were allegedly used for manipulating funds and inflating stock prices of the group's listed entities in India.

"In that, the named RPS

(Madhabi Puri Buch) had aiready redeemed the investments from the fund much before the investigations" into the allegation of manipulations of stocks against Adani Group of, companies had begun by Sebi; and it is evident from investigations by Sebi that the GDOF Cell 90, or IPE Plus Fund, in which the RPS and her husband had invested, had not made investments through EIFF and EMRF in any Adani Group shares," the order said.

"In any case the RPS (Buch) and her husband were not in control of the decision of the fund to make investments. They were only passive investors in the

fund, which they had already redee-

med in 2018," the order said.

The Congress party accused Buch of trading in listed securities, selling employee stock options from her previous employer ICICI Bank during her term at Sebi, and making money through her advisory firm that offered consultancy services

to listed companies, breaching the regulator's conflict of interest policy

okpal, the anti-corruption watchdog, has given a clean chit to former Securities and Exchange Board of India (Sebi) chairperson Madhabi Puri Buch and her husband, Dhaval Buch, in complaints that accused her of misconduct, impropriety and conflict of interest.

In a 116-page order, a sixmember bench led by Lokpal chairperson justice AM Khanwilkar said there was no need for a formal probe since the accusations were based on presumptions and assumptions and were not supported by any verifiable material.

The three complaints were filed after US-based Hindenburg Research levelled allegations that the Sebi chief and her husband had investments in offshore funds which are linked to the Adani group of companies; Sebi was probing the complaints against the conglomerate. Among the three, one was filed by a Trinamool Congress

member of parliament, Mahua Moi-Hindustan Times

Lokpal said the allegations were based on Hindenburg Research report that sought to expose the Adani group.

The Lokpal said it focused on five key allegations ranging from investment in a fund linked to Adani group and not disclosing the same; quid pro quo with companies such as Mahindra and Mahindra and Blackstone Inc in the garb of consultancy services by a company in which she had 99% ownership; quid pro quo from Wockhardt Ltd in the garb of rental income from a company, Carol Info Services Pvt, which was under investigation by Sebi for insider trading; gaining undue advantage by selling

ESOPs from ICICI Bank over five years between 2017 and 2024 at a time when ICICI had regulatory issues with Sebi; and making a pretence of recusal from matters of M&M Group and Blackstone Inc but influencing the other wholetime members and board of Sebi for a a favourable outcome.

"...we have concluded that the allegations in the complaint (s) are more on presumptions and assumptions and not supported by any verifiable material and do not attract the ingredients of the offences (under Prevention of

Corruption
Act), so as to
direct an
investiga-

tion," the Lokpal said.

"Accordingly, these complaints are disposed of," the order added.

Buch, who took over as Sebi chief on 2 March 2022, demitted office on 28 February this year after completing her term. Hindenburg accused her of a conflict of interest and favouring the Adani group. The Buchs and the Adani group had denied the allegations.

Lokpal said the Hindenburg "report by itself cannot be made the sole basis to escalate action against Buch."

The Hindenburg founder announced the closure of the company in January this year.

ANTI-CORRUPTION OMBUDS-MAN Lokpal on Wednesday dismissed complaints against former

Securities and Exchange Board of India (Sebi) chairperson Madhabi Puri Buch linked to the allegations levelled against her by forensic research firm Hindenburg.

The US short-seller, which shut shop in January, had claimed in an August 2024 report that Buch and her husband held stakes in offshore funds linked to Adani Group through complex investment structures.

The claims are "untenable, unsubstantiated, and bordering on frivolity", the Lokpal said.

The complaints were filed by Trinamool Congress MP Mahua Moitra and others on grounds of alleged impropriety and conflict of interest based on the research report.

The order issued noted that the claims were based on assumptions unsupported by verifiable evidence. It does not warrant an investigation under the Prevention of Corruption Act, it said.

Both Buch and her husband had denied the allegations. Lokpal had earlier sought oral hearings for Buch and her husband, which it clarified was procedural and not an expression of merit of complaints.

The Hindenburg report claimed that undisclosed interests could explain the Sebi's reluctance to investigate Adani firms. The US-based defunct researcher had earlier published a report on Adani Group in January 2023. It accused the group of stock manipulation and accounting fraud and called it the largest con in

corporate history. This triggered sharp losses in Adani firms. At the lowest, there was a \$150-billion dent.

The report surfaced just before Gautam Adani finalised a \$1.2-billion deal to acquire Haifa Seaport in Israel. Sebi had issued notices to the high-profile shortseller research outfit, accusing it of market manipulations. Hindenburg denied and claimed it as an attempt to silence critics.

BUCH WAS THE Sebi chairperson since March 2022 and was the first person to hold the position as a lateral hire. Tuhin Kanta Pandey was appointed the markets regulator's chief in February this year.

The Lokpal said the demand for corruption probe was solely politically motivated. Routine Sebi decisions have been recast as part of an alleged grand conspiracy involving the entire Sebi board and dozens of Sebi officers, it added.

The Lokpal has cleared Madhabi Puri Buch, former Chairperson of the Securities and Exchange Board of India, of all charges of corruption and wrongdoing levelled against her in connection with the Hindenburg Research case.

Dismissing the five allegations brought against her, the Lokpal said that the complainants had not been able to demonstrate even a basic prima facie case against her.

Terming the seeking of a corruption probe as "unjustified and solely politically motivated," the Lokpal, headed by Justice AM Khanwilkar, said that the complainants — including TMC MP Mahua Moitra and others — had approached it "with unclean hands and the complaints are liable to be dismissed on this ground alone".

The anti-corruption body, while dismissing the complaints, said, "It is submitted

Group. The complaints against her were that of financial misconduct and conflict of interest during her tenure at the regulator as a Wholetime Member and as the Chairperson. One of the allegations was that Buch and her husband invested substantial amounts in a fund linked to investments in the Adani Group of companies, under scrutiny by SEBI for stock price manipu-

lation, and that she failed to disclose them.

The second allegation pertained to a quid pro quo in the garb of consultancy fees by a company in which Buch had majority ownership, and through her husband from companies such as Mahindra & Mahindra and private equity firm Blackstone that had regulatory cases pending when she was the Wholetime Member or the Chairperson.

The complainants also alleged that though she made a pretence of recusal from the above matters, it did not prevent her from influencing SEBI members for a favourable outcome in cases pending and under investigation by the regulator.

Another allegation was that Buch had gained undue advantage by selling ESOPs from ICICI Bank during the years 2017 to 2024, when the bank had regulatory issues pending before SEBI and any adverse action would have influenced the market price of the ESOPs that had already been vested in 2013.

The Lokpal pointed out

several legal infirmities in the allegations, and also held some of them to be beyond the period of limitation and ineligible as a complaint.

NO VALID ALLEGATION

It said there was no valid allegation that the rental income or the consultancy payments were irregular or that Buch had influenced investigations. There was no valid allegation either that SEBI proceedings had produced favourable results for the entities concerned and in violation of the regulations and circulars.

In a scathing comment on the complainants, the Lokpal said, "Instead, through mischievous drafting — possibly out of fear of being found guilty of making false allegations — the complainant merely asks the questions whether the consultancy payments, rent payments or the appointment of the spouse in Blackstone constituted an undue advantage or quid pro quo, or were lawful income, and states that this needs to be investigated."

Complainants, including Trinamool lawmaker Mohua Moitra, had approached the Lokpal, alleging conflict of interest and quid pro quo by Buch during her tenure as a whole-time member and subsequently as Sebi chairman.

There were five main allegations, including the former regulator and her husband Dhaval Buch investing in a fund linked to investments in Adani group companies which were under scrutiny for stock price manipulation. Puri Buch was accused of not disclosing her investments.

Based on her response, the Lokpal concluded that she was not involved with the probe and she and her spouse had redeemed their investments before the investigations started. It also noted that Puri Buch and Dhaval were not in control of where the fund invested the money.

On allegations that Dhaval received money from M&M Group on the pretext of consultancy, Lokpal said he was a qualified professional who took up the assignment post-retirement and remuneration was much less than what he earned at Unilever. It also dismissed suggestions of Puri Buch influencing cases against M&M Group, pointing out that three cases were not related to the group.

The watchdog also dismissed charges of quid pro quo in the case of Blackstone, where Dhaval was engaged in a consulting role.

The Lokpal inquiry was limited to allegations of reciprocative arrangements with four companies: Mahindra & Mahindra; Blackstone Inc; Wockhardt and ICICI Bank apart from the Adani Group.

Three complaints were filed against Buch, including one by Trinamool Congress MP Mahua Moitra, alleging "quid pro quo arrangements which potentially threaten national interests".

the first woman chief of the market regulator, ended on February 28 under a cloud following allegations of wrongdoing.

On the allegation that Buch and her husband Dhaval Buch had invested substantial amounts in a fund linked to the Adani Group which was facing SEBI scrutiny, the Lokpal said the couple were only "passive investors" and in any case "earned annualised returns of approximately 3.9 per cent only on the amount invested in 2015, comparable to market benchmark Bond Index".

The order stated that the complainants "are indirectly doubting the correctness of the findings recorded in the investigations by SEBI which had already been unreservedly upheld" by the Supreme Court. The Lokpal was referring to the SC's decision in January dismissing a plea that questioned the legitimacy of the SEBI probe into the Adani Group.

The second allegation against Buch was that Agora Advisory Private Limited, a consultancy firm in which she had 99% ownership between 2016 and 2024, received a consultancy fee from Mahindra & Mahindra and Blackstone Inc which had issues pending with SEBI during that time.

The Lokpal agreed with Buch's submission that the case involving Mahindra & Mahindra was taken up a year before her husband took up the consultancy assignment and that the issue was dealt with by a "different whole time member".

Buch was also accused of guid pro quo arrangement with Wockhardt Limited in the garb of rental income from Carol Info Services Private Limited, a linked company that was being investigated by SEBI for insider trading. The Lokpal said that the rental agreements were drawn four years before a settlement application was filed by Wockhardt in 2019. "It is incredible to assume that the RPS (respondent public servant) had executed the rental agreement in anticipation of the application settlement Wockhardt," the order stated.

Buch was also accused of going "soft" on ICICI Bank since she was, during her tenure in SEBI, encashing ESOPS vested to her in 2013.

"We agree with the RPS that allegation by Complainants is an afterthought having realized that the other allegations would not stand the ground, being devoid of any merit. It is too much to assume that the stock options granted to an officer by the ICICI Bank up to 2011, can be used to allege quid pro quo attributable to him/her (RPS) years after superannuation in 2013 and connecting it to some remote settlement orders passed in 2019-2021," the order stated.

The Lokpal noted that Buch had submitted documentary evidence proving the investments were made in 2015, well before Sebi began its probe into the Adani Group in 2020. The complainants, the Lokpal said, failed to show benefit accrued to the Buchs from Adani Group.

Buch, assumed charge as Sebi chairperson on March 2, 2022, demitted office on February 28, 2025, upon completion of her term. Other allegations involved undue advantage through consultancy fees received by Buch's company AAPL and by her husband from entities like Mahindra & Mahindra Group and Blackstone Inc.— while regulatory matters involving these companies were pending before Sebi. The Lokpal dismissed these claims as "far-fetched," noting that Buch, at the time, was a whole-time member and not in a position to influence Sebi's collective decisions.

After a detailed inquiry, the Lokpal on Wednesday gave a clean chit to former Securities and Exchange Board of India (SEBI) chief Madhabi Puri Buch and disposed of the complaints on graft allegations against her based on the Hindenburg Research report.

The anti-corruption ombudsman, in a 116-page order, said the complainants had failed to even frame specific and valid allegations under the Prevention of Corruption Act.

"As such, there is no foundation whatsoever for establishing even a prima facie case of corruption against Madhabi.

This raises an important question of the real motivation behind filing such baseless complaints," read an excerpt from the order, accessed by *The Tribune*.

In January 2023, US shortseller Hindenburg published a report accusing the Adani Group of financial irregularities, leading to a significant

drop in the company's stock price. The group at the time had rubbished the claims and denied all accusations.

Terming the charges baseless, Madhabi and Dhaval said the short-seller was attacking the credibility of the capital markets regulator:

The Lokpal, in its order, noted that one of the complainants even went public on social media regarding the filing of her complaint, which was a "clear and deliberate violation" of the confidentiality requirements under the Lokpal Act. "It appears that the complaint was filed solely with the intention of generating media attention and not with the bona fide objective of pursuing legitimate grievance redressal," the order read, adding that the complainants approached the Lokpal with "unclean hands".

It further said in one of their recent submissions, one complainant appeared to be attempting to gain access to confidential SEBI investigation records concerning the Adani matter despite the fact that the SC had already closed the matter. The Lokpal said several allegations made by the complainants emerged as fabrications based on illegally obtained income tax returns of Madhabi, her husband and Agora Advisory.
