Ambuja Cement Net Falls 16% in Q4, Sales Rise 13%

Mumbai: Ambuja Cement's consolidated net profit fell 16% on year to ₹1,282 crore in the March quarter, even as sales volumes of the country's second-largest producer of cement rose 13% on year to 18.7 million tonnes.

Revenue for the quarter rose 11% on year to ₹9,889 crore, while earnings before interest, tax, depreciation and amortization (Ebitda) rose 10% on year to ₹1,868 crore. The Ebitda made on each tonne of cement, though, fell to ₹1,001 from ₹1,026 a year ago. Operating margins for the quarter fell by 20 basis points to 18.9% as compared to the previous year.



The company's bottomline was also impacted by a rise in the total expenses. While depreciation and amortization expenses rose more than 71% to ₹786.3 crore, the cost of raw materials consumed rose by nearly 23% on year to ₹1,578.1 crore.

An addition depreciation expense was recognised during the quarter on account of a re-evaluation of depreciation method by subsidiary, Sanghi Industries, Ambuja Cement said in its exchange filing.

For 2024-25, Ambuja Cement's consolidated profit rose 9% on year to an all-time high of ₹5,158 crore. While revenue for the year grew 6% on year to an all-time high of ₹35,045 crore, Ebitda was down 7% at ₹5,971 crore. Ambuja Cement is now the 9th largest producer in the world with a capacity of over a 100 million tonnes. —Our Bureau

Ambuja Cements' consolidated profit for Q4FY25 declined 8.98 per cent Y-o-Y to ₹956.3 crore despite a 13 per cent uptick in annual sales volume (cement and clinker). The profit numbers, however, beat the Bloomberg analysts' poll estimate of ₹735.4 crore.

The Adani family-owned company's Q4 sales volume grew to 18.7 million tonnes, the highest in one quarter in the firm's history. The share of premium cement products in the company's sales stood at 29.1 per cent, up 5.3 per cent Y-o-Y.

The company's revenue from operations for the quarter was up 11.6 per cent Y-o-Y to ₹9,802.5 crore. The revenue missed an earlier estimate of ₹9,903.2 crore. The company's total expenses for the quarter

icant step, bringing us closer to our goal of 140 mtpa by 2028."

Ambuja's operating earnings before interest, taxes, depreciation, and amortisation (Ebitda) in Q4FY25 stood at ₹1,868 crore, up 9.95 per cent Y-o-Y. Its Ebitda margin, however, declined marginally to 18.9 per cent in Q4FY25 from 19.1 per cent in Q4FY24. The Ebitda surpassed the Bloomberg estimate of ₹1,644.6 crore.

The company's revenue for FY25 stood at ₹33,697.7 crore, up 2.71 per cent Y-o-Y. Its profit during the same period increased 16.64 per cent to ₹4,167.43 crore. The company's sales volume during the financial year grew 10.14 per cent Y-o-Y, to 65.2 million tonnes.

"Higher volume, along with improved operational parameters, resulted in growth in all business parameters," the company stated.


ADANI GROUP'S CEMENT and building materials arm, Ambuja Cements, reported a 9% year-on-year decline in net profit attributable to owners for the fourth quarter of FY25, due to higher tax expenses.

Profit attributable to owners stood at ₹956.3 crore, compared to ₹1,050.6 crore in Q4FY24, though it exceeded Bloomberg's estimate of ₹735 crore. The company's consolidated net profit for the quarter came in at ₹1,282 crore, marking a 16% annual decline.

Revenue from operations for the March quarter rose 11.6% year-on-year to ₹9,802.5 crore, below Bloomberg's projection of ₹9,903 crore.

Ebitda rose 12% year-on-year to

₹1,781.4 crore, surpassing Street estimates of ₹1,645 crore. The Ebitda margin stood at 18.2%, while Ebitda per tonne was ₹1,001—a 2% decline from the

same period last year.

Due to the consolidation of Penna Cements' financials from August 2024, Ambuja Cements noted that the results for Q4 and the full year ending March 31, are not directly comparable with those from the previous year.

The company reported its highest-ever quarterly sales volume at 18.7 million tonne in Q4FY25. Sales volume was up 12.65% from the corresponding quarter in the previous fiscal.

For the full fiscal year, Ambuja Cements recorded revenue from operations of ₹33,677.7 crore and a net profit attributable to owners of ₹1,145.1 crore.

With the recent acquisition of Orient Cement, Ambuja's installed cement capacity has surpassed 100 million tonne per annum (mtpa) as of April 29.

Ambuja Cement, an Adani Group company, has reported that its net profit in March quarter was down 16 per cent at ₹1,282 crore against ₹1,521 crore logged in the same period last year on the back of lower realisations and higher tax outgo.

Revenue increased 12 per cent to ₹9,802 crore (₹8,785 crore). Sales volume was up 13 per cent at 18.7 million tonne (16.6 mt) in the quarter under review. While EBITDA was up ₹1,868 crore (₹1,699 crore), EBITDA per tonne was down 2 per cent to ₹1,001 (₹1,026).

Overall expenses were up at ₹8,822 crore (₹7,747 crore). Tax outgo also increased to ₹497 crore (₹74 crore) in the quarter. The

company's raw material cost was up 7 per cent at ₹696 (₹647) per tonne, while power and fuel cost jumped 2 per cent to ₹1,230 (₹1,202) a tonne and freight cost was down at ₹1,238 (₹1,258).

GREEN TARGET

The company has set a target to increase the green power mix from 26 per cent to 60 per cent by FY28. Out of the planned 1 GW renewable en-

ergy power with investment of ₹6,000 crore by FY28, 200-MW solar power and 99 MW of wind power at Khavda, Gujarat, was commissioned last fiscal. This will result in annualised cost saving and EBITDA improvement of ₹30 per tonne. The balance will be commissioned by next June.

Logistics costs was down 2 per cent at ₹1,238 a tonne with overall lead distance re-

duced by 16 km and direct dispatch up 4 percentage points to 58 per cent. The company targets to achieve a cost of ₹3,650 (₹3,795) per tonne by FY28 to boost EBITDA margins.

Vinod Bahety, Whole Time Director & CEO, Ambuja Cement, said the company has ongoing organic expansions at various stages, which will take capacity to 118 mtpa by FY26-end.

For FY25, the company's net profit was up 8 per cent at ₹5,158 crore (₹4,765 crore), while revenue increased 3 per cent to ₹33,698 crore (₹32,808 crore).

फैशन और लाइफस्टाइल रिटेलर ट्रेंट ने वित्त वर्ष 2024-25 की चौथी तिमाही (जनवरी-मार्च) में अपने समेकित शुद्ध लाभ में वित्त वर्ष 24 की समान अवधि की तुलना में 54.8 प्रतिशत की गिरावट देखी, जबकि इसमें इंड एस 116 के तहत पट्टा शर्तों से संबंधित अनुमानों के पुनर्मूल्यांकन पर 576 करोड़ रुपये का लाभ शामिल था। इंड एस 116 पट्टे के लिए भारतीय लेखा मानक है, जो एएस 19 की जगह लेता है। पिछले वर्ष की समान अवधि की तुलना में चौथी तिमाही के दौरान इसका परिचालनगत राजस्व 27.9 प्रतिशत बढ़कर 4,216.9 करोड़ रुपये हो गया और तिमाही के दौरान एकल आधार पर समान स्टोरों की वृद्धि एक अंक में मध्य स्तर पर रही। वित्त वर्ष 25 में समान स्टोरों के आधार पर वृद्धि दो अंकों में थी। ट्रेंट ने कहा कि उसके समेकित राजस्व में ट्रेंट हाइपरमार्केट कारोबार का राजस्व शामिल नहीं है। हालांकि दर्ज किए गए परिणामों में इस उद्यम के लाभ का आनुपातिक हिस्सा शामिल है और इसे इक्विटी पद्धति के आधार पर दर्ज किया गया है। तिमाही में समेकित आधार पर इसका शुद्ध लाभ 318.2 करोड़ रुपये रहा।

Ambuja Cements, part of the diversified Adani Group, has posted its highest-ever annual profit after tax (PAT) at Rs 5,158 crore, a 9 per cent increase year-on-year, while annual revenue surged to Rs 35,045 crore, up 6 per cent from the previous year. The company reported its strongest-ever financial and operational performance for the fiscal year ended March 31, 2025, marking a milestone as the company crossed 100 million tonnes per annum (MTPA) in cement production capacity. This achievement positions Ambuja as the ninth-largest cement producer in the world. The company also reported record cement volumes of 65.2 million tonnes, reflect-



ing a 10 per cent YoY growth. For the fourth quarter of Financial Year 2025 (Q4 FY25) alone, the company delivered an EBITDA of Rs 1,868 crore, a 10 per cent increase YoY, and the highest EBITDA per tonne at Rs 1,001, with margins improving to 18.9 per cent. Standalone PAT rose sharply by 75 per cent YoY to Rs 929 crore. Earnings per share (EPS) for the quarter stood at

Rs 3.88, and the company declared a dividend of Rs 2.0 per equity share. Ambuja's impressive performance was underpinned by its ongoing cost optimisation efforts, capacity expansion, and sustainability initiatives. The company successfully commissioned a 2.4 MTPA brownfield expansion at its Farakka Grinding Unit in West Bengal and completed the acquisition of Orient Cement, strengthening its pan-India footprint. Highlighting its green commitment, Ambuja commissioned 299 MW of renewable energy capacity (200 MW solar and 99 MW wind) in FY25. This is part of its roadmap to achieve 1,000 MW of green energy by June 2026, targeting 60 per cent green power usage by FY28.




