Mhada Partners Adani to Redevelop 142-acre Cluster Project in Goregaon

Mumbai: The Maharashtra Housing and Area Development Authority (Mhada) and Adani Properties, the real estate arm of the Adani Group, have entered into an agreement to redevelop Motilal Nagar, a 142-acre cluster in Mumbai's suburb of Goregaon (West), in the state housing body's largest-ever single redevelopment project.

As part of the redevelopment, eligible residents of the Mhada layout will get new homes with 1,600-square-foot built up area, the largest in Mhada's housing redevelopment history. Commercial unit holders will get 987 square feet space and eligible slum dwellers will receive 300 square feet homes, as per Slum Rehabilitation Authority's norms.

This marks Adani Group's second major redevelopment initiative in the country's financial capital, following the Dharavi redevelopment project spread over nearly 600 acres in the heart of the city.

NEW HOMES IN 7 YEARS



Adani has committed to hand over 3.97 lakh sq metres of housing stock. The rehabilitation is likely to be done in seven years

ET first reported on March 11 that Adani Properties secured the project by committing to hand over 3.97 lakh square metres of housing stock, the highest share of Floor Space Index (FSI), to MHADA. As per the tender terms, Mhada will retain full control over the project, including ownership of the land. The entire rehabilitation is expected to be completed within seven years.

Adani Properties, the selected Construction and Development

Agency (C&DA), will be responsible for financing and executing the entire redevelopment, including residential, commercial, and slum rehabilitation components as well as Mhada's own housing stock, within the stipulated time frame.

"We aim to make this the finest redevelopment project in the country, ensuring transparency, quality, and social commitment through Mhada's implementation... This dream of redevelopment will no longer remain on paper; it is becoming a reality," said MHADA's Vice President & CEO, Sanjeev Jaiswal.

The state government has declared this as a 'Special Project' and its comprehensive master plan has been developed by Netherlands-based Mecanoo, while the infrastructure planning was done by London-based Buro Happold. The primary objective of the redevelopment is to regularise rampant illegal construction and modernise Goregaon's housing infrastructure. In addition, the redevelopment will address longstanding civic issues like flooding and water-

logging, thereby significantly improving the quality of life for residents.

The developer is expected to bear the full cost of the project including relocation and rehabilitation of MHADA-eligible tenants, shops, and slum dwellers. The redevelopment will be executed in phases, and the C&DA cannot mortgage the land, raise funds on it, or transfer rights without MHADA's approval, ensuring protection against misuse.

Apart from sharing housing stock, the developer will be responsible for developing key physical and social infrastructure such as roads, water and sewage pipelines, storm water drainage systems, gardens, open spaces, hospitals, schools, markets, police stations etc. Motilal Nagar is one of the earliest MHADA colonies developed in the 1960s. The developer C&DA is expected to introduce modern construction technologies and urban planning expertise to rehabilitate 3,372 eligible residential units, 328 commercial units and around 1,600 eligible slum tenements, in line with the 1971 Slum Act.

Adani Properties, the real estate firm of Adani Group, on Monday signed an agreement with state agency Maharashtra Housing and Area Development Authority (Mhada) for the redevelopment of Motilal Nagar in suburban Mumbai's Goregaon (West).

Mhada has appointed the Adani Group firm as the construction and development agency for implementing the redevelopment of its Motilal Nagar 1, 2 and 3 colonies.

In March, Adani Properties emerged as the highest bidder for the ₹36,000-crore project that spans across 142 acres in the city, outbidding L&T Realty. The project will be Adani's second-largest redevelopment project after the mega Dharavi slum redevelopment project in Mumbai.

The Dharavi project is being developed by Navbharat Mega Developers Pvt. Ltd (NMDPL), a special purpose vehicle formed as a joint venture between the Maharashtra government and the Adani Group.

MHADA signs pact with Adani Realty Group after bid of Rs 36,000 crore

THE REDEVELOPMENT of Motilal Nagar colonies in Goregaon (West) has officially taken off with the Maharashtra Housing and Area Development Authority (MHADA) signing an agreement with the Adani Group.

The Adani Realty Group, which is involved in the Dharavi slum redevelopment project in Mumbai, had placed the highest bid of Rs 36,000 crore for the redevelopment of Motilal Nagar. The bids were opened in March this year. The Adani Group has been entrusted as the Construction and Development (C&D) agency to execute the project.

The MoU was signed on Monday at the MHADA headquarters in the presence of MHADA vice-president and CEO Sanjeev Jaiswal and director of

Adani Properties Pvt Ltd Pranav Adani. A presentation of the project plan was also delivered to MHADA officials during the event by the Adani Group.

"The long-cherished dream of the residents of Motilal Nagar is now taking a concrete shape. We aim to make this the finest redevelopment project in the country, ensuring transparency,

quality, and social commitment through MHADA's implementation," said Jaiswal.

The redevelopment includes Motilal Nagar 1, 2 and 3, which are located over around 142 acres. The scheme is going to rehabilitate about 3,700 tenements and is likely to be executed over a total area of 5,84,100 square metres. According to the agreement, the eligible dwellers will be rehabilitated in 1,600 sq ft flats. Apart from the dwelling units, nearly 987 sq m of commercial space will be provided for non-residential tenants.

As part of the project benefits, the developer will hand over 3,97,100 sq m of developed area to MHADA, adding to its housing stock. According to the officials, the rehabilitation is scheduled to be completed in seven years.

The State Government has notified the project as a Special Project and given MHADA per-

mission to implement it through a C&D model through their Mumbai Housing and Area Development Board. The Bombay High Court had also sanctioned the redevelopment under this model. In accordance with the direction of the court, Mumbai Board of MHADA called for bids and the Adani Group was chosen as the implementing agency.

The redevelopment scheme is being undertaken by the Mumbai Housing and Area Development Board. The planning is based on the concept of "15-minute city", with schools, hospitals, parks, public transport and offices to be within a walking distance from the residences. There will also be a five-acre central park as part of the master plan.

"Through this project, MHADA is taking a crucial step towards providing residents with modern, secure, and well equipped homes," Jaiswal said.

मुंबई, दि. ७ (प्रतिनिधी) - धारावीपाठोपाठ आता गोरेगाव पश्चिम येथील मोतीलाल नगर वसाहतीचा पुनर्विकास अदानी समूह करणार आहे. म्हाडा आणि कन्स्ट्रक्शन अँड डेव्हलपमेंट एजन्सी म्हणून नियुक्ती केलेल्या अदानी समूह यांच्यात सोमवारी मोतीलाल नगर पुनर्विकास प्रकल्पाच्या अंमलबजावणीसाठी करार करण्यात आला.

तब्बल १४२ एकर जागेवर मोतीलाल नगर १, २ व ३ ही म्हाडा वसाहत

आहे. मुंबई उच्च न्यायालयाने म्हाडाला कन्स्ट्रक्शन अँड डेव्हलपमेंट एजन्सीच्या माध्यमातून हा पुनर्विकास करायला परवानगी दिल्यानंतर मोतीलाल नगरच्या पुनर्विकासासाठी म्हाडाने निविदा मागवल्या होत्या. ही निविदा अदानी समूहाला मिळाली. या पुनर्विकास प्रकल्पातून म्हाडाला ३ लाख ९७ हजार १०० चौरस मीटर क्षेत्र विकासकाकडून बांधून मिळणार आहे.

रहिवासी २४०० चौरस फुटांच्या घरांवर ठाम

या वसाहतीत ३७०० गाळे असून पुनर्विकासात तेथील रहिवाशांना १६०० चौरस फुटांचे घर तर दुकानदारांना ९८७ चौरस मीटर चौरस फुटांचे दुकान दिले जाणार आहे. मात्र, आम्हाला २४०० चौरस फुटांचे घर आणि २१०० फुटांचे दुकान मिळावे, अशी स्थानिकांची मागणी आहे.

Following the redevelopment of Dharavi, the Adani Group will next redevelop Motilal Nagar in Goregaon West. Appointed by MHADA, Adani will construct 1.19 lakh sq m under the project. Residents will receive 430 sq ft homes, while shopkeepers get 90 sq m shops. Locals, however, are demanding larger homes and shop spaces.

मंत्री शंभूराज देसाई यांची माहिती; ३५ लाख घरांचे उद्दिष्ट; झोपडपट्ट्यांचे सर्वेक्षण अंतिम टप्प्यात

मुंबई : मुंबईतील गावठाण, कोळीवाडे आणि आदिवासी पाड्यांसाठी समावेशक गृहनिर्माण धोरण तयार केले आहे. यात ३५ लाख घरांचे उद्दिष्ट समोर ठेवण्यात आले आहे. तर, २२८ योजनांद्वारे झोपडपट्टी पुनर्वसन प्रकल्पांमध्ये २.५८ लाख घरे उभारली जात आहेत. धारावीसह केंद्र सरकारच्या जमिनीवरील झोपडपट्ट्यांचे सर्वेक्षण अंतिम टप्प्यात आहे, अशी माहिती पर्यटन मंत्री शंभूराज देसाई यांनी सोमवारी विधान परिषदेत दिली.

विधान परिषदेत सत्ताधारी पक्षाने नियम २६० अन्वये मांडलेल्या प्रस्तावाला उत्तर देताना ते बोलत होते. मुंबईतील कोळीवाड्यांच्या विकासासाठी हद्द निश्चितीचे काम अंतिम टप्प्यात आहे, असे सांगून मंत्री देसाई म्हणाले की, गिरणी कामगारांसाठीच्या योजनेतर्गत १३,१६१ घरांची लॉटरी पहिल्या टप्प्यात पार पडली आहे. आणखी ५८ हजार घरांची योजना अंतिम टप्प्यात आहे. तसेच, ठाण्यात ५२ हेक्टर जमीन राखीव ठेवण्यात आली आहे.

वरली बीडीडी चालू प्रकल्पातील ५५६ घरांचा ताबा लवकरच दिला जाणार आहे. धारावी पुनर्विकास प्रकल्पासाठी २५९ हेक्टर जमिनीवर काम सुरू असून, ६३ हेक्टर जमीन ताब्यात देण्यात आली आहे. बांद्रा पूर्व येथील शासकीय वसाहत पुनर्वसनाच्या समितीमध्ये स्थानिक आमदारांसह सुहास आडिवडेकर, किरण पावसकर, ईशान सिद्धिकी व महेश पारकर यांचा समावेश केला आहे. तसेच, प्रकल्प अर्धवट सोडणाऱ्या विकासांवर दंडात्मक कारवाई करण्यात येईल, असेही मंत्री देसाई म्हणाले.

मुंबईत ६४७ किमीपैकी ४५६ किमी मेट्रोचे काम पूर्ण झाले असून, १५३ किमी मार्ग कार्यान्वित झाले आहेत. छत्रपती शिवाजी महाराज आंतरराष्ट्रीय विमानतळ ते नवी मुंबई विमानतळ मार्गाचे कामही लवकरच सुरू करण्यात येणार आहे. चांदिवलीतील धोकादायक पोलिस इमारतीच्या पुनर्विकासातून ५८५ क्वार्टर्स उपलब्ध होणार आहेत, तर ५६पैकी २७ ठिकाणी पोलिसांसाठी ५,६५५ घरे उपलब्ध करून देण्यात आली आहेत, असे मंत्री देसाई यांनी सांगितले.

पीएमजीपी इमारतींच्या पुनर्विकासाबाबत बैठक

पीएमजीपी (पंतप्रधान गृह प्रकल्प) योजनेतील इमारतींच्या पुनर्विकासाबाबत येत्या एक महिन्याच्या आत बैठक आयोजित केली जाईल. या बैठकीत लोकप्रतिनिधी, समितीचे सदस्य आणि म्हाडाचे वरिष्ठ अधिकारी सहभागी करून घेतले जातील, अशी माहिती मंत्री शंभूराज देसाई यांनी विधानसभेत प्रश्नोत्तराच्या तासात दिली.

मुंबईतील उमरखाडी येथील जुन्या उपकरप्राप्त इमारतींच्या पुनर्विकासाबाबत भाजपच्या हरीश पिंपळे यांनी प्रश्न विचारला होता. या प्रश्नाला उत्तर देताना देसाई म्हणाले, उमरखाडी पुनर्वसन समितीच्या वतीने समूह पुनर्विकास प्रकल्पाबाबत प्रस्ताव सादर केला होता. मात्र, या प्रस्तावासोबत खासगी मालकांची आवश्यक संमती सादर करण्यात आली नव्हती. त्यामुळे खासगी मालकांच्या इमारतींचा समावेश समूह पुनर्विकास योजनेमध्ये करणे शक्य नसल्याचे मंडळाने त्यांना कळविले होते. त्यानंतरही उमरखाडी पुनर्वसन समितीने एकूण ८९ इमारतींच्या समावेशासह सुधारित प्रस्ताव ३ डिसेंबर २०२४ रोजी म्हाडा प्राधिकरणाकडे सादर केला आहे. या प्रस्तावाच्या अनुषंगाने प्रकल्पाची व्यवहार्यता पुन्हा एकदा तपासण्याचे काम सुरू करण्यात आले आहे.

'त्या' राखीव जागांचा ९० दिवसांत विकास

मुंबई विकास आराखड्यात दफनभूमी आणि स्मशानभूमीसाठी ज्या जागा राखीव आहेत त्यांचा शोध घेऊन ९० दिवसांचा कालबाधू कार्यक्रम राबवून त्यांचा विकास केला जाईल. यासाठी निधी कमी पडला तर निधीही दिला जाईल, असे आश्वासन प्रभारी नगरविकासमंत्री उदय सामंत यांनी विधानसभेत दिले.

विधानसभेत खिश्चन आणि मुस्लीम दफनभूमीसंदर्भात भाजप आमदार मनीषा चौधरी यांनी लक्षवेधी मांडणी होती. मुंबईत दफनभूमीतील मृतदेहांचे लवकर विघटन होत नाही. पुणे महापालिकेने दफनभूमीतील मृतदेहांचे लवकर विघटन होण्यासाठी विशेष पद्धतीची माती वापरली आहे, ती माती मुंबईतही वापरली जाणार का, असा सवाल मनीषा चौधरी यांनी विचारला.

मुंबई महापालिकेच्या नवीन विकास आराखड्यात दफनभूमीसाठी जागा राखीव ठेवण्यात आल्या आहेत. त्या जागांवर दफनभूमी सुरू कराव्यात अशी मागणी काँग्रेस आमदार अस्लम शेख, अमित देशमुख यांनी केली.

Mumbai's Housing Minister Shambhuraj Desai announced a housing policy targeting 5 lakh homes for Gauthan, Koliwade, and tribal villages. Slum surveys near completion; redevelopment in Dharavi and Worli ongoing. Metro and airport projects progressing. Cemetery land development and burial ground concerns addressed with assured funding support.

ધારાવીના અપાત્ર રહેવાસીઓ માટે મલાડના આક્સામાં બાંધકામ કરવા અરજી દાખલ કરાઈ

અમારા પ્રતિનિધિ તરફથી મુંબઈ, તા. ૬ : મહત્વાકાંક્ષી ધારાવી રિડેવલપમેન્ટ પ્રોજેક્ટ તરફના એક મહત્વપૂર્ણ પ્રક્રિયાગત પગલાંમાં મહારાષ્ટ્ર સરકાર અને અદાણી ગ્રુપની આગેવાની હેઠળના સ્પેશિયલ પર્પઝ વ્હીકલ-SPV દ્વારા, પ્રોજેક્ટનો અમલ કરતી કંપનીએ ધારાવીના અયોગ્ય ઝૂંપડપટ્ટીવાસીઓના પુનર્વસન માટે ફાળવવામાં આવેલા પ્લોટ પૈકીના એક - અક્સા-માલવણી જમીન માટે પર્યાવરણ, વન અને આબોહવા પરિવર્તન મંત્રાલય (MoEF&CC) સમક્ષ સંદર્ભ શરતો (TOR) અરજી દાખલ કરી છે. જોકે, જમીનનો ભૌતિક કબજો હજી સુધી મેળવવાનો બાકી છે. ૧૧ ઓક્ટોબર, ૨૦૨૪ના રોજ ૧૪૦ એકરની ફાળવણીની પુષ્ટિ કરતી ગેઝેટેડ સૂચનાના આધારે ToRફાઇલ કરવી, પર્યાવરણીય મંજૂરી મેળવવાની પ્રક્રિયા શરૂ કરવા માટેનું પ્રથમ ઔપચારિક પગલું છે. નિષ્ફાળો કહે છે કે, બધી જરૂરી ગ્રીન મંજૂરીઓ મેળવવામાં છથી સાત મહિનાનો સમય લાગી શકે છે. સંદર્ભની શરતો એ એક કરજિયાત પ્રક્રિયાગત દસ્તાવેજ છે જે પર્યાવરણીય અસર મૂલ્યાંકન (EIA) અભ્યાસની રૂપરેખા આપે છે. તેમાં પ્રસ્તાવિત બિલ્ડ-અપ વિસ્તાર, મકાન ગોઠવણી, ગ્રીન સ્પેસ અને પાર્કિંગ યોજનાઓ જેવી વિગતો સામેલ છે. ઝાણછાઈલ કરવાનો અર્થ જમીન ઉપયોગ અંતિમ પરવાનગી નથી, પરંતુ CRZ, નાગરિક ઉકુચન અને પર્યાવરણ વિભાગ સહિત અનેક એજન્સીઓ દ્વારા પર્યાવરણીય ચકાસણી શરૂ કરવી જરૂરી છે. આ પ્રક્રિયાને નજીકથી અનુસરતા એક નિષ્ફાળો સમજાવ્યું, "TOR એ પ્લોટની સંપૂર્ણ ક્ષમતાને અનલોક કરવા તરફનું પ્રથમ પગલું છે. તે પર્યાવરણીય અભ્યાસ માટે અવકાશની રૂપરેખા આપે છે, પરંતુ ડિઝાઇન અથવા જમીન ઉપયોગની મંજૂરી સૂચિત કરતું નથી. અંતિમ મંજૂરીઓ જારી કરવામાં આવે તે પહેલાં સંબંધિત એજન્સીઓ દ્વારા જમીનની ચકાસણી કરવામાં આવશે." ધારાવી પુનઃ વિકાસ બ્લુપ્રિન્ટના ભાગરૂપે, મહારાષ્ટ્ર સરકારે ૫૪૧.૨ એકર ફાળવી છે, જેમાંથી ૬૩.૫૧ એકર (લગભગ ૧૨ ટકા) પહેલાંથી જ રિડેવલમેન્ટ હેતુઓ માટે ધારાવી પુનઃ વિકાસ પ્રોજેક્ટ/SRA અને સોંપવામાં આવી છે. ધારાવીના સૂચિત વિસ્તારમાં જગ્યાની મર્યાદાઓને ધ્યાનમાં રાખીને, અક્સા-માલવણી જેવા ૩૦ કિ.મી. ત્રિજ્યામાં આવેલા જમીનના ટુકડાઓનો ઉપયોગ અયોગ્ય ઝૂંપડપટ્ટીવાસીઓને રહેવા માટે કરવામાં આવી રહ્યો છે.

The Maharashtra Government and Adani-led SPV filed a Terms of Reference (ToR) application for Dharavi Redevelopment's environmental clearance. Five acres were allocated in 2005, but land possession is pending. The ToR initiates environmental review but not final approval. About 1.5 acres are assigned for slum redevelopment within limited space.
