Mumbai: On Sunday afternoon, Mumbai Congress organised a protest in Kurla against the state's recent decision to formally approve transfer of 21.25 acres of Kurla dairy land to the Dharavi redevelopment project. Navbharat Mega Developers Pvt Ltd (NMDPL), a special purpose vehicle (SPV) set up by the state govt in a joint venture with the developer, Adani Realty, will implement the redevelopment project.

The protest was led by Congress MP Varsha Gaikwad, her sister and Dharavi MLA Jyoti Gaikwad, with several other party workers and citizens.

Speaking at the event, Varsha Gaikwad said: "While we were peacefully protesting, the govt has once again sent a large police force to suppress our voices and crush the movement using brute power. What kind of justice is this? Modani & Co. are snatching away people's rights, grabbing land that belongs to Mumbaikars, committing injustice - and instead of stopping them, the govt is shielding these land-grabbers while silencing citizens. But we will not be intimidated by this tyranny. We will continue to fight this Adani govt for Mumbai's rights and the future of Mumbaikars."

The MP said: "The land is worth hundreds of crores, but it was transferred to Adani at a nominal rate for his benefit. The BJP govt has become a facilitator of Adani's mega-loot."





Mumbai: In the early hours of dawn, as most of Mumbai still sleeps, the narrow lanes of Dharavi echo with the whistle of steamers and the clatter of aluminium vessels. In makeshift kitchens tucked inside shanties, women like Alaguthai Thangapandi are already deep into their day's work — grinding soaked rice, mixing batter, and steaming fluffy idlis that will feed hundreds across the city.

The supply chain is precise, personal, and proudly preservative-free. Most raw materials are sourced through trusted agents — Ponnirice arrives from Tamil Nadu in

bulk, and urad dal is bought from local wholesalers.

"We don't use shortcuts," says 26-year-old Prabhu, who assists his aunt Stella Nadar, 57, in their small home kitchen. "The batter is made fresh every night. We prepare at least 15 litres of batter daily, along with seven litres of

sambhar and two litres of coconut chutney."

Their idlis — four for ₹40 — reach breakfast counters in Slon, Matunga, Mahim, and Bandra. Stella, who runs her stall near Pila Bungla, says, "We are the city's breakfast makers, but we don't get any respect. Our kitchens are clean, but step outside and it's dirty, smelly, flooded in rains. How can we serve good food in such surroundings?"

As the Dharavi Redevelopment Project gains pace, the women are cautiously hopeful. "We want clear answers. Will we get better kitchens? Where will we go?" asks Thangapandi. "If they give us proper homes and space to cook, we can make 10 lakh id-

lis daily." Entrepreneur Ganesh Gajakosh says Dharavi's food makers are the backbone of informal Mumbai. "All they ask for is dignity, better roads, clean water — not charity. Let redevelopment not erase them, but empower them," says Gajakosh.

Yet the entrepreneurial spirit remains intact. Savita Muthuraman, a 22-year-old BBA student, helps her father carry steaming aluminium boxes across the city.

"If we had a proper kitchen, I wouldn't worry about my younger siblings having to do the same," she says. Most vendors earn between ₹1,000 and ₹3,000 a day. A few have scaled up into wholesale suppliers or caterers.

Mumbai party chief alleges BJP handed over Mother Dairy plot to tycoon at throwaway price for Dharavi project

THE Congress on Sunday staged a protest against the Maharashtra government's decision to allot Mother Dairy's land in Kurla for rehabilitating ineligible slum-dwellers who will be displaced by the Dharavi redevelopment project.

City Congress president Varsha Gaikwad, who led the demonstration, targeted the state government's decision with a "surrender" barb, alleging that the opposition by local people was ignored.

"The market value of this land is in the hundreds of crores, but it is being handed over to Adani at a nominal price," she alleged.

The Maharashtra Cabinet last gave its nod to the revised terms and conditions for an 8.5-hectare plot of Mother Dairy in Kurla area meant to be used for rehabilitating ineligible

slum-dwellers.

According to the government, under the Dharavi redevelopment project, 8.5 lakh families have to be rehabilitated. Of these families, 5 lakh are eligible to be rehabilitated in Dharavi itself. The Kurla plot is among the spaces that will be used to rehabilitate the remaining 3.5 lakh families, it said. "Adani seems to suffer from an

insatiable greed to grab all of Mumbai's land, and the BJP government is handing over plots to him while ignoring local opposition. The Kurla dairy land, despite being environmentally sensitive, has been transferred solely at Adani's request," Gaikwad alleged.

Despite massive public opposition, the state government granted the land to Adani in a cabinet decision.

"This is a surrender government," Gaikwad added.

She alleged that heavy police force was deployed to suppress the peaceful protest on Sunday.

"Modi-Adani & Co. are snatching away people's rights and occupying land that belongs to Mumbaikars, while the government provides security to the looters and suppresses

the people's voice," the Congress leader said.

She alleged that the government was using the Dharavi redevelopment project as a cover to hand over salt pan lands, Deonar, and Madh-Aksa land, totalling 541 acres, to Adani for free.

"Plans are also afoot to seize government land in Air India Colony, Bandra Reclamation, Behrampada, and Motilal Nagar without consulting the local population," the Congress MP alleged.

According to Gaikwad, Kurla residents had been demanding a botanical garden on the land of Mother Dairy covered by thousands of century-old trees.

Gaikwad wondered if Chief Minister Devendra Fadnavis is the spokesperson of the Election Commission.

She was responding to a query on a newspaper article written by Fadnavis rebutting Rahul Gandhi's claims on the fairness of the 2024 Maharashtra assembly elections.

"Why is Fadnavis answering the questions that Opposition Leader Rahul Gandhi posed to the Election Commission? Is he the commission's mouthpiece?" she asked.


