# Maharashtra's Budgetary Proposals can Bring about a Real Estate Boom

**Mumbai:** Maharashtra's significant FY26 budget allocations for affordable housing, infrastructure expansion, and urban development are expected to provide a strong impetus to the real estate sector in Mumbai – the country's most expensive property market.

Several key infrastructure projects announced in the budget, including the third airport to cater to the country's financial capital Mumbai, are expected to enhance real estate prospects in the state.

"The Maharashtra budget presents a robust framework that is poised to significantly accelerate economic growth through its strategic focus on mega multi-modal infrastructure projects. This visionary roadmap will undoubtedly enhance connectivity, stimulate commercial and industrial development, and further strengthen Mumbai's position as India's growth engine," said Niranjan Hiranandani-Chairman-Hiranandani Group.

With a focus on improving connectivity and easing housing shortages, the state government's initiatives are expected to drive demand in both residential and commercial markets across the state including key property markets of Mumbai, Pune, and Nashik.

A major highlight of the budget is

the ₹15,000 crore allocation for rural housing under Pradhan Mantri Awas Yojana (PMAY) Phase-2, targeting the construction of 2 million homes. Additionally, ₹8,100 crore has been set aside for urban housing under PMAY (Urban), to help achieve the stated objective of 'Housing for All.'

The substantial ₹64,000 crore investment in Mumbai's infrastructure, including road, metro, and transport network enhancements, will help decongest key corridors and open new growth nodes for residential and commercial development. The expansion of metro networks, with 41.2 km in Mumbai and 23.2 km in Pune and Nagpur, will improve intra-city mobility, strengthening demand in emerging real estate

corridors and making transit-oriented development more viable," said Gulam Zia, senior executive director, Knight Frank India. The ₹1,500 crore set aside for the Dharavi redevelopment project, according to him, underscores the government's commitment to inclusive housing and slum rehabilitation, critical for Mumbai's urban landscape.

According to Hiranandani, the emphasis on infrastructure investments will act as a multiplier, unlocking new opportunities across sectors while driving real estate demand. Enhanced connectivity and improved logistics corridors will catalyze commercial expansion, attracting investments and creating employment opportunities. The operationalisation of

Vadhvan Port in Palghar by 2030, along with a proposed third airport near the port and a Mumbai-Ahmedabad bullet train station, will improve regional connectivity and attract commercial and residential development.

The government has also announced plans to introduce a new housing policy, which could bring regulatory reforms and incentives to encourage private sector participation in affordable and mid-income housing projects.

According to industry experts, with effective implementation, this policy could ease project approvals and attract more investment into the sector. The budget also includes provisions for enhancing transparency in real estate transactions. The introduction of 'e-stamp certificates' under the Maharashtra Stamp Act is expected to simplify the process of paying stamp duty and issuing property documents online, reducing paperwork and improving efficiency.

With Maharashtra's economy projected to grow at 7.3% in 2024-25, higher than the national estimate of 6.5%, increased urbanization and rising disposable incomes are expected to further support the real estate sector.

With substantial investments in housing and infrastructure, along with digital reforms to improve ease of doing business, the budget sets the stage for long-term growth.



The Gautam Adani Group has secured the mega project for redevelopment of Motilal Nagar, spread over 143 acres in Goregaon (W).

Adani's bid of ₹36,000 crore was the highest and was accepted when the Maharashtra Housing & Area Development Authority (MHADA) opened the bids on Tuesday.

A MHADA official told FPJ that construction major Larsen & Toubro was the second-highest bidder. After winning the Dharavi redevelopment project, Adani has made yet another successful foray into the Mumbai real estate market.

"It is only a matter of time before Adani emerges as the biggest player in

Mumbai's real estate market," a city builder observed.

The Motilal Nagar project is expected to significantly impact the real estate market in the western suburbs, where several major developers are already active. Incidentally, India's biggest builder, DLF Pvt Ltd, is set to enter the Mumbai market later this month with a project in Andheri.

Motilal Nagar primarily consists of small, chawl-type houses spread across a vast area, largely occupied by the lower-middle class.

Adani Properties Pvt Ltd (APPL) emerged as the highest bidder, offering more built-up area than its closest rival, L&T, according to sources familiar with the matter.

As per the tender conditions, the selected C&DA must provide a housing stock of 3.83 million square meters. APPL won the bid by agreeing to hand over 3.97 million square meters to MHADA, whereas L&T quoted 2.6 million square meters.

MHADA retains full control over the project, including land ownership. It issued the redevelopment tender due to its financial and technical constraints in handling such an extensive project.

The private developer is prohibited from mortgaging the land, raising finance against it, or selling/transferring rights without MHADA's permission, according to the tender conditions. This ensures the protection of MHADA residents and slum dwellers while preventing misuse of redevelopment rights.

The selected C&DA will be responsible for the entire redevelopment process, including design, approvals, construction, infrastructure development, and rehabilitation.

The project aims to rehabilitate 3,372 residential units eligible under MHADA, 328 eligible commercial units, and 1,600 eligible slum tenements under the 1971 Slum Act.

Last week, a Bombay High Court division bench comprising Chief Justice Alok Aradhe and Justice Bharati Dangre upheld MHADA's decision to carry out redevelopment through a C&DA for integrated development of the entire layout.

The court noted that if individual cooperative societies managed redevelopment, they would prioritize their own interests and likely appoint developers for small-scale projects. This, the court

ruled, would hinder orderly planning and infrastructure development while exposing societies and residents to commercial risks from developers.

The court further emphasized that only holistic redevelopment can provide a long-term solution to the recurring problems of flooding and waterlogging faced by Motilal Nagar residents—issues that cannot be resolved through piecemeal redevelopment of separate land parcels.

After the Dharavi slum redevelopment project, billionaire Gautam Adani's group has emerged as the highest bidder for the Rs 36,000 crore redevelopment of Motilal Nagar in Mumbai, sources said.

Motilal Nagar I, II & III is one of Mumbai's biggest housing redevelopment projects, covering 143 acres in western suburb of Goregaon (W).

Adani Properties Pvt Ltd (APPL) emerged as the highest bidder, offering more built-up area than its nearest rival, L&T, sources aware of the matter said.

Letter of Allotment (LoA) will be issued in due course.

This will be the second mega redevelopment project of Adani Group in Mumbai. It is already redeveloping Dharavi, one of Asia's largest slums in Mumbai. Adani Group did not offer any comments on the story.

The Mumbai High Court last week gave the Maharashtra Housing and Area Development Authority (MHADA) a go-ahead to redevelop Motilal Nagar through a construction and development agency (C&DA). The State government has declared it as a 'special project', with the MHADA retaining control

over it but working through a C&DA in absence of the necessary potential to accomplish the work, based on economic viability and its capability. In Dharavi Redevelopment Project Pvt Ltd (now called Navbharat Mega Developers Pvt Ltd), Adani Group held an 80 per cent stake while the rest was with the State government.

Under the Dharavi project, Adani plans to turn 620 acres of prime land, about three-quarters of the size of New York's Central Park, into a glitzy urban hub. About 1 million people live in rickety shanties with open sewers and shared toilets in the densely populated slums, close to international airport. Eligible residents will be given flats of up to 350 square feet free of cost as part of the \$3 billion redevelopment of rubbish-strewn Mumbai slum of Dharavi into a 'world-class' district.

It will look to turn Motilal Nagar into modern apart-

ments. The total estimated redevelopment cost of Motilal Nagar is around Rs 36,000 crore, and the rehabilitation period is seven years from the project start/commencement date.

As per tender conditions for Motilal Nagar redevelopment, the C&DA must give a housing stock of 3.83 million square meters. The APPL won the bid by agreeing to hand over 3.97 million sq mt to the MHADA. The other qualified bidder, L&T quoted the figure of 2.6 million sq mt.

The MHADA retains full control over the project, including ownership of the land. It tendered for the redevelopment due to its own financial and technical limitations in handling such a large-scale redevelopment.

The project will rehabilitate 3,372 residential units eligible under the MHADA, 328 eligible commercial units and 1,600 eligible slum tenements as per the 1971 Slum Act. pn



**३** प्रकल्प पूर्ण करण्यासाठी ७ वर्षांचा अवधी निश्चित करण्यात आला आहे. निविदांच्या अटीनुसार 'सी ॲंड डीए'ला पुनर्विकासासाठी ३.८३ लाख चौरस मीटर निवासी क्षेत्र सोपविण्याची तरतूद आहे. तथापि, अदाणी समूहाने म्हाडास ३.१७ लाख चौरस मीटर क्षेत्र सोपविण्यास सहमती देऊन बोली जिंकली आहे.
