BMC floats ₹2.4k cr tender to clear 185L tons of waste at Deonar, reclaim 110 hectares

Mumbai: Four months after the state govt directed BMC to clear the Deonar landfill, the civic body Wednesday invited bids for bioremediation of 185 lakh ton of legacy waste and disposal of the material there. The contract is estimated to be for Rs 2,368 crore.

The project also includes reclamation of 110 hectares at the site, one of Mumbai's oldest solid waste dumping grounds. The contract period is set for three years.

Last Oct, the state cabinet had approved a proposal to hand over a portion of the ground for the Dharavi Redevelopment Project to rehabilitate Dharavi residents, particularly those deemed ineligible for free housing under existing criteria. The Dharavi project is being implemented by an SPV formed as a joint

venture between the state govt and the Adani Group.

While civic officials cited Swachh Bharat Mission for the Deonar clean-up contract, opposition alleged public money is being used to facilitate the Dharavi project.

BMC tender aims to clear Deonar dumpyard in 3 yrs

Mumbai: The contract to clear the Deonar dumping ground is among the largest tenders floated in recent years by BMC for solid waste management. It also comes at a time when BMC's liabilities are at an all-time high of Rs 2.32 lakh crore. The contract period is set for three years, which includes the time for mobilisation and the monsoon.

TOI was the first to report in Jan that in a letter sent to the BMC commissioner on Jan 24, the state, referring to the Swachh Bharat Mission Rules 2016, stated that it is the municipal corporation's duty to clear the land by scientifically treating the waste. The letter also stated that the request had been originally made by the Dharavi Redevelopment Project in communication dated Jan 3.

Officials said that a pre-bid meeting will be held later this month and by next month the contractor will be finalised. "We expect it to take four months for mobilisation. At some spots the waste dumped go up to 40 metres high and hence bioremediation will have to be done carefully," said an official. Alongside the landfill is the creek and so a waste spillover needs to be guarded against.

NOCs from several departments would be needed for the project, including CRZ and forest authorities. Deputy municipal commissioner in charge of the solid waste management department, Kiran Dighavkar, said that under the Swachh Bharat Mission the Centre has been pressing upon the clearing up of legacy waste. "This is a step in that direction," he said.

But former cabinet minister Aaditya Thackeray questioned the move. "The reason why @mybmc has imposed Adani Tax on Mumbai in the form of 'waste management fee'," said Thackeray referring to the BMC's recent move of planning to impose a user fee for collecting solid waste in Mumbai. ₹2,368-crore tender to clear Deonar landfill

Activists raise red flags over BMC tender's timing and financial implications as landfill will be used for Dharavi redevpt

Mumbai: The Brihanmumbai Municipal Corporation (BMC) on Wednesday issued a massive ₹2,368-crore tender for the remediation of legacy waste piled up to the equivalent of 12 storeys at the Deonar dumping ground, infamously referred to as Mount Garbage.

Touted as one of the largest tenders in recent years for solid waste management, the initiative aims to address decades of accumulated waste at one of the city's oldest dumping grounds.

The proposed project involves the bioremediation of 18.5 million tonnes of legacy waste and the disposal of excavated, processed, and segregated materials. According to the BMC, this will result in the reclamation of approximately 110 hectares (~272 acres) of land at the Deonar site.

The contract is set for a three-year period, inclusive of mobilisation and the monsoon season. Work is slated to begin upon the issuance of a letter of acceptance or a service order, whichever comes first.

The BMC's move assumes significance considering the Deonar dumping ground is slated to play a significant role in the redevelopment of Dharavi, one of Asia's largest slums.

In October 2024, the Maharashtra cabinet approved the transfer of 124 acres of the 311-acre Deonar landfill to the Adani Group-led Dharavi Redevelopment Project (DRP) for con-

structing rental homes for residents deemed ineligible for free housing within Dharavi. The decision sparked controversy due to environmental and health concerns, as the site remains an active landfill that emits toxic gases.

Activists and civil society groups have raised red flags about the BMC tender's timing and financial implications, despite the environmental promise of bioremediation. The Watchdog Foundation, an NGO, has openly criticised the move, citing concerns over the use of public funds to subsidise a private redevelopment project.

"While we acknowledge that bioremediation is an environmentally friendly process, we are perplexed by the timing and financial implications of this tender," said advocate Godfrey Pimenta of the Watchdog Foundation.

"If a significant portion of the Deonar dumping ground has already been allotted to a private entity, why is the BMC spending ₹2,368 crore of taxpayers' money on its bioremediation?"

he added.

The foundation has called for the immediate suspension of the tender, urging a comprehensive review of the project and an independent inquiry into the decision-making process.

"We believe that transparency and accountability are paramount, especially when significant public funds are involved," said Pimenta. "The citizens of Mumbai deserve clarity on how their money is being utilised, and whether such expenditures serve the public interest."

Kiran Dighavkar, deputy municipal commissioner (solid waste management), defended the BMC's move, saying there is a significant amount of legacy waste at the Mulund and Deonar dumping grounds that needs to be removed.

"Mulund alone has around 60 lakh tonnes of waste, while Deonar holds nearly 2 crore tonnes, piled up to the equivalent of 12 storeys and spread over 110 hectares. Regardless of the Dharavi Redevelopment Project, we are obligated to remove this legacy waste," said Dighavkar.

"Work at the Mulund dumping ground has been ongoing for six years, and we expect to reclaim nearly 60 acres of land there. Now, the focus has shifted to Deonar, where biomining operations are underway. In the meantime, the DRP has progressed, and the state government has requested that the land originally allotted to us in the 1930s be returned in its current condition. It is our responsibility to clean the site and hand it back, in line with the state government's directives," he added.

BMC to spend ₹2,368 cr to clear Deonar landfill, floats tender

THE BRIHANMUMBAI Municipal Corporation (BMC) Wednesday floated a tender of ₹2,368 crore for cleaning the waste piles from the Deonar landfill through bioremediation — process of treating garbage through natural elements such as air, sunlight and microorganisms. The move comes ahead of the state government's plans to relocate a section of Dharavi residents under its redevelopment project.

In October 2024, the state government allocated a 124 acres of the 311-acre Deonar landfill for constructing housing tenements for the Dharavi Redevelopment Project (DRP). In its tender, the civic officials mentioned that 110 hectares, or 271 acres, of the land

will be cleaned by them.

"The landfill will be cleared because the Union ministry has mandated the removal of legacy waste from all existing waste dumpsites in India. Alongside the part of the landfill that has been demarcated for the DRP, several other areas of the land parcel will also be cleared. This includes the portion of land parcel where a waste-to-energy (WTE) and a bio-CNG plant are coming up," Kiran Dighavkar, deputy municipal commissioner, Solid Waste Management (SWM), told *The Indian Express* Wednesday.

The entire 311 acres of land was handed over to the BMC in the early 20th century by the state government for waste management, and the 124-acre portion was handed back by the civic authorities to the state gov-

ernment in September 2024.

On April 11, *The Indian Express* reported how the government's move of relocating residents to the Deonar landfill plot as part of DRP flies in the face of established environmental norms. A Central Pollution Control Board (CPCB) report said around 6,200 kg of methane is generated from the landfill every hour, making Deonar one of the top 22 methane hotspots in the country.

The CPCB rules also mandate that a minimum 500-metre distance should be maintained between WTE plants and residential zones. The rules also state a 100-metre no-development zone needs to be maintained from the boundary of a landfill.

"The overall period that the tender covers is 36 months, of which 12 months will be monsoon..." Dighavkar said.
