Locals halt land survey for Dharavi redevpt project

Mumbai: Residents of Madh-Marve and Malvani came out in large numbers and stopped officials of Mumbai suburban district collector's office from carrying out a survey of the land for the Dharavi Redevelopment Project.

This is the second time that the collector's office tried to do the survey. A previous attempt before assembly polls was also foiled by locals who are determined not to allow relocation of Dharavi residents to Madh.

On Thursday, revenue officials arrived early morning, but residents gathered in large numbers and did not allow surveyors to enter the land. They came with placards and shouted slogans. By late morning, officials left the spot, but locals stayed put till late evening.

They were joined in the protests by local Congress MLA Aslam Shaikh who had participated in the protests earlier too.

Gregory Gracias, a local, said: "There is not enough infrastructure for existing

residents. Relocation of lakhs of people will completely ruin this place. There is huge congestion at Malad railway station, traffic jams at Mith Chowki are a daily occurrence. It takes an hour at times to reach from the railway station," said Gracias.

Another resident, Aditi Chakraborty, who joined the protest said Dharavi residents must be resettled in Dharavi. "Horizontal slums will be replaced with buildings. There is enough land to accommodate all residents in Dharavi. Malad can't take more people given the poor

infrastructure," she said.

Last October, the Eknath Shinde govt approved transfer of 140 acres of revenue land at Aksa and Malvani village for the Dharavi Redevelopment Project. The govt announced that only those eligible for free housing and those who resided in Dharavi up to 2011 will be eligible for housing in Dharavi. The rest will be moved elsewhere in the city and even in Mumbai metro region, where they will be provided rental housing. The project is being executed by Adani Realty. The govt set up a special purpose vehicle in which it has a 20% equity and Adani Realty 80%.

Panel for scientific closure of Deonar dumpyard land

Mumbai: In its latest meeting, the high court-appointed committee to monitor and improve conditions at the Deonar dumping ground urged the BMC to seek state guidance on the scientific closure of a portion of land to be transferred for the Dharavi Redevelopment Project.

The land, spanning 124 acres of the 311-acre Deonar dumping ground, was approved for transfer in Oct by the cabinet. This is to be handed over to the Dharavi Redevelopment Project Pvt Ltd (DRPPL), a joint venture between the Adani Group and the state govt.

With nearly 100 years of legacy waste still present at the dump, the committee raised concerns about how this will be managed. It specifically sought clarity on the plans and measures for its scientific clo-

sure. A BMC official said the Deonar dump currently has close to two crore tonnes of legacy waste in it, and the height of the waste goes up to 40 metres.

The BMC said that the land was given without any conditions like scientific closure of the land.

"The committee has hence sought that the BMC write to the state to understand the scientific closure of the dump. Further, they have also said that the high court should be informed about the same. The same will be done shortly," said an official.

Rajkumar Sharma, from the Chembur-based advanced locality management and networking action committee (ALMANAC) and also a member of the court-appointed committee, said, "The scientific closure of the land in possession of the BMC can also begin considering that as

compared to earlier years where a large quantum of waste would be dumped, now a minimum of 500-1,000 metric tons gets dumped daily. The land where dumping is not taking place can begin to be scientifically closed so that the gases being released, the dust flying can reduce."

The city generates 6,500 tonnes of waste daily, which is taken largely to Kanjur-marg while a small amount is sent to Deonar.

Of this, 72.6% is food waste (organic wet waste), while the rest is stones, sand, fine earth, paper, wood, plastic, and such.

Legacy waste is that which accumulates when uncontrolled and unregulated dumping of waste continues for decades on a barren piece of land called landfill, mostly on the outskirts, which now has become part of a city due to urbanisation.

Land survey for Dharavi rehab blocked again

MUMBAI: On Thursday, Aksa village in Malad saw a determined face-off between locals and city survey officials (CSO) from the collector's office who had come to survey a plot for the rehabilitation of residents from the Gautam Adani-led Dharavi Redevelopment Project.

Having stalled one attempt like this, the locals were all set to ensure that the second one too met with failure. However, the officials gave them the slip by arriving three hours earlier in a police van.

"Villagers were waiting at the ground's entrance from 9 am to prevent the officials' entry, only to find out they had already entered and were beginning the survey," said Kiran Koli, general secretary of the Maharashtra Machhimar Kruti Samiti. "As soon as this came to light, around 3,000 more people left their homes to come and stop them."

Rajendra Kshirsagar, district collector of Mumbai Suburban,

however, claimed that the survey was completed before the protestors could stop it.

The throng of people carried placards, declaring they were 'bhoomiputra' or sons of the soil in opposition to 'Adani' after their lands. The barricades erected away from the entrance ensured that they could not enter but their loud slogans nev-

ertheless made the officials back off, said Dhanaji Koli, a prominent member of the fishermen's society. "The police took them out via another exit to Malvani police station," he said. "We followed."

The protestors—a mix of Kolis (fishermen), Bhandaris (farming communities), East Indians, Adivasis, and other res-

idents of Aksa, Madh, Kharodi and Malvani villages—only calmed down when the CSO officials agreed to give them a letter saying the land had not been measured. The previous owners of the land, the Shri Mukteshwar Vividh Karyakari Seva Sahakari Society, were also present, along with farmers who have land adjoining the plot.

The crowd reached Malvani police station by 12 noon. There, the CSO officials assured them that they had stopped the survey, noted down the residents' objections and said they would relay them to the revenue department.

The protests have been on ever since the announcement in October that 140 acres at Aksa and Madh had been allotted to resettle ineligible residents of the Dharavi Redevelopment Project. A previous attempt at a survey was blocked in November 2024.

The protestors' objections are on two counts: the land is in use by them for their livelihood, and an influx in population will add to the already present strain on

civic resources. "We use part of this land to dry our fish," said Dhanaji. The rest—a large open plot filled with greenery and plants—was given to the Shri Mukteshwar Sanstha in the 1950-60s by the Maharashtra government for farming, and taken back two years ago.

"The Bombay high court has ordered the revenue department to complete hearings for the land within four months and only then start the survey," continued Dhanaji. "But the CSO office nevertheless started it. We need to be part of this decision to give away our land and want the government to hold proper talks with us about our concerns before going ahead with anything."

Kiran said that their areas were already plagued by a water shortage. "Besides, the roads are bad and inadequate, causing a lot of traffic," he said. "An additional 800,000 people will add to our burden. We have lived here for generations and need this space for ourselves. Instead, it is being given to outsiders."

Adani declined to comment on the protest.

Locals stop land survey in Malad for Dharavi rehabilitation

Residents raise high court order violations, demand consultation before taking any decisions

THE residents of Malad staged a protest against the City Survey Department when officials arrived in Aksa Village to conduct a land survey as part of the Dharavi Redevelopment Project. The survey was intended to identify land for rehabilitating Dharavi residents, but it was eventually called off due to strong resistance from locals.

According to a high court order, issued in response to a writ petition filed by the locals, the City Survey Department was required to consult the residents before beginning any survey. However, locals alleged that the officials failed to follow this directive and arrived without prior notice or formal communication.

Ajit Thakur, secretary of Mukteshwar Society said, "Why is it that the high court orders are blatantly disregarded by them? The court has specifically said that we should be consulted before taking any decision or action in regard to the land." Thakur also presented a copy of the court order to this reporter.

cerns about the redevelopment project, saying, "The redevelopment project directly impacts our homes and livelihoods. We are very clear that we do not want Dharavi in Malad."

The survey officials, accompanied by local police, arrived at the site around 7.45 am on Thursday. Residents quickly gathered to protest the unannounced survey. The area was heavily barricaded, with a significant police presence, including riot police equipped with tear gas and a rapid intervention vehicle. Amid the growing unrest, the officials were escorted away, and the survey was called off.

Local MLA Aslam Sheikh also visited the protest site. He urged the

survey officials to stop the survey and delete any data they had collected. Later, a delegation of seven representatives from Aksa Village and neighbouring koliwadās met with survey officials at the Malwani police station and subsequently with the Mumbai Suburban District Collector.

Rajendra Kshirsagar, the Mumbai Suburban District Collector, said, "The delegation met me in my office, and I listened to their concerns. I also informed them about the options available to them and explained that the decision regarding this matter will not be made at my level."

The villagers blocked roads and demanded the cancellation of the survey, citing a court dispute. The protest ended after surveyors agreed to provide a written statement.

Aksa village residents protested against the Dharavi rehabilitation project, opposing the transfer of 195 acres of agricultural land to a builder. They claimed 350 people have lived there for 34 generations, using the land for agriculture. Locals rejected the decision, fearing it would harm their future livelihoods.

धारावी पुनर्वसन प्रकल्पातील अपात्र रहिवाशांचे पुनर्वसन आक्सा येथे करण्याचे राज्य शासनाने ठरवले आहे, मात्र येथे विद्यमान विद्वया राहत असलेल्या स्थानिकांवर त्याचा काय परिणाम होईल, याबाबत शासनाने विचार केलेला नाही. या पुनर्वसनामुळे येथील पायाभूत सोई सुविधांवरही मोठा ताण निर्माण होईल. याठिकाणी पिढ्यान्पिढ्या मच्छिमार, कोळी राहतात. शासनाने १९८३ साली शासन निर्णय काढला होता. यामध्ये जे कोळीवाडे आहेत ते राखीव ठेवायचे असल्याचे नमूद केले आहे, मात्र तरीही येथील दाणादाणी विभागातील जमीन पर्यटन आणि

They objected to the survey being conducted without their knowledge and demanded a written assurance that the land was not measured, citing legal disputes.
