Mumbai: A 2023 drone survey by Navbharat Mega Developers Pvt Ltd (NMDPL) will serve as the benchmark to demolish new structures that have cropped up in the Dharavi Notified Area (DNA), said Dharavi Redevelopment Project CEO and chairman of NMDPL S V R Srinivas. So anything that has come up after that survey will be razed.

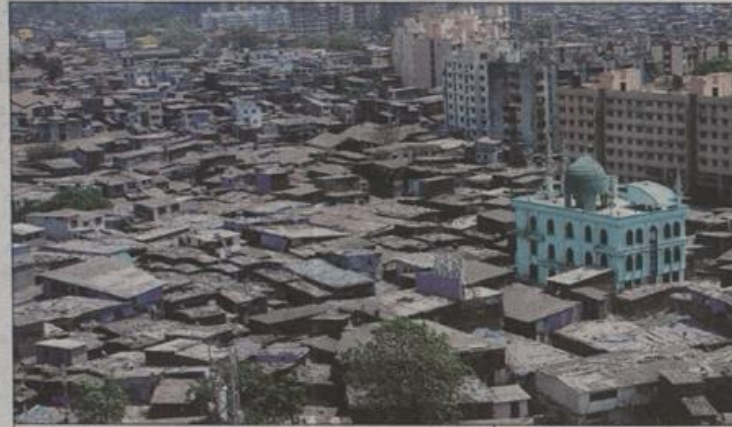
The NMDPL, the special purpose vehicle set up for the redevelopment of Dharavi, had in Nov last year submitted the Dharavi Development Plan for the 251-hectare Dharavi Notified Area (DNA) to the Maharashtra govt for its consideration. Sources said so far, the govt has not recommended any changes to the plan. It is, however, not known when the state govt will publicise the plan and invite objections and suggestions.

According to sources, while construction of the rehabilitation tenements for those who are eligible for free housing will happen on the 47 acres of railway land that is available for the project, illegal construction continues unabated in the Dharavi Notified Area.

In a press release issued on Tuesday, the Dharavi Redevelopment Project/Slum Rehabilitation Authority or DRP/SRA, which is part of the NMDPL, said that the illegal construction is being promoted by residents and the local land mafia. It further said that in 2019, the BMC had undertaken a massive demolition drive in Dharavi. "The then assistant municipal commissioner Kiran Dighekar had said that unauthorised construction was a recurring problem and the BMC would identify the perpetrators as mafia and action would be taken against them under the Maharashtra Prevention of Dangerous Activities (MPDA) Act."

Who gets what in DRP

Under the provisions of the current tender for Dharavi's redevelopment:

- Ground-floor residents who settled in Dharavi before Jan 1, 2000 will receive 350 sq ft homes within Dharavi, free of cost.
- Ground-floor residents, who settled between Jan 1, 2000 and Jan 1, 2011, will receive 300 sq ft houses outside Dharavi, at a nominal cost of ₹2.5 lakh under the Pradhan Mantri Awas Yojana (PMAY).
- All upper-floor structures up to Nov 15, 2022 and ground-floor tenements constructed between Jan 1, 2011 and Nov 15, 2022, will be offered rented accommodation with an option of hire-purchase outside Dharavi. They will be entitled to houses of 300 sq ft.
- All new townships for ineligible Dharavikars will be built within the Mumbai Metropolitan Region.

MUMBAI: For nine months last year, the 600 acres of Dharavi were mapped and surveyed using drones. The images from these drone surveys will now be used as proof to eliminate "illegal" structures, and Dharavikars in the latter will not qualify for redevelopment benefits. This is the first time that the authorities are making it clear who qualifies as illegal and stands to lose everything after the ongoing physical door-to-door survey is complete.

On Tuesday, the Adani Group-led Navbharat Mega Developers Private Limited (NMDPL), which has been awarded the project to redevelop one of Asia's largest slums, declared this on behalf of the Dharavi Redevelopment Project (DRP). According to officials, the drone survey, which was okayed in December 2023 at a cost of ₹22 crore, will serve as a

benchmark to identify existing tenements and vacant land within the Dharavi Notified Area (DNA).

"Coordinated action will be taken by the DRP and the BMC," said SVR Srinivas, CEO of the DRP. "If needed, the DRP will consider seriously the possibility of debaring such tenements from the rehabilitation package."

The authorities said that the drone images would be used to put illegal structures, namely new structures or extensions, under scrutiny. Any new structures or extensions built after this survey will be flagged as illegal and may not qualify for redevelopment benefits. "These illegal set-ups include any new upper floors, retrofitted tenements and new constructions on any vacant land in the DNA done to secure homes under the DRP," said an official close to the project.

The eligibility survey in Dhar-

avi is currently underway, and the exact number of illegal structures will be determined by the DRP once the survey is completed. The officials from NMDPL said that they had no role in determining the outcome of the survey, as it was purely a government initiative. Recently, 85,000 tenements were numbered and over 50,000 were surveyed in a door-to-door exercise.

The DRP authorities claimed that "real Dharavikars" were eager to get on with the redevelopment, were "rooting for progress" and were glad that the work had finally begun. Residents, on the other hand, are claiming that over the past few days, people from outside Dharavi have been coming and supporting the project, while Dharavikars were opposing it. In 2019, the BMC had undertaken a massive demolition drive in Dharavi. In December 2023, it wrote to the Collector's office, requesting action against encroachments.

अनधिकृत बांधकामांना पुनर्वसनाचे लाभ नाहीत

डिसेंबर २०२३ मध्ये, मुंबई महानगरपालिकेने जिल्हाधिकारी कार्यालयाला अशा अतिक्रमणांविरोधात कारवाई करण्याची विनंती केली होती. त्यावेळी नोटिशी देखील संबंधितांना जारी करण्यात आल्या होत्या. पण फक्त काही अतिक्रमणेच पाडण्यात आली होती. कारण, ही अतिक्रमणे पाडणे हे आव्हानात्मक कार्य असल्याचे तेव्हा स्पष्ट झाले होते. मात्र, खरे धारावीकर पुनर्विकासासाठी उत्सुक असून प्रगतीसाठी होणाऱ्या या कामात पाठिंब्या देत आहेत. सध्या धारावीमध्ये हे पुनर्विकासाचे कार्य सुरू झाल्याने एकप्रकारे अनियंत्रित कारामा आळाच बसतो आहे. मात्र, पुनर्विकासाला साथ देणाऱ्या धारावीकरांना भीती आहे की, हे पुनर्विकासाचे काम सुरू न झाल्यास धारावी आणखी अनियंत्रित होईल. तसेच तिथल्या सार्वजनिक आरोग्य आणि पायाभूत सुविधा आणखी दयनीय होतील.

Unauthorized construction in Dharavi hampers redevelopment efforts, according to DRP officials. Despite a drone survey identifying illegal structures, action has been slow. The Mumbai Municipal Corporation, alongside DRP, is committed to halting illegal construction and exploring rehabilitation benefits. Dharavikars support redevelopment to avoid further deterioration.

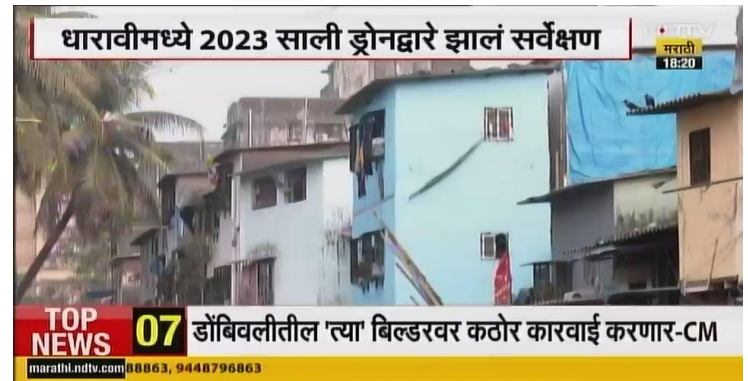
