# 'We are not against Dharavi residents'

Locals in suburbs protesting against relocation of project-affected people say it's 'unfair planning' they are opposed to

WHY exactly is there opposition to the rehabilitation of project-affected persons (PAPs) from Dharavi in other neighbourhoods? Is it rooted in social stigma, with residents of areas like Mulund, Malad and Kurla hesitant about integrating people from Dharavi due to perceptions of slum life? Or are the concerns tied to the planning and execution of the rehabilitation process?

#### Background

In 2022, as part of the Dharavi cluster redevelopment pro-ject, Gautam Adani-led Adani Realty won the tender for the 259-hectare, ₹20,000-crore project to transform the hub into a "world-class township." A special purpose vehicle (SPV), Dharavi Redevelopment Project Pvt Ltd (DRPPL), was formed in collaboration with the state government's Dharavi Redevelopment Project Authority under the Slum Re-habilitation Authority (SRA).

As the project began, several issues arose. Structures built af-ter 2000 were deemed ineligible for rehabilitation. Many feared losing their ecosystem or being uprooted, while those eligible welcomed the change. Those declared ineligible are being shifted to areas such as Kurla, Mulund, Deonar and Malad, as well as 255.9 acres of ecological well as 255.9 acres of ecological-ly fragile salt pan land. This has led to citywide protests—not against the people of Dharavi, but over displacement, envi-ronmental hazards and potential additional strain on civic infrastructure elsewhere.

#### Kurla residents' misgivings

In Kurla, the contention is over a 10.4-hectare piece of land previously used by a government-run milk dairy at Nehru Nagar. The land, strategically located along the Santacruz-Chembur Link Road, LTT Kurla Terminus ai Metro Yellow Line 2B, and the Harbour Line, was lying

unused for nearly a decade. Initially earmarked by the MMRDA for infrastructure financing, the land was later designated for rehabilitating Dharavi slum dwellers. A Government Resolution (GR) issued on June 10, emphasised



the public importance of the project, offering the land at a 25 per cent discount below the ready-reckoner rate.

mid-day has been reporting since February about the issue. Residents launched a citizen movement called 'Lok Chalwal to reserve the plot for a garden and recreation ground, citing the need for greenery and open spaces in Kurla.

We don't have an issue with Dharavi residents. In fact, they don't want to move here; they prefer in-situ rehabilitation. Our fight is to save the green plot," said Kiran Pailwan, who is leading the protest. "There are 800–900 trees on the land. If this project proceeds, we'll lose the green cover and face a 25–30 per cent rise in popu-lation," he added. Dharavi MLA Jyoti Gaikwad

#### Mulund protests

In Mulund East, several rehabilitation projects are stirring opposition. One involves allo-cating 64 acres of land near the old Octroi Naka, 46 acres at an old dumping ground, and 7,439 tenements near Kelkar College for PAPs across Mumbai. "We are not against Dharavi residents, but Mulund's civic in-

frastructure cannot bear such a load," said Sagar Devre, conven-or of the protest. When we raised the issue

cused of politicising the issue So we sat quietly. But now that the elections are over, should we talk about the issue? The PAP project is being complet-ed before our eyes. Our elected representatives have failed us. They are lying blatantly. On Oc-tober 4, 2024, the government issued a GR. It confirmed that this Dharavi rehabilitation will take place on the sites of our salt pans in Mulund, Bhandup and Vikhroli. This GR is available the government website. just have one simple question

for our lying elected represent-atives. Has the GR of 4 October 2024 been cancelled?" Devre questioned. Resident activist Chetan Bordawekar added, "Mulund East, with 1.5 lakh residents, is already struggling with crum-bling infrastructure. Adding 3.5 lakh more people will collapse

it entirely." "Additional load of PAPs will choke our utility lines and will add to the load on public trans-port. We are struggling to understand why so much land is required outside of Dharavi to rehabilitate its residents. Both Dharavi residents and Mulund East residents are opposed to the relocation," Bharat Soni, secretary, Hillside Residents' Welfare Association (HIRWA) said

#### Malad 'fight'

In Malad, fisherfolk and locals from Aksa and Bhati villages are resisting the relocation of Dharavi residents to their lands. A November 7 survey by state officials was met with strong opposition, requiring police intervention Local MLA Aslam Shaikh said, "This move dis-rupts the fabric of both Malad and Dharavi. Dharavi residents

should be resettled where they belong." "I stand with my com-munity and have been strongly opposing any project that un-dermines their rights. I chal-lenge BJP leader Ashish Shelar to allow Dharavi residents to

settle in Bandra," Shaikh added. The area has been traditionally populated by the fishermen's community with local groups such as Bhati Fishermen Sarvodaya Society, Aadivasi Ekata Samajik Sanstha, and Madh Fishermen Society officially writing to the government expressing their reservations.

"The fight is not against Dharavi or slums, but the shifting of outside residents in such large numbers will strain the existing infrastructure and even destabilise the locals who have been living here for ages," a local fisherman said.

#### **Deonar situation**

The Deonar dumping ground spanning 124.3 acres, is also earmarked for housing eligible and ineligible Dharavi resi-dents. The land will be given to eligible and ineligible residents of Dharavi at a possession rate of 25 per cent of the prevailing market rate. However, this area contains nearly 80 lakh metric tonnes of waste, making up nearly 40 per cent of the total waste, requiring at least six to seven years and ₹1,000 crore for clearance.

Residents and politicians ar-gue against the relocation. Con-gress MP Varsha Gaikwad said, "It's unethical to shift people to hazardous areas. Dharavi re-idents should stay in Dharavi."

A local resident summarised the issue: "Deonar residents want to leave due to toxic air and health hazards. Adding more people here is inhumane."

# Courts 2024: Amended IT rules on fake news quashed; Dharavi project relief for Adani group

In another significant judgement this year, the HC upheld a tender awarded to Adani Properties Private Limited by the Maharashtra government for the crucial project of Dharavi slum redevelopment in Mumbai.

Also significant was the HC's Nagpur bench order in March acquitting former Delhi University professor G N Saibaba in an alleged Maoist links case, noting the prosecution had failed to establish its case. The court also set aside his life sentence. Saibaba died in

Saibaba died in October due to healthrelated complications.

On January 31, a division bench of Justices G S Patel (now retired) and Neela Gokhale gave a split verdict on the amended Information Technology Rules against fake news on social media.

A bunch of petitions had been filed by stand-up comedian Kunal Kamra, Editors Guild of India, News Broadcast and Digital Association and Association of Indian Magazines challenging the new regulations.

While Justice Patel said the rules amounted to censorship and quashed it, Justice Gokhale upheld the rules, noting it did not have any chilling effect on free speech. The matter was then

Ine matter was then referred to a third judge, Justice A S Chandurkar, who in September, struck down the Rules terming it as unconstitutional.



This year, actor and BJP MP Kangana Ranaut had to knock court's doors seeking censor board's clearance for her movie 'Emergency', a political drama in which she played the role of former prime minister Indira Gandhi.

Following the HC's order, the Central Board of Film Certification suggested certain cuts after which the film was okayed for release.

However, Ranaut's legal battle continued with lyricist Javed Akhtar, who had filed a defamation complaint against her over comments following actor Sushant Singh Rajput's death in 2020.

Akhtar, meanwhile, was acquitted in a defamation case filed by a lawyer over his comments against the RSS.

In February, the HC quashed the Look Out Circulars issued against actor Rhea Chakraborty in connection with a probe into Rajput's death.

Mere registration of FIR can't be a reason to issue LOC, the HC noted.

This year, the Mumbai police's Economic Offences Wing and the Enforcement Directorate were also seen at loggerheads in the alleged Rs 25,000 crore Maharashtra State Cooperative Bank scam, allegedly involving state deputy chief minister Ajit Pawar.

The EOW filed a closure report in the scam. But the ED, which has already filed prosecution complaints and supplementary chargesheets in the case, sought to intervene, emphasising the interconnected nature of the investigations.

The police have opposed the ED's plea, contending its similar plea was rejected earlier by a court.

In another case involving politicians, a special court in September rejected a plea of Shiv Sena (UBT) leaders Uddhav Thackeray and Sanjay Raut challenging a magistrate's order refusing to discharge them in a defamation case filed by former Lok Sabha MP Rahul Shewale.

The court said "it found no illegality or mistake" in the magistrate's order. The trial continues against them in the magistrate court.

Rajya Sabha member Raut, meanwhile, in October was convicted in another defamation case filed by BJP leader Kirit Somaiya's wife, but the sentence is suspended and he is out on bail.

In March, the HC convicted controversial encounter specialist, former cop Pradeep Sharma, and sentenced him to life imprisonment in a 2006 fake encounter of Ramnarayan Gupta, an alleged close aide of gangster Chhota Rajan.

In April, the HC dismissed a 2014 suit challenging the position and appointment of Syedna Mufaddal Saifuddin as the leader of the Dawoodi Bohra community. The suit was filed initially by Khuzaima Qutbuddin soon after his brother and then Syedna Mohammed Burhanuddin passed away in January 2014 at the age of 102.

The murder of NCP politician Baba Siddique and firing outside Bollywood actor Salman Khan's residence also dominated courts' headlines, while trials in cases like the 2008 Malegaon blast and Sheena Bora killing continued at a sluggish pace.

Almost 16 years after a bomb blast at Malegaon in Nashik claimed six lives and left over 100 injured, the trial proceedings have entered the final phase, with a special NIA court hearing the final argument of the accused.

There has been no movement in the trial of the Sheena Bora murder case, where her mother Indrani Mukerjea is the prime accused, since the past one-and-half months. The reason being the

special CBI court, presiding over the matter, is vacant following the judge's transfer to the Supreme Court.

The HC, meanwhile, refused to stay release of a docu-series on Indrani. It also overturned a special CBI court order that allowed her to travel to Spain and the UK.

The HC this year also granted medical bail to Jet Airways founder Naresh Goyal in a money laundering case.

In June, the HC ordered immediate release of a 17-year-old boy allegedly involved in a Porsche car incident in Pune, noting the orders remanding him to an observation home in Pune were illegal.

The police claimed the teen was drunk and driving the luxury car when it hit a two-wheeler killing two techies. - PTI

# 'ADANI GROUP READY TO WORK WITH ANY GOVT, NOT GETTING ANY SPECIAL TREATMENT'

Noting that Adami Group is working in over 25 states of the country. Adami Group Chairman Gautam Adami has said that they are open to working with any goverement and do not get any special treatment. He cited the example of

Vizhinjam port in LDFruled Kerala, which is India's first deep water Container Transhipment Port, to emphasise Adani Group carrying out infrastructure projects across states. Vizhinjam port is being developed by Adani Ports and SEZ Ltd.

"We are working in almost over 25 states. Many people often say Adaai Group only works in BJP state. See Vizhinjam port in Kerala, bailt for Rs 20000 crore...Adani Group is ready to work with anyone as far as they are not doing any politics.We are ready to work with any governments, asfar as they are not doing any politics," Gautam Adani said at a private event here in the national capital.



"Building infrastructure is the most toughest job. If it was easy, everybody would have basically done it. Infrastructure development is not possible if you are thoroughly not involved," he said.

"Adani Group is not getting any special treatment," he said, apparently referring to allegations made by some political parties. In July this year, Union

Minister of Ports, Shipping and Waterways Sarbananda Sonowal received the first Mother Ship 'MV San Fernando' marking the beginning of operation at India's first deep water container transhipment port in Vizhinjam.

It is India's first automated port equipped with state of the art that offers largescale automation for quick turnaround of vessels including capacity to handle megamax containerships. Gautam Adani said that without governments' support, irrespective of the party in power, development of infrastructure is not possible.

He noted that building large infrastructure is the

toughest job and requires thorough involvement and patience.

"Building infrastructure is the most toughest job. If it was easy, everybody would have basically done it. Infrastructure development is not possible if you are thoroughly not involved," he said.

Gautam Adani said that returns on investment in infrastructure space take a considerable period of time, which again needs patience.

Adani Group is a diversified organisation and is into various sectors from ports to airports, cement to transmission lines and edible oil to solar power projects.

Speaking about the ambitious Dharavi redevelopment project, Gautam Adani said he wants to make it a reality in the next few years. "Personally, not from a Group point of view, even at my level, I always continue to think that this (Dharawi project can create a legacy, how we can just provide dignity to one million population. It was tried thrice in the past 40 years. but failed," he said. Gautam Adani said his Group has made possible many unbelievable things and that he now wishes to redevelop the Dharavi project.

"I am 62, and when I retire in the next 5-10 years, I want to make it a reality so that the one million people (in Dharavi) should remember for the next SO years," he said.

The Adani Group Chairman also spoke a bit into his personal journey and noted that life becomes simple when people accept the fact they are mortal.

"No one has come here permanently. When one understands this, life becomes simple," Gautam Adami said."I have not completed my college, I didn't event complete my first year. Even after the tenth standard, I was unable to speak confidently, I did my schooling in the village, from a very very humble background, no exposure When I close my eyes, I recall how have I reached this position today without family background, money and education," he added.


