# Streaming wars set to intensify with JioHotStar debut

Mumbai, February 14

**THE RELIANCE-DISNEY** joint venture on Friday merged its two streaming platforms — Disney+ Hotstar and JioCinema — into one. This comes within three months of the JV (called JioStar) coming into existence.

The speed of the action, said experts, points to the rapid consolidation of the domestic media market and will see the combined service (called JioHotstar) taking on OTT majors Amazon Prime Video and Netflix, among others.

It will offer both sports and entertainment content at an "affordable price".

Premium content will include films, TV shows and animation

from the Disney stable, NBCUniversal Peacock, Warner Bros Discovery HBO, and Paramount on the merged platform.

"At the core of JioHotstar is a

powerful vision—to make premium entertainment truly accessible to all Indians," Kiran Mani, CEO, digital, JioStar, said. "By integrating AI-driven recommendations and offering

streaming in over 19 languages, we are personalising content like never before," he added.

Last month, Disney+ Hotstar had live-streamed Coldplay's con-

cert in Ahmedabad. JioStar will also look to bring more live experiences, beyond sports and entertainment, setting itself up for "infinite possibilities", Sanjog Gupta, chief executive officer, sports, JioStar, said.

Subscription plans will start at ₹149 for mobile-only access to JioStar for three months. A super plan for ₹299 for two devices (for three months) is also available. While a premium subscription plan for the same period, but without advertisements and for four devices, will cost ₹499.

The consolidation will see JioHotstar having over 400 million monthly active users, according to industry experts, making it a formidable digital media player, rivalling Google's YouTube, which has close to 500 million monthly active users

in India, its largest market.

MX Player, which was merged with Amazon Mini TV after its acquisition in September 2024, has a base of over 250 million monthly active users. Amazon Prime Video, which is a subscription-based video on demand (SVOD) service, is estimated to have over 60 million monthly active users on its platform. Netflix is estimated to have monthly active users of around 12-15 million in India, according to industry experts.

Existing JioCinema and Disney+ Hotstar subscribers will be able to switch to JioHotstar starting Friday, the company said. The new platform will also host Sparks, which will offer original, short-form content with a single episode lasting between two and 12 minutes.

## Now, IPL fans will have to pay to view matches on JioHotstar

Fans of the popular Indian Premier League (IPL) will now have to pay for viewership on the new JioHotstar platform, but Reliance Jio and Bharti Airtel users will continue to have free access to platform content under their bundles, sources said.

Viewers have been watching IPL matches for free on JioCinema for the last couple of years, after the platform bagged the digital streaming rights in 2023.

With the merger of

JioCinema and Disney-Hotstar that spawned the mega platform JioHotstar, however, IPL will now be available at a minimum subscription ₹149. Sources said that any formal announcement on this is likely to be made closer to the start of IPL matches, scheduled to begin late in March. Reliance Industries Limited did not respond to a request for comment on its plans for IPL.

**IMPACT ON AD RATES**

According to Ajimon Francis, Managing Director of Brand Finance, the move will cause a flutter in the advertiser community but ultimately

only cause a segmented impact rather than a pan-India impact. "There will be questions and answers from both

advertisers and broadcasters in terms of which segment is going to get hit more and how that will impact the ad

rates. That discussion is going to happen over the next 2-3 weeks," said Francis.

Similarly, Vikram Sahuja, Group CEO of Madison Media & OOH, said, "What JioStar is doing is allowing 4 hours/month of free viewing (of any content) and introducing a charge of ₹149 only after that. Also we can expect some accretion in the base when jio cinema and hotstar fully migrate to jio hotstar - both on subscription and free. As a result, I don't expect reach of IPL to fall."

**PREDATORY PRICING**

Meanwhile, Lloyd Mathias, Marketer & Business

Strategist, anticipates some amount of predatory pricing given that key properties like IPL are now owned by the same group.

"They were using key event properties to get more subscribers because they were competing with HotStar at that time. They were offering prime properties like FIFA World Cup, IPL, free of cost. Now, they will control the entire ecosystem both on television and digital. I think they will indulge in a bit of predatory pricing, which means they will even make subscribers pay and get content," said Mathias.
